
New World Order Plans for the Economy. Be Prepared!

Lockdowns do work. Not at stopping the spread of a virus, but they're successful at destroying economies. This virus is statistically as devastating to the population as a bad flu.

So why have the governments implemented and held such a disproportionate response, destroying their economies and pretending that it doesn't matter? It's because COVID is the scapegoat, and an excuse or an opportunity to bring about their "Great Reset".

QE [Quantiative Easing. See

https://www.investopedia.com/terms/q/quantitative-easing.asp] started in 2008, following the banking crisis caused by misuse of the lending markets, and the economy has been on life support ever since. In September 2019. a month before Bill Gates' Event 201, the overnight money market seized, the Federal Reserve had to step in printing \$50 million to \$100 million per night to try and fix it. But there was no fixing it.

Since COVID, they have expanded the money supply between 20% to 25%, under the guise of COVID relief, rather than what is another banking crisis. History tells us this money printing ends with the collapse of the currency and the economy it is attached to.

Since 1971, when the dollar as the reserve currency came off the gold standard, all currencies have been Fiat. They are backed by nothing, and depend on faith. Only 3% of the money supply is physical notes and coins. The other 97% is debt-based. Debt brings money into existence, you borrow \$100,000, and the banks are allowed to create that money from the ether and loan it to you with interest.

In the reverse case, it's important that you know that when you deposit money into a bank, it no longer belongs to you. The banks can legally invest 90% of it, and they provide you with interest for this. In 2008, we saw bank bailouts. But as of 2014, Ireland and the UK have agreed to bank-bail-ins instead. **Meaning they can legally take your money in a crisis**. This is what happened in Cyprus in 2013. The government claims to guarantee a certain amount of deposits, but only holds less than half percent. So good luck getting your money back.

So the credit markets are under stress. What is the best pressure release valve for the credit markets to hold back a collapse? It's a weaker economy. This could be part of the reason the economy was shut down. The difficulty they now face in opening back up, is when you combine an increase in money supply with an increase in velocity, you're inviting inflation.

In 2008 QE was given to the banking sector and large corporations. But in 2020, it was also given to the general public readily available now to spend.

By keeping sectors of the economy closed, you're breaking the velocity; velocity is the number of times the same amount of money changes hands. And increase velocity will lead to inflation. But it isn't essential for it.

Couple this with the inevitable increased demand for debt. When the economy does open back up. People are taking out loans again, and this could pop the debt bubble.

This financial system is held together with debt. When you buy a loaf of bread that could be 10 different transactions of credit to get to your door between manufacturers, suppliers, and distributors. Mathematically, credit is doomed to break. And this will seize the entire economy.

This is why the banks were considered too big to fail. If credit isn't functioning then products won't be created. When the credit market feels so does the entire economy. So what did they do?

Inflation is inevitable. More money is chasing the same amount of goods and services. That's just how money works. It has been evident in property for a long time, but it's recently showing up in commodity prices like lumber, copper, and also food prices.

Inflation initially raises asset prices and then filters down into living costs. The last to inflate is wages, making it increasingly difficult for the less wealthy to buy property, as their wages only make their living expenses. The government have got themselves into overwhelming debt. So they can't raise interest rates or they won't be able to service that debt as they can barely meet the interest requirements.

It seems they are planning to let inflation rise trying to maintain some control over it and inflate away the debt.

Inflation is a hidden tax. Just as they inflate away the debt they inflate away your purchasing power and you slowly lose everything you've worked for. With inflation and bank barons, they're taking your money. The danger here is

hyperinflation.

If control and faith are lost, look at Venezuela and Zimbabwe where currency litters the streets and it has so little purchasing power that it isn't even worth picking up.

We are moving into a central bank digital currency. This has already been rolled out in China with Sweden, Turkey and Iran following. With digital currency, the government has complete control as it is programmable. It is the loss of your freedom and privacy. They can control velocity by programming it with expiry dates, or deciding where the economy can be spent. They can limit your leisure spending, prohibit you from buying certain items, or only allow spending on basic food items and rent. They can tax and fine, directly. They have control. They can incentivize you to spend or save with negative or positive interest rates respectively.

How would you implement a control agenda? I would collapse the economy so that there are no independent businesses, therefore making everyone dependent on the state. I provide them with a generous Universal Credit system, then slowly reduce it or inflate it away. The concept of UBI [Universal Basic Income] has been about for some years now.

Over 80% of jobs that make moderate to low wages are predicted to be automated away by 2030. Humans are becoming surplus to requirement.

In the fourth industrial revolution, according to the World Economic Forum, our bodies will be so high tech, we won't be able to distinguish between what's natural and what's artificial. A future of superhumans. It's frightening.

They're also proponents of the green energy carbon tax movement, which if you look into it is eugenics repackaged. They are telling us that if we pay more taxes and stop eating meat, it will cool down the planet.

The middle and working classes will be eroded and replaced with robots, AI, and by corporations, and given a basic income. So how is this funded? The Davos IMF concept is that you own nothing and be happy. So the idea is to confiscate or severely limit all private property. The other option is taxes. But the rich don't pay taxes. The loopholes are designed to be beneficial to them but too costly for us. While universal basic income is proposed, the more effective solution to stop the wealth divide would be a universal maximum income with a wealth cap.

Let them have \$20 million. That's a lot of money that can buy all the houses and yachts that they want, but it would limit their amount of control and influence.

This is the biggest heist of wealth transfer in history. The media does not inform you. Its purpose is to distract and advertise to you. The economy has collapsed under the wave of debt-fueled greed, and the media are silent. Billionaires have increased their wealth by 28% during the crisis; gained at the expense of small businesses.

The stock market is fake. And it is a rigged game fueled by money printing and doomed to crash. The Old World is now coming back. A group of billionaires are deciding how the rest of the world should live. And they have the ear of the government the claims to represent you.

When you hear Johnson, Trudeau and Biden say "build back better" that is a Davos concept, a collection of non-elected private billionaire influencers.

If we submit to a digital currency, we lose control and privacy. This is what you really need to wake up to. Furlough is psychological prepping for UBI. You're not being paid to stay at home, you're being paid not to revolt. If you know the pounds, dollars, etc, are losing purchasing power, why would you keep them?

This is why people are moving to hold assets such as silver, gold, land, or property instead, and transferring currency to crypto to outrun the inflation that is already becoming evident.


There's also a ridiculous increase in shipping costs. COVID impacted the supply chain. China stockpiled containers and the system broke. This led to a problem with stock on shelves. When it's fully operational again, the additional costs will be passed on to the consumer. It would be wise to buy supplies to combat any shortages while the system resets. 

The Papacy

We also define that the holy apostolic see, and the Roman pontiff, holds the **primacy over the whole world**, that the Roman pontiff is the successor of blessed Peter, prince of the apostles, that he is the true vicar of Christ, the **head of the whole Church** and the **father and teacher of all Christians**, and that to him was committed in blessed Peter the full power of tending, ruling and governing the whole church, as is contained also in the acts of ecumenical councils and in the sacred canons (COUNCIL OF FLORENCE, 1439).



Vicar: (From Latin) vicarius, a substitute,
Anti: (From Greek) against, opposite, instead of,
Vicar of Christ = Anti Christ

Did you get that? Even though YOU may not acknowledge the authority of the Catholic Pope over your life, as far as he is concerned, you belong to him!

Did the Pope take "upon himself to be lord and master above all kings and princes"?

The papal deposing power was the most powerful tool of the political authority claimed by and on behalf of the Roman Pontiff, in medieval and early modern thought, amounting to the assertion of the Pope's power to declare a Christian monarch heretical and powerless to rule.

Pope Gregory VII's Dictatus Papae (c. 1075) claimed for the Pope "that it may be permitted to him to depose emperors" (12) and asserted the papal power to "absolve subjects from their fealty to wicked men" (27).

Oaths of allegiance held together the feudal political structure of medieval Europe. The principle behind deposition was that the Pope, as the ultimate representative of God from whom all oaths draw their force, could in extreme circumstances absolve a ruler's subjects of their allegiance, thereby rendering the ruler powerless. In a medieval Europe in which all confessed the Pope as head of the visible Church, it gave concrete embodiment to the superiority of the spiritual power over the temporal—the other side, so to speak, of the role of Popes and bishops in anointing and crowning emperors and kings. The Prophecy Jesus Told His Disciples on the Mount of Olives was ALL Fulfilled in 70AD



This article is from communication with a friend who wrote:

I'm very interested in your comments about Jesus's Olivet prophecy saying it does not refer to our future but to AD70 when the Romans sacked Jerusalem. (I hope I'm not misrepresenting your position but please correct me if I am.) I know you've mentioned it before to me. Can you explain to me in layman's terms, how we know this refers to AD70 and not to our current future? I believe it relates to the years in Daniel? Thanks, and sorry I'm very muddled on this.

My reply:

You are presenting my position correctly when you said I believe it was all fulfilled in 70 AD.

If we agree that Matthew 24 Mark 13 and Luke 21 are all talking about the same thing, meaning the Olivet Discourse, it behooves us to compare these passages with each other to see if the account of one Gospel writer may shed more light on the account of another Gospel writer. It seems to me most contemporary teachers of the Olivet discourse have not done that!! And this has resulted in two very serious misinterpretations. One of them has resulted from a mistranslation of Matthew 24:3. Let's compare that verse with what Mark and Luke have to say.

Matthew 24:3 (KJV) And as he sat upon the mount of Olives, the disciples came unto him privately, saying, Tell us, when shall these things be? and what shall be the sign of thy coming, and of the end of the world?

Mark 13:4 (KJV) Tell us, when shall these things be? and what shall be the sign when all these things shall be fulfilled?

Luke 21:7 (KJV) And they asked him, saying, Master, but when shall these things be? and what sign will there be when these things shall come to pass?

Notice that Mark and Luke does not say "the end of the world." A better translation would be, the end of the age, meaning the Jewish age.

Other translations confirm this:

I don't recommend modern English translations but I think some of the translations are better than the KJV in some verses. Most King James only people would not want to accept that. But I do see some errors in the King James version. For example, In the book of Acts, it uses the word Easter but it should say Passover. The Passover is not determined by the first Sunday after the first full moon after the spring equinox as Easter is.

In 70 AD the Roman army destroyed Jerusalem and the Temple and all the records of Jewish lineage. And that means there is no person who claims to be Jewish today who can tell you what tribe of Israel he is from. Dr Chuck Baldwin does the most thorough job of any preacher I have ever heard in explaining the Olivet discourse and the meaning of it.

It's long but worth reading if you can take the time. It answers very clearly the second serious major misinterpretation of the Olivet discourse: The meaning of the Abomination of Desolation.

I will sum it up for you as succinctly as I can.

Most evangelicals today believe the Abomination of Desolation is the End time Antichrist erecting an idol in a rebuilt Temple of Solomon in Jerusalem. And this is connected to false doctrines of so-called Christian Zionism. This was a popular doctrine in the Scofield Reference Bible and has misled millions of English-speaking Christians. And again to find the truth all we have to do is compare what Matthew has to say with one other Gospel writer, Luke and what he has to say:

Matthew 24:15-16 (KJV)

15 When ye therefore shall see the abomination of desolation, spoken of by Daniel the prophet, stand in the holy place, (whoso readeth, let him understand:)

16 Then let them which be in Judaea flee into the mountains:

Luke 21:20-21 (KJV)

20 And when ye shall see Jerusalem compassed with armies, then know that the desolation thereof is nigh.

21 Then let them which are in Judaea flee to the mountains; and let them which are in the midst of it depart out; and let not them that

are in the countries enter thereinto.

Luke clearly identifies the Abomination of Desolation as Jerusalem compassed with armies — Roman armies. And both Matthew and Luke tell the followers of Jesus who witness that event what to do: Flee into the mountains. From where? From Judaea. Why? To avoid the slaughter of the Jews by the Romans. To me, that's as clear as crystal. The followers of Jesus who believed in the prophecy left Jerusalem and Judea and survived the Roman attack. The unbelieving Jews who remained were killed.

In this prophecy, Jesus was referring to the final words of Daniel 9:27.

Daniel 9:27 (KJV) And he shall confirm the covenant with many for one week: and in the midst of the week he shall cause the sacrifice and the oblation to cease, and for the overspreading of abominations he shall make it desolate, even until the consummation, and that determined shall be poured upon the desolate.

The "overspreading of abominations" is talking about the attacking armies of Rome, and "make it desolate" is referring to the destruction of Jerusalem and the temple. The problem evangelicals make is that they also include the prophecies of Daniel 11, and they are completely different prophecies and were already fulfilled before Jesus was born on Earth. I also talk about this on my website but I don't want to give you too much to read right now.

Another point: Matthew refers to it as great tribulation, but Luke refers to it as days of vengeance.

Luke 21:22 (KJV) For these be the days of vengeance, that all things which are written may be fulfilled.

Days of vengeance on whom? On the Jesus of Nazareth rejecting Jews who crucified their Christ, their Messiah. This is brought out very clearly in Dr. Baldwin's talk and it makes a whole lot of sense to me.

Evangelicals today are always talking about a future coming great tribulation of people. Some say this includes believers as well if you believe in a post-tribulation rapture. I cannot see how you can come up with this doctrine when you read Luke chapter 21, because it's clearly referring to God's judgment on the unbelieving Christ-rejecting Jews!

Anyway, there's a lot more to talk about on this subject, and you're only going to learn it if you take the time to read what Pastor Chuck Baldwin has to say and or read other articles about it on my website. I have written extensively about it:

And of course, you can say all of the above are *also* really interpretations but please know that this was the standard Protestant interpretation up to the end of the 18th century. Bible commentators up to that time have all said Matthew 24, Mark 13, and Luke 21 are fulfilled prophecies. This is not the same thing as Preterism! The preterists say that ALL of the Bible prophecies have been fulfilled, including all of the Book of Revelation, and I certainly don't believe that.

<u>Views of the Russian Invasion of</u> <u>Ukraine by a Christian Missionary Who</u> Lived in Ukraine



This post is in addition to the views of <u>Ukrainian Lydia about the Russian invasion of Ukraine</u> by missionaries friends, a married couple. The husband sent me two emails in response for my request to hear their views. I would rather hear from the people who are actually there than from a corporate news agency with hidden agenda. They have no reason to lie to me.

The first email

First of all, I want to give you a little background concerning ourselves and the time we've spent in this part of the world.

We have lived in Russia, Ukraine, and Eastern Europe for nearly 30 years, 18 of those in Ukraine. We lived behind the "Iron Curtain" for 4 years and made trips to the Soviet Union during that time, as well as living in Yugoslavia, Hungary, and Bulgaria. We spent 7 years in Russia.

So, if any of that makes a difference, here is our take on what's

happening:

Putin is an absolute monster! Period!

Any defense of his actions is **extremely offensive to us, our friends,** and the people of Ukraine.

Timothy Snyder, a leading authority on Central European history and the Holocaust, says Putin's claim about "de-Nazification" is "grotesque" because he's trying to justify invading a democratic country — led by a Jewish president who lost relatives in the Holocaust — by claiming he's there to fight Nazis.

Snyder calls Putin's justification a variation of Hitler's Big Lie — a Nazi propaganda technique that insists that if a political leader repeats a colossal untruth enough, people will eventually believe it.

"Adolf Hitler had some public relations advice: Tell a lie so big that people will not believe that you would ever try to deceive them on such a grand scale," Snyder wrote in an essay titled, "Putin's Hitler-like tricks and tactics in Ukraine."

By telling lies that Ukraine is run by Nazis bent on genocide, Putin is making a mockery of people who survived the Holocaust, says Snyder, author of "On Tyranny."

Synder wrote a best seller book on the atrocities committed by the Germans and the Soviets in Ukraine's Bloodlands: Europe between Hitler and Stalin. I read the book as well as meeting Mr. Synder.

I'm posting a chart (the one at the top of this article) sent to me by one of our Bible students who attended our classes for many years before his job took him to the United Arab Emirates. He is a Frenchman and has many fond memories of the years that he spent in Ukraine. I thought his chart would be helpful for you to understand the depth of pain that Russia has inflicted on Ukraine over the years and why the Ukrainians will fight to the death before allowing Russia to dominate them again.

Please look it over carefully, as the numbers are staggering.

So that's my take on the situation. Russia is destroying an innocent country before our very eyes, committing gross atrocities by bombing whole towns into rubble, and killing innocent people and children.

I could go on and on about this subject, but suffice it to say that there is absolutely no justification for Putin's invasion of Ukraine and I believe he should be tried for war crimes and Russia be made to pay for all the damage they've caused in Ukraine and withdraw all their troops for Ukraine, including Donbas and the Crimea.

The second email

I wanted to comment on what you wrote about your friend (who lives in Japan) not seeing eye-to-eye on the point of Russia's invasion of Ukraine.

I beg to disagree with your friend, James. There is no such thing as surrendering to Putin. Surrendering would have meant that Zelensky would have been killed along with all members of his government and a puppet regime would have been installed in his place.

I'm not sure if your friend is a student of history or not, but if he is, let me remind him of the brutality of the Soviet Army. Wherever the Soviet Army captured territory one of the first orders of business was the raping of all the women in those areas. Berlin in particular was subjected to mass rape, but so weren't Poland, Romania, and Hungary. I've personally talked to people from those countries and they told me of how their grandparents hid in fear of the Russians.

I know the answer may be that rape is just a by-product of war, but if you do a little research about the subject, you'll see that the Russians' conducted this on a massive scale.

Today's Russians invading Ukraine are cut from the same cloth, so to speak, in this regard.

I believe we can get too lost in conspiratorial thinking to the point that we see someone as evil as Putin as somehow standing up against the globalists.

There are many "Monday morning quarterbacks" out there, dissecting what the Ukrainians should have done, but how many of them were there? How many of them have lived in fear of what the Russians are capable of? Have they ever been subjected to mass starvation like Ukraine experienced in the 1932-33 famine, where more than 4 million of their countrymen died at the hands of their Soviet masters?

It's very easy to say they just should have given in to the Russian, but do those who make those judgements know the depth of Ukraine's feelings on the matter. At the time of the invasion, more than 80% of the Ukrainian population didn't want to be a part of Russia or have anything to do with them. Now, since the war, those numbers have approached nearly 100%.

To say that this was all Zelensky's doing is to discount the overwhelming sentiments of the Ukrainian population.

Let me point out that I was there, not only in Russia for seven years, but in Ukraine for 18. It would be like saying that I know better the picture on the ground in South Africa or anywhere else for that matter, than someone who has lived for an extended period of time in that country.

Putin is a liar and is being nurtured by his father, the father of lies.

Right up till the very invasion, Putin denied he was going to invade Ukraine. He denied that Russian troops were in Crimea in 2014, he denied that Russia was assisting the, so-called, separatists in the Donbas region, he denied that a Russian surface-to-air missile shot down the Malaysian plane, the Russians denied that they had participated in state run doping of their athletes in the Olympics, they denied that they have poisoned former agents abroad, and the list goes on-and-on.

- ECC.3:4 A time to weep, And a time to laugh; A time to mourn, And a time to dance;
- ECC.3:5 A time to cast away stones, And a time to gather stones; A time to embrace, And a time to refrain from embracing;
- ECC.3:6 A time to gain, And a time to lose; A time to keep, And a time to throw away;
- ECC.3:7 A time to tear, And a time to sew; A time to keep silence, And a time to speak;
- ECC.3:8 A time to love, And a time to hate; A time of war, And a time of peace.

Throughout the Bible, we have wars happening and the people of God fighting the forces of evil.

David chose to fight Goliath and won. He didn't surrender to him. The little David, Ukraine, is fighting the mighty Goliath, Russia, and miraculously is winning. From all I can see, God is fighting with them.

When Jeremiah warned the Jews to "take upon them the yoke of Babylon", it was because God brought the Babylonians as His instrument of punishment to punish the Jewish people for their turning away from God and being joined to idols and other gods.


Ukraine, in contrast, is the most Christian country in Europe, with over 80% of their people professing faith in God.

The 45 Goals of Communism



I just saw a 2010 documentary film entitled, "Agenda: Grinding America Down" about the leftist socialist takeover of America. It talks about a book written in 1958 by a former FBI Agent, Cleon Skousen, called "The Naked Communist". On Jan. 10, 1963, Congressman Albert S. Herlong Jr. of Florida read this list of 45 Communist goals into the Congressional Record. How many of these 45 goals do you think have been implemented? You can write your answer in the comments section below.

Some of the goals are dated due to the collapse of the Soviet Union and the unification of East and West Germany, but from my observation, the goals have been fulfilled or close to fulfillment by the liberal leftist socialists — most of the current American Democratic party members. I enhanced in **bold font** the ones I especially find disturbing.

- 1. U.S. should accept coexistence as the only alternative to atomic war.
- 2. U.S. should be willing to capitulate in preference to engaging in atomic war. [Note: These encapsulate the Kennan Doctrine, which advocated for the "containment" of communism. Establishment figures supporting the amoral containment policy at least implicitly worked with the communists in scaring the wits out of the American people concerning atomic war. President Ronald Reagan undid the doctrine when he took an aggressive stand against the Evil Empire by backing freedom fighters from around the world that were struggling against the left-wing communist jackboot. As a result, the Soviet Union and its satellites imploded, a considerable and unexpected setback to the international communist edifice.]

- 3. Develop the illusion that total disarmament by the U.S. would be a demonstration of "moral strength." [Note: The nuclear freeze advocates supported a freeze on American nuclear development only. Rarely were Soviet nukes or those of other nations mentioned in their self-righteous tirades. The same advocates now call for reducing American military might, claiming that there is something immoral about America preserving its military preeminence in the world.]
- 4. Permit free trade between all nations regardless of Communist affiliation and regardless of whether or not items could be used for war. [Note: Today, there are calls to end the embargo on the slave island of Cuba, there were complaints about the embargo against Iraq, and the U.S., not Saddam Hussein, was blamed for the suffering of the Iraqi people. Would they have advocated for free trade with Hitler and his National Socialist regime?]
- 5. Extend long-term loans to Russia and Soviet satellites.
- 6. Provide American aid to all nations regardless of Communist domination. [Note: Such aid and trade over decades contributed greatly to the left-wing communist liquidation of over 100 million people worldwide, according to the well-documented "Black Book of Communism." This aid and trade marks a shameful chapter in American history. Without the aid and trade, the left-wing international communist behemoth would have imploded on its own rot a lot sooner and umpteen millions would have been saved from poverty, misery, starvation and death.]
- 7. Grant recognition of Red China and admission of Red China to the U.N. [Note: Not only did President Nixon fulfill this goal but he also betrayed America's allies in Nicaragua, El Salvador, Iran, Afghanistan, Angola and elsewhere.]
- 8. Set up East and West Germany as separate states in spite of Khrushchev's promise in 1955 to settle the Germany question by free elections under supervision of the U.N.
- 9. Prolong the conferences to ban atomic tests because the U.S. has agreed to suspend tests as long as negotiations are in progress.
- 10. Allow all Soviet satellites individual representation in the U.N.
- 11. Promote the U.N. as the only hope for mankind. If its charter is rewritten, demand that it be set up as a one-world government with its own independent armed forces. [Note: There are still American intellectuals, and elected members of Congress, who dream of an eventual one world government and who view the U.N., founded by communists such as Alger Hiss, the first secretary-general, as the instrument to bring this about. World government was also the dream of Adolf Hitler and J.V. Stalin. World government was the dream of Osama bin Laden and the 9/11 hijackers.]
- 12. Resist any attempt to outlaw the Communist Party. [Note: While the idea of banning any political party runs contrary to notions of American freedom and liberty, notions that are the exact opposite of those held by the left-

wing communists themselves, nevertheless these goals sought to undermine the constitutional obligation of Congress to investigate subversion. The weakening of our government's ability to conduct such investigations led to the attack of 9/11.]

- 13. Do away with loyalty oaths. [Note: It is entirely proper and appropriate for our government to expect employees, paid by the American taxpayer, to take an oath of loyalty.]
- 14. Continue giving Russia access to the U.S. Patent Office.
- 15. Capture one or both of the political parties in the U.S. [Note: In his book, "Reagan's War," Peter Schweizer demonstrates the astonishing degree to which communists and communist sympathizers have penetrated the Democratic Party. In his book, Schweizer writes about the presidential election of 1979.]
- 16. Use technical decisions of the courts to weaken basic American institutions, by claiming their activities violate civil rights. [Note: This strategy goes back to the founding of the American Civil Liberties Union by Fabian Socialists Roger Baldwin and John Dewey and Communists William Z. Foster and Elizabeth Gurley Flynn among others.]
- 17. **Get control of the schools**. Use them as transmission belts for Socialism and current Communist propaganda. Soften the curriculum. Get control of teachers associations. Put the party line in textbooks.
- 18. Gain control of all student newspapers.
- 19. Use student riots to foment public protests against programs or organizations that are under Communist attack. [Note: The success of these goals, from a communist perspective, is obvious. Is there any doubt this is so?]
- 20. **Infiltrate the press**. Get control of book review assignments, editorial writing, policy-making positions.
- 21. Gain control of key positions in radio, TV & motion pictures.
- 22. Continue discrediting American culture by degrading all form of artistic expression. An American Communist cell was told to "eliminate all good sculpture from parks and buildings," substituting shapeless, awkward and meaningless forms.
- 23. **Control art critics and directors of art museums**. "Our plan is to promote ugliness, repulsive, meaningless art."
- 24. Eliminate all laws governing obscenity by calling them "censorship" and a violation of free speech and free press.
- 25. Break down cultural standards of morality by promoting pornography and obscenity in books, magazines, motion pictures, radio and TV. [Note: This is the Gramscian agenda of the "long march through the institutions" spelled out

explicitly: gradual takeover of the "means of communication" and then using those vehicles to debauch the culture and weaken the will of the individual to resist.


- 26. Present homosexuality, degeneracy and promiscuity as "normal, natural and healthy." [Note: Today those few who still have the courage to advocate public morality are denounced and viciously attacked. Most Americans are entirely unwitting regarding the motives behind this agenda.]
- 27. **Infiltrate the churches** and replace revealed religion with "social" religion. **Discredit the Bible** and emphasize the need for intellectual maturity, which does not need a "religious crutch." [Note: This has been largely accomplished through the communist infiltration of the National Council of Churches, Conservative and Reform Judaism, and the Catholic seminaries.]
- 28. Eliminate prayer or any phase of religious expression in the schools on the grounds that it violates the principle of "separation of church and state"
- 29. **Discredit the American Constitution** by calling it inadequate, old fashioned, out of step with modern needs, a hindrance to cooperation between nations on a worldwide basis.
- 30. **Discredit the American founding fathers**. Present them as selfish aristocrats who had no concern for the "common man."
- 31. **Belittle all forms of American culture** and discourage the teaching of American history on the ground that it was only a minor part of "the big picture." Give more emphasis to Russian history since the Communists took over. [Note: Obliterating the American past, with its antecedents in principles of freedom, liberty and private ownership is a major goal of the communists then and now.]
- 32. **Support any socialist movement to give centralized control** over any part of the culture education, social agencies, welfare programs, mental health clinics, etc.
- 33. Eliminate all laws or procedures which interfere with the operation of the Communist apparatus.
- 34. Eliminate the House Committee on Un-American Activities.
- 35. Discredit and eventually dismantle the FBI.

[Note: This describes the dialectical fostering of group consciousness and conflict, which furthers the interests of authoritarianism.]
- 43. Overthrow all colonial governments before native populations are ready for self-government.
- 44. Internationalize the Panama Canal.
- 45. Repeal the Connally Reservation so the U.S. cannot prevent the World Court from seizing jurisdiction over domestic problems. Give the World Court jurisdiction over domestic problems. Give the World Court jurisdiction over nations and individuals alike.

The fifth letter is HE, the sixth letter is VAU. YOD HE VAU HE spells Yahweh.

I will say it again. God's name is on every human chromosome. You are made in His image and sealed with the name of your Creator. Every cell in your body is hallmarked. And it is this very divine hormone that the enemy desires to obliterate. By injecting loaded messenger RNA into cells, one can sneak fragments of foreign enemy DNA through the carefully guarded nuclear walls and unload their contents into the scroll of DNA that God wrote for you. Is the enemy to blaspheme and revive your name forever? Why do you hold back your hand even your right hand? Draw it out of your bosom and consume them to make an end of them. They have profaned the dwelling place of your name.

There is no better description of what has happened worldwide in the human body than these words. And in every nation, believers are being coerced into taking the supposed health-inducing jab. Is this not causing the great falling away described in II Thessalonians two verse three? The totality of the scheme is to leave the Third Temple desolate, destroyed, overtaken, and subjugated to an ancient enemy, who always coveted God's throne and the worship of God's bride.

Apostasia, the Greek for falling away means defection from truth, and comes from the Strong's G647 which means to separate, the writing of divorcement. How significant that a fragment of DNA writing is what separates or breaks asunder the record of God's name in the human DNA.

The Greek for *delusion* comes from a root word meaning deceiver or imposter. So the recurring theme is deception, which brings distraction.

No surprise that pharmakeia also means witchcraft, and comes from a root word meaning drug, or poison. Poison is intended to induce the death of the victim. The Word tells us that the life is in the blood. It is surely no coincidence that the foreign spike proteins, which the human body is forced to produce after it has been hijacked, trigger blood clots, which in turn cause fatal heart attacks and strokes.

As God has said, I will dwell in them and walk among them, and I will be their God, and they shall be my people. Therefore come out from among them and be separated says the Lord, and do not touch the unclean thing, and I will receive you, and I will be a father to you, and you shall be my sons and daughters, says the Lord Almighty.

And the (Greek) word for *unclean thing* is *akathartos*, meaning foul, unclean, and demonic.

May God Almighty give you the strength to stand uncompromising in the days which were facing.

Transcription of the interview

Stew Peters: So we're now up to our fourth COVID shot here in the United States. And Anthony Fauci is talking about possibly doing another round of lockdowns too. Hell, I mean, that might happen because half of this country are sheep, and will fall for anything, it seems.

Well, Dr. David Martin recently warned that the ultimate long-term purpose of all of this will be exposing humanity to constant forcible gene editing, via mRNA vaccines and who knows what else. Dr. Martin will be joining me I'm very excited because he also will be speaking at the April let's go Brandon rally,

but he joins us now. And I'm excited about that, as well. Thank you for coming. So that's what this is replacing God's likeness, essentially, as we worship the mRNA masters.

Dr. David Martin: You know, it's fascinating. And just the last couple of weeks, I have gone on record for quite some time now, Stew, saying that this entire exercise was about transcribing a computer-synthesized model into the human genome. And in the last month, we've seen mainstream science come back with a giant revelation that it turns out that this shot persists in the human body for an indeterminate period of time. The most recent data shows that at least surviving up to eight weeks in the lymph system, where it continually produces the spike protein. We see evidence coming from municipal waste systems that allegedly even though we're all allegedly getting better, and the pandemic is starting to normalize, apparently spike protein is showing up in our waste streams at alarmingly high rates. Stew, the reason is because as I've said all along, when you inject the body with instructions to make A chimeric model of a synthetic spike protein, where you have never done testing on that gene therapy, it turns out that you don't know what you might be manufacturing, and how long each individual who gets the injection might be manufacturing these pathogens. And not surprisingly, we were told about this years before this injection started. This is a pandemic of the bio weaponization of the human organism. This is not public health. And Anthony Fauci is the architect of this genocide.

Stew Peters: You have read so many different quotes and given so many examples using the criminals' own words as they have forecasted exactly what was coming and this dates all the way back. I mean, everybody I talked to that has relevant resources can trace this first, it was back to 2015. Then it was 2005. And now even before that, is it possible,...

Dr. David Martin: Yeah, all the way to 1990.

Stew Peters: 1990? I mean, now. Is this, is it possible? Why? What are some other reasons that this could be showing up in our water?

Dr. David Martin: Well, listen, the reason is really simple. We are now obsessing about the fact that every way to Sunday, what is being done is the human organism is now being modified, and it is being modified to perpetually produce a toxic protein known and scheduled to harm humanity. And when I say known and scheduled to harm humanity, why don't we go ahead and make sure I clarify the reference because apparently, people don't understand what it is. Under 7 CFR Part 331, under 9 CFR Part 121, and on 42 CFR Part 73, we have what's called the Federal Select Agent Toxin List. Stew, this is not my list. This is not Dave's allegation. This is the Code of Federal Regulations where we put very specific toxins on a schedule and say these things are known to harm humans. They are known to be damaging, and they are subject to the biological and chemical weapons treaties and laws that we have enforced here in the United States. And why don't we read it directly from the schedule because why would I need to make up for the criminals' acts are even more egregious? Any SARS CoV or SARS CoV2 chimeric virus resulting from any deliberate manipulation of SARS CoV2 to incorporate nucleic acids coding for SARS CoV virulence factors. Stew, they actually say that doing the thing

they're doing is illegal.

Stew Peters: Hold on, read that again.

Dr. David Martin: Right. Sars CoV and SARS CoV2 chimeric viruses resulting from any deliberate manipulation of SARS COv2 to incorporate nucleic acids coding for SARS Cov2 virulence factors. That's actually in three sections of the Code of Federal Regulations subject to the biologic and toxin agent program, defined under 18 US Code section 178, as a biological agent subjected to 18 US Code section 175 prohibition of biological weapons. Literally, the statute says what they're doing is a felony punishable by 99 years in prison, and up to \$100 million per count.

Stew Peters: If you didn't think that that was going to happen. And if you didn't think that justice was going to prevail, and if you didn't think that we were going to win, then you wouldn't be fighting as hard as you are, you're fighting because there really was a purpose and you see a way to win, we're going to win, aren't we?

Dr. David Martin: That's exactly right. And, and so it's important when, when, when, still, you know, I'm a broken record on stuff like this. The fact of the matter is, the criminals' own statements are so egregious, that we don't even have to make up a conspiracy because they did it and they published it. So in violation of criminal conspiracy and racketeering laws, they're the ones that actually admitted to it and let's go to the 20 F filing. For those of you not familiar with a 20 F filing, when a foreign company files with the United States Securities Exchange Commission, one of their filings is called a 20 F filing, and Biotech, the mRNA injection manufacturer for Pfizer makes the following statement in their 20 F filing. So let's just, let's just set up at the gate. This is them speaking. This is not David Martin. This is them speaking, I'm reading straight from their 20 F filing.

To our knowledge. There is no current precedent for an mRNA-based immunotherapy, such as the type we are developing, being approved for sale by the FDA, the European Commission or any other regulatory agency elsewhere in the world. Although we expect to submit BLAs (which is the biologics license for mRNA-based product candidates in the United States and in the European Union) mRNA therapies have been classified as Gene Therapy Medicinal Products. Other jurisdictions may consider our mRNA-based product candidates to be new drugs, but not biologics or gene therapy, or medicinal products and require different marketing applications. Securing regulatory approval requires submission of extensive preclinical and clinical data and supporting information the various regulatory authorities for each therapeutic indication to establish the product's candidate safety and efficacy."

Listen, I read it straight out of their filing. When I say that this is not a public health vaccine, but this is a computer generated synthetic chimeric alternative to the virulence factor of SARS co V, which is exactly, exactly what it is. This is actually not Dave's theory. This is the reality that says we are being subjected to a perpetual addiction to a known pathogen and toxic

agent. And the reason why Anthony Fauci is now advocating for the next round of boosters to be followed by the next round of boosters, is until we actually achieve the stated goal, which is a 15% population reduction, which I don't know if you do the math quick in your head, but **that's about 800 million people dead**. Dr. David Martin: Well, and the fact of the matter is, it's their words, not mine. They're the ones that said it. And by the way, it's important to realize that that wonderful thing about SARS cov 2 chimeric viruses that I read from the Code of Federal Regulations, that little thing called the Federal select agent program, that little thing called the Department of Health and Human Services and USDA agents and toxins program, that thing that I read, mysteriously had SARS co2 fragments listed as scheduled pathogens in April of 2020. This is intentionally designed. This was chimerically engineered by people who knew exactly what they were putting into these injections delivered with this mRNA technology. They know exactly what they're doing. These are not experimental, the clinical trial data, they didn't need that they didn't need it. Why? Because they knew what that was what was going to happen. They knew what they were going to do. And the reason there's no threshold for death, the reason why it's not alarming to anybody that only

Dr. David Martin: That is exactly right. 

The Four World Empires of the Book of Daniel



The World Run by Arturo Sosa Abascal through Pope Francis



King Nebuchadnezzar of Babylon successfully besieges Jerusalem and carries off some of the treasure from the temple of God to Babylon. Nebuchadnezzar also captures some young men of the royal family with him to serve him in his court (Da 1:3). Daniel is one of them (1:6)

King Nebuchadnezzar's Dream in Daniel 2

- 31 Thou, O king, sawest, and behold a great image. This great image, whose brightness was excellent, stood before thee; and the form thereof was terrible.
- 32 This image's head was of fine gold, his breast and his arms of silver, his belly and his thighs of brass,
- 33 His legs of iron, his feet part of iron and part of clay.
- 34 Thou sawest till that a stone was cut out without hands, which smote the image upon his feet that were of iron and clay, and brake them to pieces.
- 35 Then was the iron, the clay, the brass, the silver, and the gold, broken to pieces together, and became like the chaff of the summer threshingfloors; and the wind carried them away, that no place was found for them: and the stone that smote the image became a great mountain, and filled the whole earth.

The First Kingdom: Babylon 605 BC led by Nebuchadnezzar II. Ended in 539 BC, capital city in Iraq

37 Thou, 0 king, art a king of kings: for the God of heaven hath given thee a kingdom, power, and strength, and glory.
38 And wheresoever the children of men dwell, the beasts of the field and the fowls of the heaven hath he given into thine hand, and hath made thee ruler over them all. **Thou art this head of gold**.

So according to God's Word, the great kingdom of Babylon, the "golden city" of ancient times (Is.14:4), with its great King Nebuchadnezzar, was undeniably the head of gold, or the beginning of this great image.

Isaiah 14:4 That thou shalt take up this proverb against the king of Babylon, and say, How hath the oppressor ceased! **the golden city** ceased!

Daniel 7:4 The first was like a lion, and had eagle's wings: I beheld till the wings thereof were plucked, and it was lifted up from the earth, and made stand upon the feet as a man, and a man's heart was given to it.

THIS IS THE SAME AS THE HEAD OF GOLD IN THE IMAGE AND IT REPRESENTS BABYLON. Its wings being plucked represent Nebuchadnezzar's abasement as a beast for 7 years (Dan.4:29-33), and "a man's heart...given to it" his subsequent salvation. (Dan.4:34-37)

The Second Kingdom: Medo-Persia founded 550 BC by Cyrus the Great. Ended in 330 BC, capital city in Iran

Daniel 2:39 And after thee shall arise another kingdom inferior to thee,...

According to world history, the dual kingdom of Medo-Persia followed Babylon; therefore we know what the kingdom of silver was without its even being named in the interpretation here. It is named, however, in a later chapter, the "MENE MENE" handwriting on the wall vision of Daniel 5:18-31, as being the kingdom that did conquer Babylon.

Daniel 5:28 PERES; Thy kingdom is divided, and given to the Medes and Persians.

Notice also the remarkable symbolism in the image. The dual kingdom of Medo-Persia is depicted here by two arms. Persia was the stronger of the two, just as in the body one arm is stronger than the other!

The second kingdom, the Medo-Persian empire is called a bear in Daniel

Daniel 7:5 And behold another beast, a second, like to a bear, and it raised up itself on one side, and it had three ribs in the mouth of it between the teeth of it: and they said thus unto it, Arise, devour much flesh.

Notice that the bear is a little higher on one side than the other because the Persians were a little more powerful than the Medes. The Medes conquered Babylon, but it was Cyrus, the Persian king, who actually ruled. This symbolism is also borne out in the vision of Daniel 8 which pictures "a ram which had two horns... but one was higher than the other." (Dan.8:3) It then says, "The ram... having two horns are the kings of Media and Persia." (Dan.8:20) The 3 ribs the bear devoured were the 3 nations which were conquered by the Medo-Persians. The primary nations were, of course, Egypt, Assyria, and Babylon.

Also in Daniel chapter 8 the Medo-Persian empire was represented by a ram!

Daniel 8:3 Then I lifted up mine eyes, and saw, and, behold, there stood before the river a ram which had two horns: and the two horns were high; but one was higher than the other, and the higher came up last. (The Medes conquered Babylon and the Persians ruled the empire.)

4 I saw the ram pushing westward, and northward, and southward; so that no beasts might stand before him, neither was there any that could deliver out of his hand; but he did according to his will, and became great.

Daniel 8:20 The ram which thou sawest having two horns are the kings of Media and Persia.

The Third Kingdom: Greece. Alexander the Great of Macedon succeeded his father Philip II to the throne in 336 BC and conquerored the civilized world in 10 years

Daniel 2:32b ...his belly and his thighs of brass...

Daniel 2:39b... and another third kingdom of brass, which shall bear rule over all the earth.

We know from history that this third kingdom, the one to follow Persia, was the Grecian Empire. In a later chapter Daniel specifically prophesies that Greece will be the conqueror of Medo-Persia. (Dan.8:21,22) This was fulfilled over three hundred years after the prophecy was given!

Daniel 8:21 And the rough goat is the king of Grecia: and the great horn (Alexander the Great) that is between his eyes is the

first king.

The empire of Alexander the Great was not necessarily the most powerful, but it was the most extensive. It extended almost to Italy, all the way to India, and all the way from southern Russia down into Africa, bearing rule over or dominating the world of his day. In just 10 years Alexander conquered the known civilized Western world, the fastest world conquest in history!

The Greeks were also interested in philosophy and religion or spiritual things. And it is held by the Greeks and by almost all religions that the seat of the spirit is in the BELLY. As Jesus said, "Out of his BELLY shall flow rivers of living water. (But this spake He of the Spirit.)" (Jn.7:38,39)

In Daniel 7 Alexander was likened to a leopard!

Daniel 7:6 After this I beheld, and lo another, like a leopard, which had upon the back of it four wings of a fowl; the beast had also four heads; and dominion was given to it.

The four heads represents Alexander's four generals. As Alexander said on his deathbed when his generals asked, "Well, which one of us is to inherit the kingdom?" He said, "To the strongest!" But they were smart! They decided it wasn't smart to fight it out until they found out who was strongest & one man take over the whole thing. They said, "Well, let's just make peace now & divvy it up & you take that & I'll take this & you can take that etc." So it was divided up into four areas which each general ruling one area.

In Daniel 8 Alexander is likened to a he goat!

Daniel 8:5 And as I was considering, behold, an he goat came from the west on the face of the whole earth, and touched not the ground: and the goat had a notable horn between his eyes.

(Alexander)

- 6 And he came to the ram that had two horns, which I had seen standing before the river, and ran unto him in the fury of his power. (Conquered Medo-Persia)
- 7 And I saw him come close unto the ram, and he was moved with choler against him, and smote the ram, and brake his two horns: and there was no power in the ram to stand before him, but he cast him down to the ground, and stamped upon him: and there was none that could deliver the ram out of his hand.
- 8 Therefore the he goat waxed very great: and when he was strong, the great horn was broken; and for it came up four notable ones toward the four winds of heaven.

The fourth Kingdom: Rome

Daniel 2:40 And the fourth kingdom shall be strong as iron: forasmuch as iron breaketh in pieces and subdueth all things: and as iron that breaketh all these, shall it break in pieces and bruise.

- 41 And whereas thou sawest the feet and toes, part of potters' clay, and part of iron, the kingdom shall be divided; but there shall be in it of the strength of the iron, forasmuch as thou sawest the iron mixed with miry clay.
- 42 And as the toes of the feet were part of iron, and part of clay, so the kingdom shall be partly strong, and partly broken.
- 43 And whereas thou sawest iron mixed with miry clay, they shall mingle themselves with the seed of men: but they shall not cleave one to another, even as iron is not mixed with clay.
- 44 And in the days of these kings shall the God of heaven set up a kingdom, which shall never be destroyed: and the kingdom shall not be left to other people, but it shall break in pieces and consume all these kingdoms, and it shall stand for ever.

Daniel 7:7 After this I saw in the night visions, and behold a fourth beast, dreadful and terrible, and strong exceedingly; and it had great iron teeth: it devoured and brake in pieces, and stamped the residue with the feet of it: and it was diverse from all the beasts that were before it; and it had ten horns.

This fourth kingdom was rome. Rome, the tough, iron-fisted kingdom which clamped down with IRON MILITARY RULE over the entire known world in the days before Christ, was one of the longest-reigning empires the world has ever known. It so "subdued all things" that for nearly one hundred years there were no major wars, no one even being able to muster a force against the Roman rule.

Here again, it is very interesting to note how similar this particular part of the image is to the actual fulfilment of the Roman Empire. Two legs of iron: Was Rome ever divided into two parts? Yes! In its decline it was divided into an Eastern and Western Empire. The Western Empire was ruled by Rome, and the Eastern Empire, ruled by Constantinople, was called the Byzantine Empire. So EVEN THE PARTS OF THE IMAGE ITSELF SYMBOLISE THE KINGDOMS OF MAN, AND THIS BECOMES EXTREMELY SIGNIFICANT AS WE GO ON TO THE FEET.

The city of Rome is in Italy, and the country of Italy on a world map looks something like a boot! "Boots on the ground" is an expression for foreign infantry or military presence in a country.

Most Bible believing scholars teach that the last and 4th kingdom of the interpretation of the dream that King Nebuchadnezzar had in Daniel chapter 2 is the Roman Empire. Is therefore the Roman Empire ruling the earth today? Most people don't seem to think so. But Daniel 2 teaches the fourth kingdom continues till the "stone cut without hands" — Jesus Christ — comes and destroys it.

Daniel 2:45 Forasmuch as thou sawest that the stone was cut out of the mountain without hands, and that it brake in pieces the iron, the brass, the clay, the silver, and the gold; the great God hath made known to the king what shall come to pass hereafter: and the dream is certain, and the interpretation thereof sure.

Message from a Ukrainian Refugee about Putin and the Russian Invasion of Ukraine



This meme was posted by my Ukrainian friend on her Facebook timeline.

Since the Russian invasion of Ukraine, I've been very concerned about a dear Ukrainian sister in Christ, Lydia from Kyiv. I have known her since 1994. She was one of my partners in St. Petersburg, Russia, my interpreter and teammate in evangelistic work sharing the Gospel with the people of Russia. Thankfully she fled her home in Kyiv and is now safe in Poland.

I've been hearing different interpretations of the Russian invasion. Dr. Chuck Baldwin, a pastor I like, wrote a recent article entitled "Ukraine is not a victim" in which he is very critical of the Ukrainian government and talks about all its faults and misdeeds. And I listened to the testimonial of an American from Texas who lived in the Donbas area of Ukraine for 8 years, became a Russian citizen, and is pro-Putin and anti-Ukrainian government policies. And because the US and Western governments of the world are so anti-Russian / anti-Putin, it makes me wonder if I'm not being bombarded with another round of government propaganda. I, therefore, was very interested to hear directly from my Ukrainian friend what her views are. Below is the dialog we had:

Me: Lydia, I know this may not be a good time for you now, but I would like to hear your opinion about the Russian invasion. One man I am listening to now is an American from Texas who has lived in Donbas in eastern Ukraine for the last 8 years. He is telling me just the opposite of what western media is saying!! He says that Biden and the USA are most responsible for provoking Putin to invade to protect ethnic Russians from Nazis in eastern Ukraine.

Lydia: From my own relatives and acquaintances I know how strong and effective Russian propaganda is. I experienced friends turned into enemies because they believe what was broadcasted more than people. But the truth is people from Donbas could travel all over Ukraine freely, speak Russian, and even get Ukrainian social

benefits and nobody was attacking them nor in words or by deeds. You are a smart man, but it seems to me you've caught some of that propaganda.

Putin is a liar. And he used the same false accusations to attack other countries as well. You might've known that. That video you've posted about what was happening in 2013, before and after is not accurate, not true. The same twisted lies they fed and keep on feeding to Russians and anybody for that matter.

If someone in power is concerned that somebody's rights are violated (like ethnic Russians), why can't he do it the civil way: collect the evidence and go to international court with it?

Ukrainian independence is what Putin didn't like and you can get that message from his speeches before he started this inhuman war. By what can you justify targeted bombing of an maternity hospital, an orphanage and shootings of unarmed civilians?

Why do we had to run from our home for dear life and to become refugees now? Every day cites and towns are bombed. Every day something is destroyed in Kyiv and I check news in the morning worried sick it might be our apartment building. I just pray for my parents, sister and all my loved ones to be safe. Over 60 of my fellow Kievans were killed, 4 of them were kids.

In Ukraine people of different nationalities live together peacefully and we don't want anyone's territory. We want to live in peace, choose our own course without anybody dictating us what to do.

The sad truth is most Russians consider themselves superior to Ukrainians and any other nations as well. Doesn't that resemble you something?

I'm sorry if I sound overly emotional, I actually am and some of the thoughts are hard to put into words. I didn't want to offend you in any way, and I hope you'll come to the right conclusions.

Me: Lydia, if you know me at all you should know that I am a truth seeker. The reason I asked you is that I value the views of people who live in Ukraine. I believe you more than the media. I am praying daily for the end of the war and the end of Putin.

I know from experience not to trust the mainstream media, and I can't even trust alternative media. That's why I asked you, Lydia, for your views. I do not trust any head of State, not Putin, not Biden, and not Trump either. I believe the world is under the control of the Beast of Revelation chapter 13. It's not the future, it's right NOW! I'm sorry if you thought I am influenced by Putin's propaganda. I am not. I know he's an evil man and a criminal. But

so is Joe Biden, and so is probably all the American presidents since the early 20th century with the possible exception of John F Kennedy. I also know the first casualty of war is the truth. The Western media tells me Russia is committing war crimes. They also told me Iraq has weapons of mass destruction. That was proven to be a lie. War is a Racket

CHAPTER ONE War Is A Racket

WAR is a racket. It always has been.

It is possibly the oldest, easily the most profitable, surely the most vicious. It is the only one international in scope. It is the only one in which the profits are reckoned in dollars and the losses in lives.

A racket is best described, I believe, as something that is not what it seems to the majority of the people. Only a small "inside" group knows what it is about. It is conducted for the benefit of the very few, at the expense of the very many. Out of war a few people make huge fortunes.

In the World War [I] a mere handful garnered the profits of the conflict. At least 21,000 new millionaires and billionaires were made in the United States during the World War. That many admitted their huge blood gains in their income tax returns. How many other war millionaires falsified their tax returns no one knows.

How many of these war millionaires shouldered a rifle? How many of them dug a trench? How many of them knew what it meant to go hungry in a rat-infested dug-out? How many of them spent sleepless, frightened nights, ducking shells and shrapnel and machine gun bullets? How many of them parried a bayonet thrust of an enemy? How many of them were wounded or killed in battle?

Out of war nations acquire additional territory, if they are victorious. They just take it. This newly acquired territory promptly is exploited by the few — the selfsame few who wrung dollars out of blood in the war. The general public shoulders the bill.

And what is this bill?

This bill renders a horrible accounting. Newly placed gravestones. Mangled bodies. Shattered minds. Broken hearts and homes. Economic instability. Depression and all its attendant miseries. Back-breaking taxation for

generations and generations.

For a great many years, as a soldier, I had a suspicion that war was a racket; not until I retired to civil life did I fully realize it. Now that I see the international war clouds gathering, as they are today, I must face it and speak out.

Again they are choosing sides. France and Russia met and agreed to stand side by side. Italy and Austria hurried to make a similar agreement. Poland and Germany cast sheep's eyes at each other, forgetting for the nonce [one unique occasion], their dispute over the Polish Corridor.

The assassination of King Alexander of Jugoslavia [Yugoslavia] complicated matters. Jugoslavia and Hungary, long bitter enemies, were almost at each other's throats. Italy was ready to jump in. But France was waiting. So was Czechoslovakia. All of them are looking ahead to war. Not the people — not those who fight and pay and die — only those who foment wars and remain safely at home to profit.

There are 40,000,000 men under arms in the world today, and our statesmen and diplomats have the temerity to say that war is not in the making.

Hell's bells! Are these 40,000,000 men being trained to be dancers?

Not in Italy, to be sure. Premier Mussolini knows what they are being trained for. He, at least, is frank enough to speak out. Only the other day, Il Duce in "International Conciliation," the publication of the Carnegie Endowment for International Peace, said:

"And above all, Fascism, the more it considers and observes the future and the development of humanity quite apart from political considerations of the moment, believes neither in the possibility nor the utility of perpetual peace. . . . War alone brings up to its highest tension all human energy and puts the stamp of nobility upon the people who have the courage to meet it."

Undoubtedly Mussolini means exactly what he says. His well-trained army, his great fleet of planes, and even his navy are ready for war — anxious for it, apparently. His recent stand at the side of Hungary in the latter's dispute with Jugoslavia showed that. And the hurried mobilization of his troops on the Austrian border after the assassination of Dollfuss showed it too. There are others in Europe too whose sabre rattling presages war, sooner or later.

Herr Hitler, with his rearming Germany and his constant demands for more and more arms, is an equal if not greater menace to peace. France only recently increased the term of military service for its youth from a year to eighteen months.

Yes, all over, nations are camping in their arms. The mad dogs of Europe are on the loose. In the Orient the maneuvering is more adroit. Back in 1904, when Russia and Japan fought, we kicked out our old friends the Russians and backed Japan. Then our very generous international bankers were financing Japan. Now the trend is to poison us against the Japanese. What does the

"open door" policy to China mean to us? Our trade with China is about \$90,000,000 a year. Or the Philippine Islands? We have spent about \$600,000,000 in the Philippines in thirty-five years and we (our bankers and industrialists and speculators) have private investments there of less than \$200,000,000.

Then, to save that China trade of about \$90,000,000, or to protect these private investments of less than \$200,000,000 in the Philippines, we would be all stirred up to hate Japan and go to war — a war that might well cost us tens of billions of dollars, hundreds of thousands of lives of Americans, and many more hundreds of thousands of physically maimed and mentally unbalanced men.

Of course, for this loss, there would be a compensating profit — fortunes would be made. Millions and billions of dollars would be piled up. By a few. Munitions makers. Bankers. Ship builders. Manufacturers. Meat packers. Speculators. They would fare well.

Yes, they are getting ready for another war. Why shouldn't they? It pays high dividends.

But what does it profit the men who are killed? What does it profit their mothers and sisters, their wives and their sweethearts? What does it profit their children?

What does it profit anyone except the very few to whom war means huge profits?

Yes, and what does it profit the nation?

Take our own case. Until 1898 we didn't own a bit of territory outside the mainland of North America. At that time our national debt was a little more than \$1,000,000,000. Then we became "internationally minded." We forgot, or shunted aside, the advice of the Father of our country. We forgot George Washington's warning about "entangling alliances." We went to war. We acquired outside territory. At the end of the World War period, as a direct result of our fiddling in international affairs, our national debt had jumped to over \$25,000,000,000. Our total favorable trade balance during the twenty-five-year period was about \$24,000,000,000. Therefore, on a purely bookkeeping basis, we ran a little behind year for year, and that foreign trade might well have been ours without the wars.

It would have been far cheaper (not to say safer) for the average American who pays the bills to stay out of foreign entanglements. For a very few this racket, like bootlegging and other underworld rackets, brings fancy profits, but the cost of operations is always transferred to the people — who do not profit.

CHAPTER TWO Who Makes The Profits?

The World War, rather our brief participation in it, has cost the United States some \$52,000,000,000. Figure it out. That means \$400 to every American

man, woman, and child. And we haven't paid the debt yet. We are paying it, our children will pay it, and our children's children probably still will be paying the cost of that war.

The normal profits of a business concern in the United States are six, eight, ten, and sometimes twelve percent. But war-time profits — ah! that is another matter — twenty, sixty, one hundred, three hundred, and even eighteen hundred per cent — the sky is the limit. All that traffic will bear. Uncle Sam has the money. Let's get it.

Of course, it isn't put that crudely in war time. It is dressed into speeches about patriotism, love of country, and "we must all put our shoulders to the wheel," but the profits jump and leap and skyrocket — and are safely pocketed. Let's just take a few examples:

Take our friends the du Ponts, the powder people — didn't one of them testify before a Senate committee recently that their powder won the war? Or saved the world for democracy? Or something? How did they do in the war? They were a patriotic corporation. Well, the average earnings of the du Ponts for the period 1910 to 1914 were \$6,000,000 a year. It wasn't much, but the du Ponts managed to get along on it. Now let's look at their average yearly profit during the war years, 1914 to 1918. Fifty-eight million dollars a year profit we find! Nearly ten times that of normal times, and the profits of normal times were pretty good. An increase in profits of more than 950 per cent.

Take one of our little steel companies that patriotically shunted aside the making of rails and girders and bridges to manufacture war materials. Well, their 1910-1914 yearly earnings averaged \$6,000,000. Then came the war. And, like loyal citizens, Bethlehem Steel promptly turned to munitions making. Did their profits jump — or did they let Uncle Sam in for a bargain? Well, their 1914-1918 average was \$49,000,000 a year!

Or, let's take United States Steel. The normal earnings during the five-year period prior to the war were \$105,000,000 a year. Not bad. Then along came the war and up went the profits. The average yearly profit for the period 1914-1918 was \$240,000,000. Not bad.

There you have some of the steel and powder earnings. Let's look at something else. A little copper, perhaps. That always does well in war times.

Anaconda, for instance. Average yearly earnings during the pre-war years 1910-1914 of \$10,000,000. During the war years 1914-1918 profits leaped to \$34,000,000 per year.

Or Utah Copper. Average of \$5,000,000 per year during the 1910-1914 period. Jumped to an average of \$21,000,000 yearly profits for the war period.

Let's group these five, with three smaller companies. The total yearly average profits of the pre-war period 1910-1914 were \$137,480,000. Then along came the war. The average yearly profits for this group skyrocketed to \$408,300,000.

A little increase in profits of approximately 200 per cent.

Does war pay? It paid them. But they aren't the only ones. There are still others. Let's take leather.

For the three-year period before the war the total profits of Central Leather Company were \$3,500,000. That was approximately \$1,167,000 a year. Well, in 1916 Central Leather returned a profit of \$15,000,000, a small increase of 1,100 per cent. That's all. The General Chemical Company averaged a profit for the three years before the war of a little over \$800,000 a year. Came the war, and the profits jumped to \$12,000,000. a leap of 1,400 per cent.

International Nickel Company — and you can't have a war without nickel — showed an increase in profits from a mere average of \$4,000,000 a year to \$73,000,000 yearly. Not bad? An increase of more than 1,700 per cent.

American Sugar Refining Company averaged \$2,000,000 a year for the three years before the war. In 1916 a profit of \$6,000,000 was recorded.

Listen to Senate Document No. 259. The Sixty-Fifth Congress, reporting on corporate earnings and government revenues. Considering the profits of 122 meat packers, 153 cotton manufacturers, 299 garment makers, 49 steel plants, and 340 coal producers during the war. Profits under 25 per cent were exceptional. For instance the coal companies made between 100 per cent and 7,856 per cent on their capital stock during the war. The Chicago packers doubled and tripled their earnings.

And let us not forget the bankers who financed the great war. If anyone had the cream of the profits it was the bankers. Being partnerships rather than incorporated organizations, they do not have to report to stockholders. And their profits were as secret as they were immense. How the bankers made their millions and their billions I do not know, because those little secrets never become public — even before a Senate investigatory body.

But here's how some of the other patriotic industrialists and speculators chiseled their way into war profits.

Take the shoe people. They like war. It brings business with abnormal profits. They made huge profits on sales abroad to our allies. Perhaps, like the munitions manufacturers and armament makers, they also sold to the enemy. For a dollar is a dollar whether it comes from Germany or from France. But they did well by Uncle Sam too. For instance, they sold Uncle Sam 35,000,000 pairs of hobnailed service shoes. There were 4,000,000 soldiers. Eight pairs, and more, to a soldier. My regiment during the war had only one pair to a soldier. Some of these shoes probably are still in existence. They were good shoes. But when the war was over Uncle Sam has a matter of 25,000,000 pairs left over. Bought — and paid for. Profits recorded and pocketed.

There was still lots of leather left. So the leather people sold your Uncle Sam hundreds of thousands of McClellan saddles for the cavalry. But there wasn't any American cavalry overseas! Somebody had to get rid of this leather, however. Somebody had to make a profit in it — so we had a lot of McClellan saddles. And we probably have those yet.

Also somebody had a lot of mosquito netting. They sold your Uncle Sam 20,000,000 mosquito nets for the use of the soldiers overseas. I suppose the boys were expected to put it over them as they tried to sleep in muddy trenches — one hand scratching cooties on their backs and the other making passes at scurrying rats. Well, not one of these mosquito nets ever got to France!

Anyhow, these thoughtful manufacturers wanted to make sure that no soldier would be without his mosquito net, so 40,000,000 additional yards of mosquito netting were sold to Uncle Sam.

There were pretty good profits in mosquito netting in those days, even if there were no mosquitoes in France. I suppose, if the war had lasted just a little longer, the enterprising mosquito netting manufacturers would have sold your Uncle Sam a couple of consignments of mosquitoes to plant in France so that more mosquito netting would be in order.

Airplane and engine manufacturers felt they, too, should get their just profits out of this war. Why not? Everybody else was getting theirs. So \$1,000,000,000 — count them if you live long enough — was spent by Uncle Sam in building airplane engines that never left the ground! Not one plane, or motor, out of the billion dollars worth ordered, ever got into a battle in France. Just the same the manufacturers made their little profit of 30, 100, or perhaps 300 per cent.

Undershirts for soldiers cost $14\$ [cents] to make and uncle Sam paid $30\$ to $40\$ each for them — a nice little profit for the undershirt manufacturer. And the stocking manufacturer and the uniform manufacturers and the cap manufacturers and the steel helmet manufacturers — all got theirs.

Why, when the war was over some 4,000,000 sets of equipment – knapsacks and the things that go to fill them – crammed warehouses on this side. Now they are being scrapped because the regulations have changed the contents. But the manufacturers collected their wartime profits on them – and they will do it all over again the next time.

There were lots of brilliant ideas for profit making during the war.

One very versatile patriot sold Uncle Sam twelve dozen 48-inch wrenches. Oh, they were very nice wrenches. The only trouble was that there was only one nut ever made that was large enough for these wrenches. That is the one that holds the turbines at Niagara Falls. Well, after Uncle Sam had bought them and the manufacturer had pocketed the profit, the wrenches were put on freight cars and shunted all around the United States in an effort to find a use for them. When the Armistice was signed it was indeed a sad blow to the wrench manufacturer. He was just about to make some nuts to fit the wrenches. Then he planned to sell these, too, to your Uncle Sam.

Still another had the brilliant idea that colonels shouldn't ride in automobiles, nor should they even ride on horseback. One has probably seen a picture of Andy Jackson riding in a buckboard. Well, some 6,000 buckboards were sold to Uncle Sam for the use of colonels! Not one of them was used. But

the buckboard manufacturer got his war profit.

The shipbuilders felt they should come in on some of it, too. They built a lot of ships that made a lot of profit. More than \$3,000,000,000 worth. Some of the ships were all right. But \$635,000,000 worth of them were made of wood and wouldn't float! The seams opened up — and they sank. We paid for them, though. And somebody pocketed the profits.

It has been estimated by statisticians and economists and researchers that the war cost your Uncle Sam \$52,000,000,000. Of this sum, \$39,000,000,000 was expended in the actual war itself. This expenditure yielded \$16,000,000,000 in profits. That is how the 21,000 billionaires and millionaires got that way. This \$16,000,000,000 profits is not to be sneezed at. It is quite a tidy sum. And it went to a very few.

The Senate (Nye) committee probe of the munitions industry and its wartime profits, despite its sensational disclosures, hardly has scratched the surface.

Even so, it has had some effect. The State Department has been studying "for some time" methods of keeping out of war. The War Department suddenly decides it has a wonderful plan to spring. The Administration names a committee — with the War and Navy Departments ably represented under the chairmanship of a Wall Street speculator — to limit profits in war time. To what extent isn't suggested. Hmmm. Possibly the profits of 300 and 600 and 1,600 per cent of those who turned blood into gold in the World War would be limited to some smaller figure.

Apparently, however, the plan does not call for any limitation of losses — that is, the losses of those who fight the war. As far as I have been able to ascertain there is nothing in the scheme to limit a soldier to the loss of but one eye, or one arm, or to limit his wounds to one or two or three. Or to limit the loss of life.

There is nothing in this scheme, apparently, that says not more than 12 per cent of a regiment shall be wounded in battle, or that not more than 7 per cent in a division shall be killed.

Of course, the committee cannot be bothered with such trifling matters.

CHAPTER THREE Who Pays The Bills?

Who provides the profits — these nice little profits of 20, 100, 300, 1,500 and 1,800 per cent? We all pay them — in taxation. We paid the bankers their profits when we bought Liberty Bonds at \$100.00 and sold them back at \$84 or \$86 to the bankers. These bankers collected \$100 plus. It was a simple manipulation. The bankers control the security marts. It was easy for them to depress the price of these bonds. Then all of us — the people — got frightened and sold the bonds at \$84 or \$86. The bankers bought them. Then these same bankers stimulated a boom and government bonds went to par — and above. Then the bankers collected their profits.

But the soldier pays the biggest part of the bill.

If you don't believe this, visit the American cemeteries on the battlefields abroad. Or visit any of the veteran's hospitals in the United States. On a tour of the country, in the midst of which I am at the time of this writing, I have visited eighteen government hospitals for veterans. In them are a total of about 50,000 destroyed men — men who were the pick of the nation eighteen years ago. The very able chief surgeon at the government hospital; at Milwaukee, where there are 3,800 of the living dead, told me that mortality among veterans is three times as great as among those who stayed at home.

Boys with a normal viewpoint were taken out of the fields and offices and factories and classrooms and put into the ranks. There they were remolded; they were made over; they were made to "about face"; to regard murder as the order of the day. They were put shoulder to shoulder and, through mass psychology, they were entirely changed. We used them for a couple of years and trained them to think nothing at all of killing or of being killed.

Then, suddenly, we discharged them and told them to make another "about face" ! This time they had to do their own readjustment, sans [without] mass psychology, sans officers' aid and advice and sans nation-wide propaganda. We didn't need them any more. So we scattered them about without any "three-minute" or "Liberty Loan" speeches or parades. Many, too many, of these fine young boys are eventually destroyed, mentally, because they could not make that final "about face" alone.

In the government hospital in Marion, Indiana, 1,800 of these boys are in pens! Five hundred of them in a barracks with steel bars and wires all around outside the buildings and on the porches. These already have been mentally destroyed. These boys don't even look like human beings. Oh, the looks on their faces! Physically, they are in good shape; mentally, they are gone.

There are thousands and thousands of these cases, and more and more are coming in all the time. The tremendous excitement of the war, the sudden cutting off of that excitement — the young boys couldn't stand it.

That's a part of the bill. So much for the dead — they have paid their part of the war profits. So much for the mentally and physically wounded — they are paying now their share of the war profits. But the others paid, too — they paid with heartbreaks when they tore themselves away from their firesides and their families to don the uniform of Uncle Sam — on which a profit had been made. They paid another part in the training camps where they were regimented and drilled while others took their jobs and their places in the lives of their communities. The paid for it in the trenches where they shot and were shot; where they were hungry for days at a time; where they slept in the mud and the cold and in the rain — with the moans and shrieks of the dying for a horrible lullaby.

But don't forget — the soldier paid part of the dollars and cents bill too.

Up to and including the Spanish-American War, we had a prize system, and

soldiers and sailors fought for money. During the Civil War they were paid bonuses, in many instances, before they went into service. The government, or states, paid as high as \$1,200 for an enlistment. In the Spanish-American War they gave prize money. When we captured any vessels, the soldiers all got their share — at least, they were supposed to. Then it was found that we could reduce the cost of wars by taking all the prize money and keeping it, but conscripting [drafting] the soldier anyway. Then soldiers couldn't bargain for their labor, Everyone else could bargain, but the soldier couldn't.

Napoleon once said,

"All men are enamored of decorations . . . they positively hunger for them."

So by developing the Napoleonic system — the medal business — the government learned it could get soldiers for less money, because the boys liked to be decorated. Until the Civil War there were no medals. Then the Congressional Medal of Honor was handed out. It made enlistments easier. After the Civil War no new medals were issued until the Spanish-American War.

In the World War, we used propaganda to make the boys accept conscription. They were made to feel ashamed if they didn't join the army.

So vicious was this war propaganda that even God was brought into it. With few exceptions our clergymen joined in the clamor to kill, kill, kill. To kill the Germans. God is on our side . . . it is His will that the Germans be killed.

And in Germany, the good pastors called upon the Germans to kill the allies . . to please the same God. That was a part of the general propaganda, built up to make people war conscious and murder conscious.

Beautiful ideals were painted for our boys who were sent out to die. This was the "war to end all wars." This was the "war to make the world safe for democracy." No one mentioned to them, as they marched away, that their going and their dying would mean huge war profits. No one told these American soldiers that they might be shot down by bullets made by their own brothers here. No one told them that the ships on which they were going to cross might be torpedoed by submarines built with United States patents. They were just told it was to be a "glorious adventure."

Thus, having stuffed patriotism down their throats, it was decided to make them help pay for the war, too. So, we gave them the large salary of \$30 a month.

All they had to do for this munificent sum was to leave their dear ones behind, give up their jobs, lie in swampy trenches, eat canned willy (when they could get it) and kill and kill . . . and be killed.

But wait!

Half of that wage (just a little more than a riveter in a shipyard or a laborer in a munitions factory safe at home made in a day) was promptly taken from him to support his dependents, so that they would not become a charge upon his community. Then we made him pay what amounted to accident insurance — something the employer pays for in an enlightened state — and that cost him \$6 a month. He had less than \$9 a month left.

Then, the most crowning insolence of all — he was virtually blackjacked into paying for his own ammunition, clothing, and food by being made to buy Liberty Bonds. Most soldiers got no money at all on pay days.

We made them buy Liberty Bonds at \$100 and then we bought them back — when they came back from the war and couldn't find work — at \$84 and \$86. And the soldiers bought about \$2,000,000,000 worth of these bonds!

Yes, the soldier pays the greater part of the bill. His family pays too. They pay it in the same heart-break that he does. As he suffers, they suffer. At nights, as he lay in the trenches and watched shrapnel burst about him, they lay home in their beds and tossed sleeplessly — his father, his mother, his wife, his sisters, his brothers, his sons, and his daughters.

When he returned home minus an eye, or minus a leg or with his mind broken, they suffered too — as much as and even sometimes more than he. Yes, and they, too, contributed their dollars to the profits of the munitions makers and bankers and shipbuilders and the manufacturers and the speculators made. They, too, bought Liberty Bonds and contributed to the profit of the bankers after the Armistice in the hocus-pocus of manipulated Liberty Bond prices.

And even now the families of the wounded men and of the mentally broken and those who never were able to readjust themselves are still suffering and still paying.

CHAPTER FOUR How To Smash This Racket!

WELL, it's a racket, all right.

A few profit — and the many pay. But there is a way to stop it. You can't end it by disarmament conferences. You can't eliminate it by peace parleys at Geneva. Well-meaning but impractical groups can't wipe it out by resolutions. It can be smashed effectively only by taking the profit out of war.

The only way to smash this racket is to conscript capital and industry and labor before the nations manhood can be conscripted. One month before the Government can conscript the young men of the nation — it must conscript capital and industry and labor. Let the officers and the directors and the high-powered executives of our armament factories and our munitions makers and our shipbuilders and our airplane builders and the manufacturers of all the other things that provide profit in war time as well as the bankers and the speculators, be conscripted — to get \$30 a month, the same wage as the lads in the trenches get.

Let the workers in these plants get the same wages — all the workers, all

presidents, all executives, all directors, all managers, all bankers — yes, and all generals and all admirals and all officers and all politicians and all government office holders — everyone in the nation be restricted to a total monthly income not to exceed that paid to the soldier in the trenches!

Let all these kings and tycoons and masters of business and all those workers in industry and all our senators and governors and majors pay half of their monthly \$30 wage to their families and pay war risk insurance and buy Liberty Bonds.

Why shouldn't they?

They aren't running any risk of being killed or of having their bodies mangled or their minds shattered. They aren't sleeping in muddy trenches. They aren't hungry. The soldiers are!

Give capital and industry and labor thirty days to think it over and you will find, by that time, there will be no war. That will smash the war racket — that and nothing else.

Maybe I am a little too optimistic. Capital still has some say. So capital won't permit the taking of the profit out of war until the people — those who do the suffering and still pay the price — make up their minds that those they elect to office shall do their bidding, and not that of the profiteers.



Another step necessary in this fight to smash the war racket is the limited plebiscite to determine whether a war should be declared. A plebiscite not of all the voters but merely of those who would be called upon to do the fighting and dying. There wouldn't be very much sense in having a 76-year-old president of a munitions factory or the flat-footed head of an international banking firm or the cross-eyed manager of a uniform manufacturing plant — all of whom see visions of tremendous profits in the event of war — voting on whether the nation should go to war or not. They never would be called upon to shoulder arms — to sleep in a trench and to be shot. Only those who would be called upon to risk their lives for their country should have the privilege of voting to determine whether the nation should go to war.

There is ample precedent for restricting the voting to those affected. Many of our states have restrictions on those permitted to vote. In most, it is necessary to be able to read and write before you may vote. In some, you must own property. It would be a simple matter each year for the men coming of military age to register in their communities as they did in the draft during the World War and be examined physically. Those who could pass and who would therefore be called upon to bear arms in the event of war would be eligible to vote in a limited plebiscite. They should be the ones to have the power to decide — and not a Congress few of whose members are within the age limit and fewer still of whom are in physical condition to bear arms. Only those who must suffer should have the right to vote.

A third step in this business of smashing the war racket is to make certain that our military forces are truly forces for defense only.

At each session of Congress the question of further naval appropriations comes up. The swivel-chair admirals of Washington (and there are always a lot of them) are very adroit lobbyists. And they are smart. They don't shout that "We need a lot of battleships to war on this nation or that nation." Oh no. First of all, they let it be known that America is menaced by a great naval power. Almost any day, these admirals will tell you, the great fleet of this supposed enemy will strike suddenly and annihilate 125,000,000 people. Just like that. Then they begin to cry for a larger navy. For what? To fight the enemy? Oh my, no. Oh, no. For defense purposes only.

Then, incidentally, they announce maneuvers in the Pacific. For defense. Uh, huh.

The Pacific is a great big ocean. We have a tremendous coastline on the Pacific. Will the maneuvers be off the coast, two or three hundred miles? Oh, no. The maneuvers will be two thousand, yes, perhaps even thirty-five hundred miles, off the coast.

The Japanese, a proud people, of course will be pleased beyond expression to see the united States fleet so close to Nippon's shores. Even as pleased as would be the residents of California were they to dimly discern through the morning mist, the Japanese fleet playing at war games off Los Angeles.

The ships of our navy, it can be seen, should be specifically limited, by law, to within 200 miles of our coastline. Had that been the law in 1898 the Maine would never have gone to Havana Harbor. She never would have been blown up. There would have been no war with Spain with its attendant loss of life. Two hundred miles is ample, in the opinion of experts, for defense purposes. Our nation cannot start an offensive war if its ships can't go further than 200 miles from the coastline. Planes might be permitted to go as far as 500 miles from the coast for purposes of reconnaissance. And the army should never leave the territorial limits of our nation.

To summarize: Three steps must be taken to smash the war racket.

- 1. We must take the profit out of war.
- 2. We must permit the youth of the land who would bear arms to decide whether or not there should be war.
- 3. We must limit our military forces to home defense purposes.

CHAPTER FIVE To Hell With War!

I am not a fool as to believe that war is a thing of the past. I know the people do not want war, but there is no use in saying we cannot be pushed into another war.

Looking back, Woodrow Wilson was re-elected president in 1916 on a platform that he had "kept us out of war" and on the implied promise that he would "keep us out of war." Yet, five months later he asked Congress to declare war

on Germany.

In that five-month interval the people had not been asked whether they had changed their minds. The 4,000,000 young men who put on uniforms and marched or sailed away were not asked whether they wanted to go forth to suffer and die.

Then what caused our government to change its mind so suddenly?

Money.

An allied commission, it may be recalled, came over shortly before the war declaration and called on the President. The President summoned a group of advisers. The head of the commission spoke. Stripped of its diplomatic language, this is what he told the President and his group:

"There is no use kidding ourselves any longer. The cause of the allies is lost. We now owe you (American bankers, American munitions makers, American manufacturers, American speculators, American exporters) five or six billion dollars.

If we lose (and without the help of the United States we must lose) we, England, France and Italy, cannot pay back this money . . . and Germany won't.

So . . . "

Had secrecy been outlawed as far as war negotiations were concerned, and had the press been invited to be present at that conference, or had radio been available to broadcast the proceedings, America never would have entered the World War. But this conference, like all war discussions, was shrouded in utmost secrecy. When our boys were sent off to war they were told it was a "war to make the world safe for democracy" and a "war to end all wars."

Well, eighteen years after, the world has less of democracy than it had then. Besides, what business is it of ours whether Russia or Germany or England or France or Italy or Austria live under democracies or monarchies? Whether they are Fascists or Communists? Our problem is to preserve our own democracy.

And very little, if anything, has been accomplished to assure us that the World War was really the war to end all wars.

Yes, we have had disarmament conferences and limitations of arms conferences. They don't mean a thing. One has just failed; the results of another have been nullified. We send our professional soldiers and our sailors and our politicians and our diplomats to these conferences. And what happens?

The professional soldiers and sailors don't want to disarm. No admiral wants to be without a ship. No general wants to be without a command. Both mean men

without jobs. They are not for disarmament. They cannot be for limitations of arms. And at all these conferences, lurking in the background but all-powerful, just the same, are the sinister agents of those who profit by war. They see to it that these conferences do not disarm or seriously limit armaments.

The chief aim of any power at any of these conferences has not been to achieve disarmament to prevent war but rather to get more armament for itself and less for any potential foe.

There is only one way to disarm with any semblance of practicability. That is for all nations to get together and scrap every ship, every gun, every rifle, every tank, every war plane. Even this, if it were possible, would not be enough.

The next war, according to experts, will be fought not with battleships, not by artillery, not with rifles and not with machine guns. It will be fought with deadly chemicals and gases.

Secretly each nation is studying and perfecting newer and ghastlier means of annihilating its foes wholesale. Yes, ships will continue to be built, for the shipbuilders must make their profits. And guns still will be manufactured and powder and rifles will be made, for the munitions makers must make their huge profits. And the soldiers, of course, must wear uniforms, for the manufacturer must make their war profits too.

But victory or defeat will be determined by the skill and ingenuity of our scientists.

If we put them to work making poison gas and more and more fiendish mechanical and explosive instruments of destruction, they will have no time for the constructive job of building greater prosperity for all peoples. By putting them to this useful job, we can all make more money out of peace than we can out of war — even the munitions makers.

So…I say,

TO HELL WITH WAR!

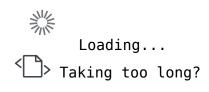

The Wickedness of War



Hitler meets Pope Pius XII

I first posted this article on Aug. 26, 2009. Now because of Russia's invasion of Ukraine, I thought Christians might appreciate this message and stand against the spirit of war. The only justifiable war according to the Bible and in my opinion, is one of self-defense when an enemy attempts to invade one's nation.

FROM THE CHRISTIAN REVIEW, JUNE 1838, PP. 230-237, UNSIGNED

The war spirit is so wrought into the texture of governments and the habits of national thinking, and even into our very festivals and pomps, that its occasional recurrence is deemed a matter of unavoidable necessity. Setting aside the matter of a defensive war for now, it is our intention to offer a few thoughts to show how utterly at variance the spirit of war is with truth and righteousness.

1. It contradicts the genius and intention of Christianity. Christianity requires us to seek to amend the condition of man. But war cannot do this. The world is no better for all the wars of five thousand years. Christianity, if it prevailed, would make the earth a paradise. War, where it prevails, makes it a slaughterhouse, a den of thieves, a brothel, a hell. Christianity cancels the laws of retaliation. War is based upon that very principle. Christianity is the remedy for all human woes. War produces every woe known to man.

We may always trace it to the thirst of revenge, the acquisition of territory, the monopoly of commerce, the quarrels of kings, the intrigues of ministers, or some other source, equally culpable; but never has any war devised by man been founded on holy tempers and Christian principles.

"War is the greatest plague that can afflict humanity. It destroys religion, it destroys states and it destroys families. Any scourge is preferable to it."-Martin Luther

2. War sets at nought the example of Jesus. One of Christ's primary laws is, "Learn of Me, for I am meek" His constant declaration was that He "came not to destroy men's lives, but to save."

He drove men from the temple, but it was with "a scourge of small cords," and a gentle doom it was, compared to their just deserts. He expressly said His servants would not fight, because His kingdom was not of this world. He was the Prince of Peace.

Do we forget that Christ is our example? Imagine the Redeemer laying a country waste, setting fire to cities, storming fortresses, and consigning tens of thousands to wounds and anguish, death and damnation, just to define some point of policy, to decide some kingly quarrel, or to enlarge some boundary. Could "meekness and lowliness" be learned from Him thus engaged? It is most certain that we gather no army lessons from Him who "came to bind up the broken-hearted, to proclaim liberty to the captives, and to comfort all that mourn." It is most certain that no man who makes fighting his profession can find authority in the example of our Lord.

3. War is inconsistent not only with the general structure and nature of Christianity and the example of Jesus, but it violates all the express precepts of the New Testament. Even the Old Testament does not sanction war, as a custom. In each case of lawful war, it was entered on by express command. It should be remembered that in no case, even under the Old Testament, was war appointed to decide doubtful questions or to settle quarrels. Wars were intended to chastise nations guilty of provoking God. Such is never the pretext of modern war.

As to the New Testament, a multitude of precepts might be quoted: "Ye have heard, an eye for an eye, but I say unto you, resist not evil." "Follow peace with all men." "Love one another." "Do justice, love mercy." "Love your enemies." "Follow righteousness, faith, charity, peace." "Return good for evil." "Let all bitterness, and wrath, and anger, and clamor, and evil speaking, be put away from you, with all malice; and be ye kind one toward another, tender-hearted, forgiving one another, even as God, for Christ's sake, hath forgiven you." "Be not overcome of evil, but overcome evil with good."

All know how much these passages abound in the New Testament. There they stand. In any sense the words will bear, they forbid war. If language has any force at all, these words equally forbid retaliation. Yet retaliation is always advanced as the very best pretext for war and is more frequently the avowed reason than any other!

Rehearse all the catalogue of graces, and mark how we are enjoined to be meek, lowly, peaceable, easy to be entreated, gentle, thinking no evil, merciful, slow to anger, given to quietness, knowledge, patience, temperance, prayer. War sets them all at nought.

Of the sermon on the mount, five benedictions are upon the poor in spirit, the mourners, the meek, the merciful, and the peacemakers. Two others are upon the persecuted and reviled. The professed warrior, therefore, shuts himself out from all these benedictions! The discourse expressly revokes the law of retaliation, and, exploding the [practice] of loving our neighbor and hating our enemy, requires us to love our enemies and do good to them which despitefully use us. Afterward, in presenting a form of prayer, it not only teaches us to say, "Forgive us our trespasses, as we forgive those that trespass against us," but adds, "If ye forgive not men their trespasses, neither will your heavenly Father forgive you." What a peace sermon is here!

The regular soldier ... makes war a trade, and is ready to fight any nation, or any part of his own nation, as he is sent. He is to wheel, march, load, fire, advance or flee, just as he is bidden, and because he is bidden. The nearer a soldier comes to a mere machine, the better soldier he makes. Is this right for a Christian? Is it compatible with his duty to "examine all things, and hold fast that which is good?"

What gospel precept is there, which he who makes war a profession is not at times compelled to violate? He must cast away meekness, and fight. He must cast away forgiveness, and revenge his country. He must not return good for evil, but blow for blow, wound for wound.

Look at an army in the hour of battle. See attacks and retreats, battalions annihilated, limbs flying in the air; suffocating smoke, thundering artillery, thousands smarting in the agony of death, and none to administer a cup of water. Do the precepts of Christianity authorize such a scene? Look at the field when all is over. The harvest trampled and destroyed, houses smoking in ruin, the mangled and slain strewed among dead horses and broken gun-carriages! Prowlers stripping booty even from the warm bodies of the dying! Jackals lurking around, and birds of prey wheeling above. Here and there a wretched widow, or an anxious wife, seeking her loved one among the dead and dying. Does all this look as if Christians had there been serving their Master, the God of mercy?

But nowhere does war wear such horrors as in a siege. The inhabitants are straitly shut up. Business, pleasure, education and intercourse are checked; and sorrow, poverty, terror, and distress are spread abroad. The bombardment begins. Shells explode in the streets, or penetrate the roofs. Citizens are killed in the streets, and soldiers on the ramparts. Women and children retreat to cellars and live in all discomfort. Day by day the gloom thickens. All news is of houses burnt, persons killed, and scarcity increased, At length, famine is threatened. Everything is sold to buy a little food.

Anon, breaches are made in the walls. All must work, amid galling fire, to repair them. Mines are sprung, blowing houses and the occupants into the air. No relief comes. Hundreds perish in desperate sorties. All are miserable. The widow, the bereft mother, the disappointed bride, and the tender orphan, mourn continually.

Pestilence succeeds to famine. Thousands, who have escaped violence, die of disease. At length, the city is taken by storm; pillage, and perhaps an awful

conflagration, succeed; a brutal soldiery raven among the virtuous; and the indescribable scene ends in permanent poverty, lamentation, and dishonor. Is this Christianity?
