

[Dr. David Martin: We Are Allowing Human Organisms To Become Bioweapon Factories – Video and Text](#)



Transcription of the interview

Stew Peters: So we're now up to our fourth COVID shot here in the United States. And Anthony Fauci is talking about possibly doing another round of lockdowns too. Hell, I mean, that might happen because half of this country are sheep, and will fall for anything, it seems.

Well, Dr. David Martin recently warned that the ultimate long-term purpose of all of this will be exposing humanity to constant forcible gene editing, via mRNA vaccines and who knows what else. Dr. Martin will be joining me I'm very excited because he also will be speaking at the April let's go Brandon rally, but he joins us now. And I'm excited about that, as well. Thank you for coming. So that's what this is replacing God's likeness, essentially, as we worship the mRNA masters.

Dr. David Martin: You know, it's fascinating. And just the last couple of weeks, I have gone on record for quite some time now, Stew, saying that this entire exercise was about transcribing a computer-synthesized model into the human genome. And in the last month, we've seen mainstream science come back with a giant revelation that it turns out that this shot persists in the human body for an indeterminate period of time. The most recent data shows that at least surviving up to eight weeks in the lymph system, where it continually produces the spike protein. We see evidence coming from municipal waste systems that allegedly even though we're all allegedly getting better, and the pandemic is starting to normalize, apparently spike protein is showing up in our waste streams at alarmingly high rates. Stew, the reason is because as I've said all along, when you inject the body with instructions to make a chimeric model of a synthetic spike protein, where you have never done testing on that gene therapy, it turns out that you don't know what you might be manufacturing, and how long each individual who gets the injection might be manufacturing these pathogens. And not surprisingly, we were told about this years before this injection started. This is a pandemic of the bio weaponization of the human organism. This is not public health. And Anthony Fauci is the architect of this genocide.

Stew Peters: You have read so many different quotes and given so many

examples using the criminals' own words as they have forecasted exactly what was coming and this dates all the way back. I mean, everybody I talked to that has relevant resources can trace this first, it was back to 2015. Then it was 2005. And now even before that, is it possible,...

Dr. David Martin: Yeah, all the way to 1990.

Stew Peters: 1990? I mean, now. Is this, is it possible? Why? What are some other reasons that this could be showing up in our water?

Dr. David Martin: Well, listen, the reason is really simple. We are now obsessing about the fact that every way to Sunday, what is being done is the human organism is now being modified, and it is being modified to perpetually produce a toxic protein known and scheduled to harm humanity. And when I say known and scheduled to harm humanity, why don't we go ahead and make sure I clarify the reference because apparently, people don't understand what it is. Under 7 CFR Part 331, under 9 CFR Part 121, and on 42 CFR Part 73, we have what's called the Federal Select Agent Toxin List. Stew, **this is not my list. This is not Dave's allegation. This is the Code of Federal Regulations where we put very specific toxins on a schedule and say these things are known to harm humans.** They are known to be damaging, and they are subject to the biological and chemical weapons treaties and laws that we have enforced here in the United States. And why don't we read it directly from the schedule because why would I need to make up for the criminals' acts are even more egregious? Any SARS CoV or SARS CoV2 chimeric virus resulting from any deliberate manipulation of SARS CoV2 to incorporate nucleic acids coding for SARS CoV virulence factors. Stew, they actually say that doing the thing they're doing is illegal.

Stew Peters: Hold on, read that again.

Dr. David Martin: Right. Sars CoV and SARS CoV2 chimeric viruses resulting from any deliberate manipulation of SARS CoV2 to incorporate nucleic acids coding for SARS CoV2 virulence factors. That's actually in three sections of the Code of Federal Regulations subject to the biologic and toxin agent program, defined under 18 US Code section 178, as a biological agent subjected to 18 US Code section 175 prohibition of biological weapons. Literally, the statute says what they're doing is a felony punishable by 99 years in prison, and up to \$100 million per count.

Stew Peters: If you didn't think that that was going to happen. And if you didn't think that justice was going to prevail, and if you didn't think that we were going to win, then you wouldn't be fighting as hard as you are, you're fighting because there really was a purpose and you see a way to win, we're going to win, aren't we?

Dr. David Martin: That's exactly right. And, and so it's important when, when, when, still, you know, I'm a broken record on stuff like this. The fact of the matter is, the criminals' own statements are so egregious, that we don't even have to make up a conspiracy because they did it and they published it. So in violation of criminal conspiracy and racketeering laws, they're the ones that actually admitted to it and let's go to the 20 F

filing. For those of you not familiar with a 20 F filing, when a foreign company files with the United States Securities Exchange Commission, one of their filings is called a 20 F filing, and Biotech, the mRNA injection manufacturer for Pfizer makes the following statement in their 20 F filing. So let's just, let's just set up at the gate. This is them speaking. This is not David Martin. This is them speaking, I'm reading straight from their 20 F filing.

To our knowledge. There is no current precedent for an mRNA-based immunotherapy, such as the type we are developing, being approved for sale by the FDA, the European Commission or any other regulatory agency elsewhere in the world. Although we expect to submit BLAs (which is the biologics license for mRNA-based product candidates in the United States and in the European Union) mRNA therapies have been classified as Gene Therapy Medicinal Products. Other jurisdictions may consider our mRNA-based product candidates to be new drugs, but not biologics or gene therapy, or medicinal products and require different marketing applications. Securing regulatory approval requires submission of extensive preclinical and clinical data and supporting information the various regulatory authorities for each therapeutic indication to establish the product's candidate safety and efficacy."

Listen, I read it straight out of their filing. When I say that this is not a public health vaccine, but this is a computer generated synthetic chimeric alternative to the virulence factor of SARS co V, which is exactly, exactly what it is. This is actually not Dave's theory. This is the reality that says we are being subjected to a perpetual addiction to a known pathogen and toxic agent. And the reason why Anthony Fauci is now advocating for the next round of boosters to be followed by the next round of boosters, is until we actually achieve the stated goal, which is a 15% population reduction, which I don't know if you do the math quick in your head, but **that's about 800 million people dead**. Until we get there. We will be recommending this injection to harm, maim, kill, murder, and sterilize humanity.

Stew Peters: To murder people. To murder people to prevent them from procreating. To alter their image of God their God given DNA and to make them worship a new master.

Dr. David Martin: Well, and the fact of the matter is, it's their words, not mine. They're the ones that said it. And by the way, it's important to realize that that wonderful thing about SARS cov 2 chimeric viruses that I read from the Code of Federal Regulations, that little thing called the Federal select agent program, that little thing called the Department of Health and Human Services and USDA agents and toxins program, that thing that I read, mysteriously had SARS co2 fragments listed as scheduled pathogens in April of 2020. Stew, do remember in February of 2020 we allegedly had a novel pathogen that we didn't know anything about? Remember, we just invented the thing. And we started filing patents for injections for the thing before we actually knew anything about it. So those wonderful days back in our prescience years where we could anticipate a pathogens emergence before it actually happened, and then build operation warp speed in September before the first accorded evidence of the disease in

December of that year, all of the wonderful things that we have unfolding around us. Somehow or another in April of 2020, we had the ability to know that there was going to be SARS Cov2 virulence factors added to a schedule of toxins before we even had a Moderna or Pfizer shot, except we had already transferred those things in November of 2019, under a material transfer agreement to make sure that we had an injection for a pathogen before we had an outbreak of said pathogen.

This is just clear evidence of the fact that this entire campaign of terror, which is what we need to be calling it, this is domestic terrorism. And this is international terrorism. This is bioterrorism writ large. And those acts were willfully and Premeditatedly perpetrated on the population. And to date the population has had not one, not Ron DeSantis, nobody in Florida, no attorney general, no governor, not a single person who has been willing to take on the crime. Not one.

Stew Peters: Disgraceful. It's completely disgraceful. **These are not side effects. These are *intended* consequences.** (Dr. Martin: That's correct.) These are not experimental injections, stop calling them that. This is not an experiment. This is a well-thought-out meticulous plan to commit murder. on a large scale. This is intentionally designed. This was chimerically engineered by people who knew exactly what they were putting into these injections delivered with this mRNA technology. They know exactly what they're doing. These are not experimental, the clinical trial data, they didn't need that they didn't need it. Why? Because they knew what that was what was going to happen. They knew what they were going to do. And the reason there's no threshold for death, the reason why it's not alarming to anybody that only one percent has reported to VARS and 25,000 people are dead, **the reason why nobody's talking about it is because they know that and they have not achieved their goal yet!** That's minuscule in comparison to where they want to take us.

Dr. David Martin: That is exactly right. And what we already know is that if we look at the pseudouridine addition to the mRNA that was put into this injection, if we look at all of the data that we know is now part of the code that went into the mRNA shot, we know that **these things were done with the intention of making them a permanent resident in the organic system.** And by the way, when you hear B A 2 variant, which is now the latest campaign of terror, recognize something very clearly. This new variant is not an alteration of a natural mutation of any viral model.

This is what's happening. When we have human beings turning into perpetual spike protein manufacturing facilities, we will have variant upon variant upon variant and these are going to be coming from injected people who are allegedly coming down with COVID. These are not diseases born of a natural virus. These are premeditated acts of engineered pathogenicity, where we are now allowing the human organism to become a bioweapons factory itself.

Stew Peters: Wow. Somebody is going to hear this or you wouldn't be putting this all together. Somebody is going to take this. A court is going to hear this, these people will be indicted, tried, and hopefully fried.

Dr. David Martin: Well, and still, you know, we filed in Utah. We filed the federal case in Utah on March the third. It is the first federal case where we're taking on the root of this definitional question around the difference between a gene therapy and a vaccination. We filed in Utah because we wanted to in addition to the claims that we laid out in that case, we wanted to see the federal government trying to defend itself because it turns out in Utah, their defense is going to be an affirmative admission of felonies in the state of Utah.

Stew Peters: Criminal consequences.

Dr. David Martin: Criminal consequences for their response.

Stew Peters: Good. I can't get over what you just said. I mean the reality of that turning the human body into a bioweapons lab, a bioweapon manufacturing facility.

Dr. David Martin: That's correct.

In 1900 there were 13.3 measles deaths per 100,000 population. By 1955, before the first measles shot, the death rate had declined 97.7 percent to only 0.03 deaths per 100,000.” – Dr. Mendelsohn, MD

“Up to 90% of the total decline in the death rate of children between 1860 and 1965, because of whooping cough, scarlet fever, diphtheria, and measles, occurred before the introduction of immunizations and antibiotics.” – Dr Archie Kalokerinos, MD

“For thirty years kids died from smallpox vaccinations even though no longer threatened by the disease.” – Dr. Robert Mendelsohn, MD

“I am and have been for years a confirmed anti-vaccinationist. Anti-vaccination has no backing from the orthodox medical opinion. A medical man who expresses himself against vaccination loses caste. Tremendous pecuniary interests too have grown around vaccination.” – Mahatma Gandhi

“Using kids as guinea pigs in potentially harmful vaccine experiments is every parents’ worst nightmare. This actually happened in 1989-1991 when Kaiser Permanente of Southern California and the Centers for Disease Control (CDC) jointly conducted a measles vaccine experiment. Without proper parental disclosure, the Yugoslavian-made “high titre” Edmonston-Zagreb measles vaccine was tested on 1,500 poor, primarily black and Latino, inner city children in Los Angeles. 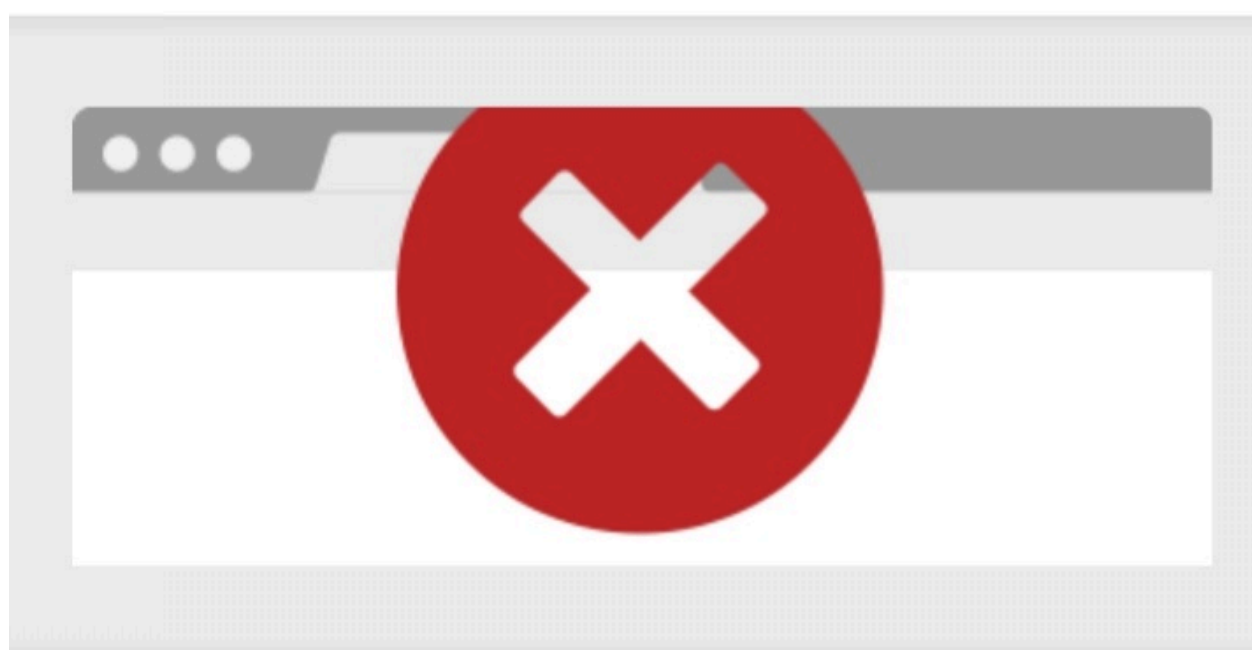

It seems that every time someone such as myself attempts to encourage our Christian brothers and sisters to resist an unconstitutional or otherwise reprehensible government policy, we hear the retort, "What about Romans Chapter 13? We Christians must submit to government. Any government. Read your Bible, and leave me alone." Or words to that effect.

No doubt, some who use this argument are sincere. They are only repeating what they have heard their pastor and other religious leaders say. On the other hand, let's be honest enough to admit that some who use this argument are just plain lazy, apathetic, and indifferent. And Romans 13 is their escape from responsibility. I suspect this is the much larger group, by the way.

Nevertheless, for the benefit of those who are sincere (but obviously misinformed), let's briefly examine Romans Chapter 13. I quote Romans Chapter 13, verses 1 through 7, from the Authorized King James text:

"Let every soul be subject unto the higher powers. For there is no power but of God: the powers that be are ordained of God. Whosoever therefore resisteth the power, resisteth the ordinance of God: and they that resist shall receive to themselves damnation. For rulers are not a terror to good works, but to the evil. Wilt thou then not be afraid of the power? do that which is good, and thou shalt have praise of the same: For he is the minister of God to thee for good. But if thou do that which is evil, be afraid; for he beareth not the sword in vain: for he is the minister of God, a revenger to execute wrath upon him that doeth evil. Wherefore ye must needs be subject, not only for wrath, but also for conscience sake. For this cause pay ye tribute also: for they are God's ministers, attending continually upon this very thing. Render therefore to all their dues: tribute to whom tribute is due; custom to whom custom; fear to whom fear; honor to whom honor."

Do our Christian friends who use these verses to teach that we should not oppose President Bush or any other political leader really believe that civil magistrates have unlimited authority to do anything they want without opposition? I doubt whether they truly believe that.

For example, what if our President decided to resurrect the old monarchical custom of Jus Primae Noctis (Law of First Night)? That was the old medieval custom when the king claimed the right to sleep with a subject's bride on the first night of their marriage. Would our sincere Christian brethren sheepishly say, "Romans Chapter 13 says we must submit to the government"? I think not. And would any of us respect any man who would submit to such a law?

So, there are limits to authority. A father has authority in his home, but does this give him power to abuse his wife and children? Of course not. An employer has authority on the job, but does this give him power to control the private lives of his employees? No. A pastor has overseer authority in the church, but does this give him power to tell employers in his church how to run their businesses? Of course not. All human authority is limited in nature. No man has unlimited authority over the lives of other men. (Lordship

and Sovereignty is the exclusive domain of Jesus Christ.)

By the same token, a civil magistrate has authority in civil matters, but his authority is limited and defined. Observe that Romans Chapter 13 clearly limits the authority of civil government by strictly defining its purpose: "For rulers are not a terror to good works, but to the evil . . . For he is the minister of God to thee for good . . . for he is the minister of God, a revenger to execute wrath upon him that doeth evil."

Notice that civil government must not be a "terror to good works." It has no power or authority to terrorize good works or good people. God never gave it that authority. And any government that oversteps that divine boundary has no divine authority or protection.

Civil government is a "minister of God to thee for good." It is not a minister of God for evil. Civil magistrates have a divine duty to "execute wrath upon him that doeth evil." They have no authority to execute wrath upon him that doeth good. None. Zilch. Zero. And anyone who says they do is lying. So, even in the midst of telling Christians to submit to civil authority, Romans Chapter 13 limits the power and reach of civil authority.

Did Moses violate God's principle of submission to authority when he killed the Egyptian taskmaster in defense of his fellow Hebrew? Did Elijah violate God's principle of submission to authority when he openly challenged Ahab and Jezebel? Did David violate God's principle of submission to authority when he refused to surrender to Saul's troops? Did Daniel violate God's principle of submission to authority when he disobeyed the king's law to not pray audibly to God? Did the three Hebrew children violate God's principle of submission to authority when they refused to bow to the image of the state? Did John the Baptist violate God's principle of submission to authority when he publicly scolded King Herod for his infidelity? Did Simon Peter and the other Apostles violate God's principle of submission to authority when they refused to stop preaching on the streets of Jerusalem? Did Paul violate God's principle of submission to authority when he refused to obey those authorities who demanded that he abandon his missionary work? In fact, Paul spent almost as much time in jail as he did out of jail.

Remember that every apostle of Christ (except John) was killed by hostile civil authorities opposed to their endeavors. Christians throughout church history were imprisoned, tortured, or killed by civil authorities of all stripes for refusing to submit to their various laws and prohibitions. Did all of these Christian martyrs violate God's principle of submission to authority?

So, even the great prophets, apostles, and writers of the Bible (including the writer of Romans Chapter 13) understood that human authority—even civil authority—is limited.

Plus, Paul makes it clear that our submission to civil authority must be predicated on more than fear of governmental retaliation. Notice, he said, "Wherefore ye must needs be subject, not only for wrath, but also for conscience sake." Meaning, our obedience to civil authority is more than just

“because they said so.” It is also a matter of conscience. This means we must think and reason for ourselves regarding the justness and rightness of our government’s laws. Obedience is not automatic or robotic. It is a result of both rational deliberation and moral approbation.

Therefore, there are times when civil authority may need to be resisted. Either governmental abuse of power or the violation of conscience (or both) could precipitate civil disobedience. Of course, how and when we decide to resist civil authority is an entirely separate issue. And I will reserve that discussion for another time.

Beyond that, we in the United States of America do not live under a monarchy. We have no king. There is no single governing official in this country. America’s “supreme Law” does not rest with any man or any group of men. America’s “supreme Law” does not rest with the President, the Congress, or even the Supreme Court. In America, the U.S. Constitution is the “supreme Law of the Land.” Under our laws, every governing official publicly promises to submit to the Constitution of the United States. Do readers understand the significance of this distinction? I hope so.

This means that in America the “higher powers” are not the men who occupy elected office, they are the tenets and principles set forth in the U.S. Constitution. Under our laws and form of government, it is the duty of every citizen, including our elected officials, to obey the U.S. Constitution. Therefore, this is how Romans Chapter 13 reads to Americans:

“Let every soul be subject unto the [U.S. Constitution.] For there is no [Constitution] but of God: the [Constitution] that be [is] ordained of God. Whosoever therefore resisteth the [Constitution], resisteth the ordinance of God: and they that resist shall receive to themselves damnation. For [the Constitution is] not a terror to good works, but to the evil. Wilt thou then not be afraid of the [Constitution]? do that which is good, and thou shalt have praise of the same: For [the Constitution] is the minister of God to thee for good. But if thou do that which is evil, be afraid; for [the Constitution] beareth not the sword in vain: for [the Constitution] is the minister of God, a revenger to execute wrath upon him that doeth evil. Wherefore ye must needs be subject, not only for wrath, but also for conscience sake. For this cause pay ye tribute also: for [the Constitution is] God’s minister, attending continually upon this very thing. Render therefore to all their dues: tribute to whom tribute is due; custom to whom custom; fear to whom fear; honor to whom honor.”

Dear Christian friend, the above is exactly the proper understanding of our responsibility to civil authority in these United States, as per the teaching of Romans Chapter 13.

Furthermore, Christians, above all people, should desire that their elected representatives submit to the Constitution, because it is constitutional government that has done more to protect Christian liberty than any governing document ever devised by man. As I have noted before in this column (See: http://www.chuckbaldwinlive.com/c2005/cbarchive_20050630.html), Biblical principles form the foundation of all three of America’s founding documents:

The Declaration of Independence, The U.S. Constitution, and The Bill of Rights.

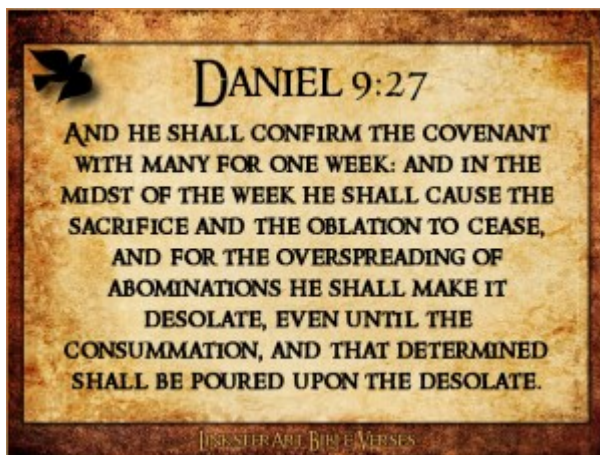
As a result, Christians in America (for the most part) have not had to face the painful decision to “obey God rather than men” and defy their civil authorities.

It's been a series of epiphanies that have made me realize that there's no upside to just being circumspect and trying to be a nice guy in this environment. This is full-on media warfare, information warfare, political warfare, 21st century, like we've never seen before, and coordinated globally.

The other thing for me has been the personal journey of coming to terms with what the World Economic Forum really represents. And I really resisted that people initially, were coming to me talking about the Great Reset, and I was like, "Ah, this crazy talk." But then it's all documented! And then you see it being deployed. Here it is. They're proud of it. They don't hide it. This is the vision. It is a full on globalist totalitarian vision, with the money in control.

And I did a lot of political science when I was an undergraduate in the early 80s. And I had read things like books about transnationalism and the New World Order. I've found that fascinating, but confused, how could this possibly happen? And now to see it playing out in real-time, and in a way in which national sovereignty governments are increasingly irrelevant. You know, that's the thing that folks got to wake up about.

This is not about the vaccine. The vaccine is a symptom. That's a really hopeful message going into the new year, is that there's a growing cohort of people that are increasingly aware of how thoroughly we've been manipulated.

I thought I was red-pilled. You know, I've been on the inside for so long and seen Tony Fauci's machinations for so long. That's my origin story, was the initial AIDS crisis starting in 83. When I was at Davis (a university in Davis California). So I saw the hardball politics. It's not that I haven't been aware of that. But I had not been aware before of the information control that is globally coordinated. I mean the [Trusted News Initiative](#) is profound. What that means that has become the Ministry of Truth (Reference to George Orwell's classic novel (Nineteen Eighty-Four)). And what Twitter's doing right now, that I think, with [Alex Berenson's bold and brave lawsuit](#), taking on Twitter, and then I've had a bunch of lawyers come to me because of getting de-platformed or canceled I think is really the right term.

Certainly, people can't deny it anymore. There's so much evidence. And the CNN ratings keep slipping, yay! Maybe we're gonna see some change in 2022. There is a kind of a growing movement and awareness that part of the problem here is the structure of how we have been building our organizations in doing business in a deep, profound way. And just dissatisfaction with what one sees at the World Health Organization and the CDC, and the whole HHS structure in the United States where you have carefully controlled information, only one leader is allowed to speak, only one leader is allowed to represent the position, I think that is gonna turn out to be one of the changes here is a growing awareness that that model is dysfunctional, broken, and it needs to be fixed.

For me, it has been an awakening journey, there's no question. I didn't seek this and never expected it. I find myself at the center of this storm of the resistance. That's what it is really. And I'm still amazed. But it has profoundly changed my view of the information that we receive.

You talk about me becoming more outspoken. I've seen that with my peers too. So for instance, (Dr.) Peter McCullough, he's kind of chilled out a little bit. But when you're attacked all the time. And you have all of this weaponized information against you and no respect... I mean, I'm Mr. Malone, you know, who claims to have invented... I mean, all this language, classic yellow journalism language to have it all deployed against me in absolutely no respect for what I actually did. They never cite all the patents. I mean, they just gloss over all that.

This is asymmetric warfare. We're basically in a guerrilla warfare situation and we got to play it smart. Because what I'm seeing is the other side is generally not very smart. They have a big hammer. They've got all kinds of resources, but they don't seem to be very bright.

I don't know what's going to happen in 2022. But there are some encouraging signs. You know, I try really hard to look for the silver lining and things and if this whole trauma that we've been through nationally and globally, leads to an awareness of how interconnected we are, and the need for healing and the need for community and the importance of integrity, and the

importance of human dignity. That's kind of the perhaps naive pollyannish hopeful position in response to the Great Reset, is people use the term the Great Awakening.

Our government is out of control. And they are lawless. They completely disregard bioethics. They completely disregard the federal common rule. They have broken all the rules that I know of, that I've been trained on for years and years and years. These mandates are explicitly inconsistent with the Nuremberg Code. They're explicitly inconsistent with [the Belmont Report](#). They are flat-out illegal and they don't care. It's hard for me to reconcile the behavior of the government and its public health decisions with the data. Is it incompetence? Or is there some ulterior

political motive? Or are they just dumb, stupid?

We're in an environment in which truth and consequences are fungible. This is modern media management and warfare. The truth is what those that are managing the trusted news initiative, say it is. In my case, I'm the president of the International Alliance of physicians and scientists. We're over 16,000 people from all over the world, physicians, and scientists. And you can find our website at globalCOVIDsummit.org. We are gobsmacked about what's going on. And we are shut down, censored, demeaned – fill in the blank – all over the world. And they're taking our licenses because we are speaking about these matters.

And you can label me however you want to label me. I don't care. I've done what I've done in my career. I'm at a stage at 62 years old. I've got a farm. It's almost paid off. I raise horses. I love my wife. You know, I've been married a long time. My kids are both married. I got grandkids, man. Oh, I don't need this. There's this claim. I'm doing all this because I seek attention. Trust me. This is not a fun thing to be doing at this stage.

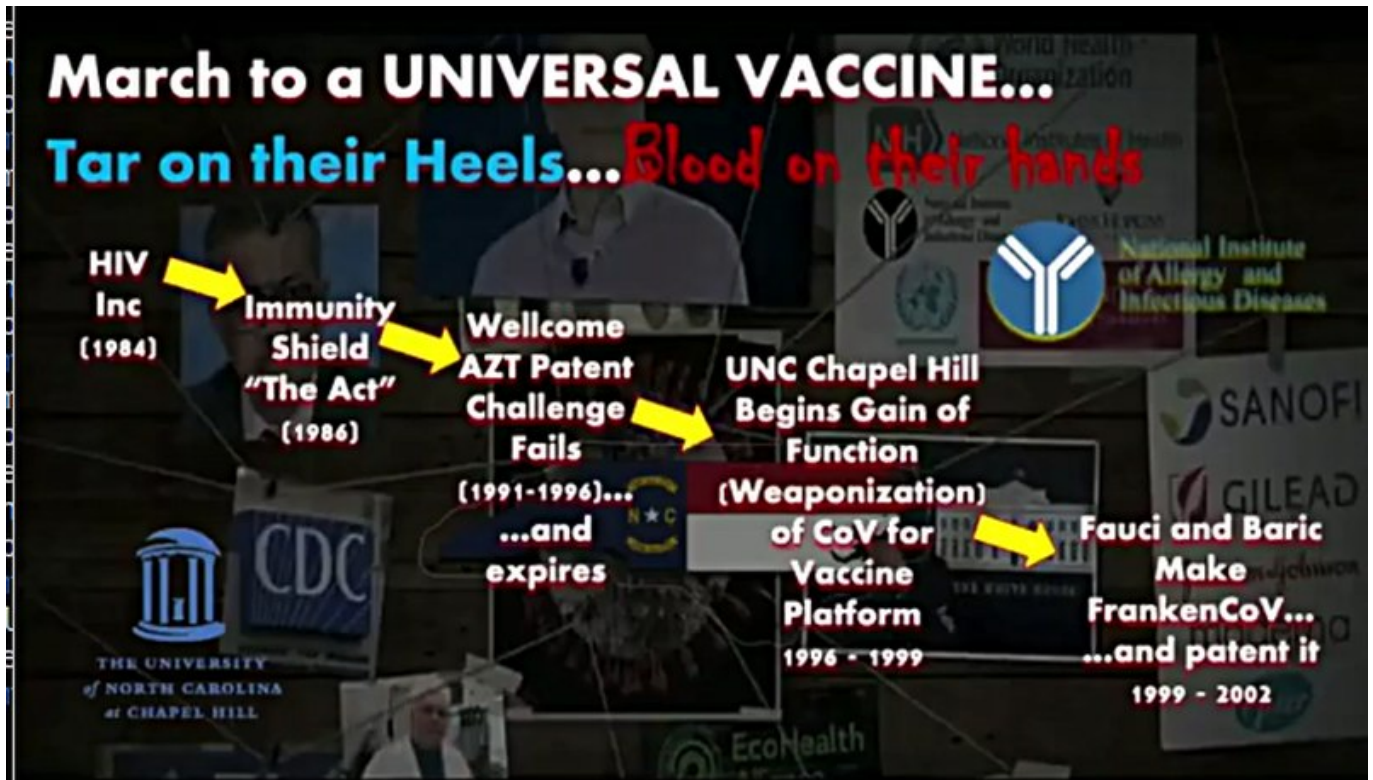
COVID-19 and SARS COv2 was a coup d'etat. And let me be precise about what I mean by that. Sediton in the United States is actually defined very simply, by when any act is done by a conspiring party or group of parties, that its intent is to disrupt or interrupt or overtake the government of a state or a country. And under 18 US Code, the act of sedition was in fact, a coup d'etat to ensure that there would not be a democracy in 2018. Okay, and I'm going to present across the next few minutes the evidence of that. And I'm going to end my presentation with a challenge to you. Because during my presentation, the 30 minutes that I have, is going to cost two children their life because of the inaction of every attorney general in America, because of the inaction of every US attorney, and because of the inaction of every governor in this country. But my grandfather said, Never attribute to malevolence what is ignorance. So in the next 30 minutes, I'm giving every elected official the opportunity to do the right thing. And after 30 minutes, I'm not going to give them that opportunity again. (Applause) So you got Mr. Nice Guy for 30 minutes.

Next. Now, most of you don't know the details of all of the elements. And the good news is I'm going to flip through these slides very quickly because the end of the story is the important part of the story. But for those of you who don't know, COVID is a direct result of HIV Inc. HIV Inc. was founded in

1984. Anthony Fauci was the chief architect of HIV Inc. And his goal was to use sexuality, and specifically homosexuality, as a way to indoctrinate humanity into the acceptance of a universal vaccine mandate. Now, interestingly enough, most of us didn't take the bait. And the reason we didn't is because we didn't live the lifestyles that were associated with HIV in 1984. But cunningly, by 1986, Anthony Fauci and his team at NIAID (National Institute of Allergy and Infectious Diseases) and his minions at the CDC had convinced each and every one of us that maybe we've been in a car accident, maybe we would get a transfusion, and maybe we would get AIDS, which was the justification for a universal HIV vaccine in 1984. It's gonna get nasty because I'm going to show you some real images from 1984 just to let you see that what I'm saying is not my imagination.

But in 1984, something happened. People realized that to accept a universal vaccine, we needed to create a liability shield for the manufacturers of those vaccines. And from 1984 to 1986. We actually built **the first-ever product immunity in the United States, which allowed manufacturers to kill people with intent**. And you heard what I just said, kill people with intent. Anthony Fauci was quoted himself as saying that the ultimate killer of pharmaceutical interventions with vaccines was the smallpox vaccine, which killed one in every 100,000 and injured or maimed one in every 10,000. Did you hear what I just said? Killed one in 100,000, maimed one in 10,000. And that was something that he thought he could turn into a universal vaccine for HIV in 1986. I don't know what an acceptable death rate is for you people. But an acceptable death rate for any product, anywhere in the history of humanity in my definition, is zero! (Applause)

But then, a little dirty secret came along. Somebody at the NIH (National Institutes of Health) said, "Hey, Tony, Cool your jets baby. We have this drug called AZT. And we don't want a vaccine too quickly. We want to kill people with AIDS with AZT. So let's run the clock on it in the state of North Carolina...". By the way, if you're from North Carolina, or you've done anything in North Carolina, you got tar on your heels and blood on your hands. Because the state of North Carolina since 1986 has been brought to you by HIV Inc.



That's a bummer. I think I just lost the elected officials in North Carolina. Shoot. I couldn't even make it through a presentation.

UNC-Chapel Hill began the weaponization of Coronavirus in 1986. But by 1996 Anthony Fauci had a little plan. Coronavirus, as a model, has a very interesting set of attractive attributes, which include this very interesting thing called a spike protein and a couple of other binding sites where the virus allegedly binds to the outside of the cell. And it turns out that Ralph Baric (a professor) at the University of North Carolina Chapel Hill, was the very first person to figure out how to take a pathogen, which used to be an infection of the gut, gastroenteritis. For over 30 years Coronavirus was gastroenteritis. But Ralph Baric figured out how to weaponize it and not weaponize the virus, weaponize the spike protein. And he was the one that figured out how to make a **thing that used to hit your gut, hit your heart**. That was gain of function ladies and gentlemen, the thing that we never did, allegedly. He did it! And in 1996, he received a grant and then a series of grants in 1999, by Anthony Fauci to actually weaponize the Coronavirus spike protein so it could be used as a vaccine vector with the idea that it would be the next HIV vaccine.

That's when I started watching this. I've been a locust-eating prophet in the wilderness. (Laughter) Because my first briefing on this was in 1999. My first intelligence briefing on this was in 2003, in a published document that I have sitting on my desk to remind me that sometimes being right isn't as good as being effective. Turns out I was right in 2003. And unfortunately, I wasn't effective.

But Fauci ran into another problem. And in 1999 to 2002, and patented by the University of North Carolina Chapel Hill, and conveniently in the fall of 2018, do you all remember the big Coronavirus outbreak of 2018? No, that's because there wasn't one. But in an unprecedented move, the University of

North Carolina Chapel Hill was forced to sign their SARS vaccine patent from UNC-Chapel Hill back to NIH. By the way that hasn't been done. But they did it in the fall of 2018. Does it feel like they were preparing for something?

Next slide. Do not read this slide. Because I used to hate professors who put reading charts and eye exams on slides. Don't read it with any luck, Clay Clark can figure out how to make all of this presentation available to you. And I hope he does because that's what it's for. But in 1984, we created the vaccine nightmare, and **we let Anthony Fauci have \$191 billion**. And you heard the number, right, *billion*. We've been told about \$3.7 million going to China, and we're supposed to be upset about that. How about \$191 billion of your taxpayer money that has gone to weaponize nature against humans? 191 billion, and let's do the little walk-through, shall we? 1984 we invent the **vaccines for HIV, which led to death and permanent disability to over 50% of the participants**. But that was okay because they were gay. That was okay. It gets worse. Okay. 2001 you remember the anthrax scare the domestic terrorism scare? Did anybody know that the US military in the spring of 2001 ordered 300 million doses of Ciprofloxacin? 300 million doses. Now we have a pretty compelling army in this country. But with all due respect, 300 million sounds like every citizen in America, it doesn't sound like every member of the US military. And how is it that at least five months before anthrax was released, we ordered 300 million doses of the treatment called Ciprofloxacin? And from – oh that's right – a German company called Bear.

That's by the way when I started busting these stories because it turns out that this wasn't the only pathogen that was being developed by the Department of Defense. And it was interesting because in the early 2000s, I started seeing Coronavirus show up in a bunch of DARPA contracts and a bunch of DOD contracts and I'm sitting there going, why would we be doing that? Why would we be taking a thing which was for dogs and porcine – that's pigs by the way, that's a scientific term for pigs. Think bacon and you got it. Pigs and various other vertebrates? Why would we suddenly be trying to weaponize that and make it hit human lung epithelial cells and human cardiac cells? Why would we be doing that? And why would the Defense Department be doing that? Is that where you expect to go to kind of get your kind of basic treatment programs? NO!! And you don't go there? Because it sounds like a weapon system if it's being funded by billions of dollars of Defense Department black contracts, doesn't it? Or is that Dave the conspiracy theorist?

Well, let's jump into my favorite 2016 protocol, the [AMP \(Antibody Mediated Prevention\) protocol](#). The AMP protocol has a line that I absolutely love. This was when we decided to let the University of North Carolina Chapel Hill develop the HIV vaccine. And it turns out that read what they said about this protocol, it will take place in sites, 24 sites in Brazil, Peru, and the United States and will enroll 2700 men and transgender people who have sex with men. What?! That's by the way straight out of the protocol.

If you don't believe what I say about the fact that Fauci has no concern for human life, but is more than happy to kill people who most people think shouldn't live anyhow, guess what happens? We start introducing the camel's nose under the tent and we start saying it's okay to kill people in the advancement of science. Now listen, people listen carefully. I am not

advocating for any lifestyle. But what I am saying is that when you've decided that you're playing God and that there is a person by any designation, that doesn't deserve to live, you left humanity! (Applause) Period! If any of you see my wife, you know, I'm very heterosexual and very happy. (Laughter) But that doesn't justify making a determination that somebody who doesn't share my values is worth killing in the name of HIV Inc. (Applause) Let's be clear on that. And then 2016 2019. And by the way, look at 2019, the hepatitis C vaccine, which guess what has to do with yet another sexual context story that they tried to turn into, they were killing people that are promiscuous, and usually gay and promiscuous, so we don't care about that. I'd love for some of the bleeding hearts left to actually realize that they're the ones celebrating the execution of the people who they allegedly represent. I think that would be a very interesting proposition. Because maybe somewhere along the line, we should actually go back to 1984. And look at the ghost of Anthony Fauci in this slide, by the way, if you see this slide that's on the screen, what you'll see is 1984 Anthony Fauci, no kidding. That's what he looked like in 1984. He still looked like that center from the high school basketball team.

What?! I'm going to tell you if I had to bet on a basketball team, and I knew that Anthony Fauci was the captain of that team in high school, I bet against him. And guess what, I'd bet against him now, too, because the dirty little secret is he actually made the statement, "it is quite possible. In fact, it's invariable that we will develop a vaccine for AIDS." Now, you know, sometimes there are things called Freudian slips, people say things and they didn't mean to say it. So I want to give him credit. He probably misspoke. He probably meant to say it's inevitable that we'll do it. But he didn't say that. He said, it's *invariable* that we do it. And it turns out that if you look at the definition of the word invariable, you know what it means? "I'm never going to stop doing a thing". Ah oh! You think we're talking about a COVID vaccine right now. No. We're still talking about Anthony Fauci's fantasy of an AIDS vaccine. Don't make a mistake by being fooled.

Next slide. Here's the problem. 1984. He had an epic fail. He tried to make an AIDS vaccine, it didn't work. In 2005 he tried to do H1N1, an epic fail, people died, it didn't work, people didn't roll up their sleeves, epic fail. And then a bumper of an opportunity came along. In 2018 we actually did have an influenza pandemic. We had a lot of people that died. And guess what we didn't do. We didn't shut down countries. We didn't shut down borders. We didn't shut down schools or churches or anything else. We just let people die. And it was seen inside of NIAID as a lost opportunity. Dead people was a lost opportunity. So what he did was he figured out something and he gave the University of North Carolina Chapel Hill a grant to create a pathogen. So that we could actually get, and I'm quoting, "the public to accept the need for a pan coronavirus vaccine. We need the media to create the hype to get to the real issues. We need to use that hype to our advantage. Investors will follow if they see profit at the end of the process."

That's a quote, National Academy of Sciences, Peter Daszak 2015, published in February 2016, Proceedings of the National Academy of Sciences. This was not a public health problem. This was a biowarfare act of domestic terrorism meted out on the citizens of the United States and the people of the world. And it was not a lab leak from China. It was not a lab leak from anywhere. It was an intentional weaponization of the spike protein, and it is murder and we will call it what it is. (Applause) It was murder then, and it's premeditated murder. The guy on the left is Alex Azar. Now, what you don't know about the guy on the left is the guy in the portrait further to the left is even a bigger problem, Henry Waxman. Henry Waxman the patron saint of caring about health, who was the one that made sure every pharmaceutical company got a shield of liability so they could never be held accountable. That Henry Waxman had a very interesting guy appointed by Trump in 2017, Alex Azar, Director of the Department of Health and Human Services. What Trump didn't know, what you didn't know, what most of America didn't know was Alex Azar was an executive, not a physician, an executive at Eli Lilly. And at the time of his appointment, he happened to be under investigation for price-fixing diabetes drugs in Mexico. Hmm hmm. In fact, during his now found to be collusion and racketeering and price fixing an antitrust violation, which turned out to be, held to be, exactly what I just said. While he was actually trying to deflect attention from the racketeering that he was doing by price-fixing insulin in Mexico, he actually made President Trump sign an order. That was the execution order for Americans. And President Trump was advised by appointed individuals who never told him the facts. This ladies and gentlemen was treason. This was treason. And anybody who wants to point the

finger at Donald Trump, the best you can do is say he was subjected to corruption and maliciousness and treason and traders within his circle. That's true. But when he signed this, he did not know the cost. He did not know. And the persons who did know was the lobby, the pharma lobby, the single largest donor in US history to political campaigns. They were the puppets that actually put that paper in front of Donald Trump. And **Alex Azar was the executive responsible for the death and destruction of America.** And you have not even heard his name. Because criminals like to put other people upfront. Well, they hide in the shadows. Well, guess what, we're not going to let happen today. A lobbyist turned executive, turned architect of oh my gosh, under the Bush administration, Alex Azar was the one who also came up with the prep Act, which actually shielded companies from liability in the event of a national emergency. **Alex Azar is the perpetrator of the largest genocide this country has ever seen.** And you do not know his name. But that just changed today. (Applause)

Oops, that was my out-loud voice. And it turns out, he's the boss of Anthony Fauci. He's the boss of CDC. He's the boss of NIAID. He's the boss of NIH (National Institutes of Health). He's the boss of the FDA. And guess what? He's the first guy that the FBI should cuff, lock up, and put in prison for the rest of his life! (Applause) That's our target. And don't think I'm actually advocating justice for the sake of justice. I'm advocating justice, because the minute we actually have the first felony conviction, the first time the emergency use authorization vanishes, because it turns out the emergency use authorization cannot stand if the basis of it was a felony. And that's written into the law. We have one focus. We have one silver bullet. And I am waiting for one AG (Attorney General) in this country to stand up and be accountable for the lives that are being lost because well, I'm talking, two children died because they're being murdered by a collusion racket. Which is like having Al Capone drive through the streets of Chicago and shoot into a school. You wouldn't sit for that but you have sat for this. Well, guess what? Not after this. From now on every hour that you do not follow the instructions I have at the end of this speech, for every hour that you don't take action, another two children die. And I want you to go to bed tonight asking yourself, did you pay attention? Or Are you cool with two kids dying every hour? I want you to sleep on that. I want you to sleep with that. Because on my watch, that ain't gonna happen.

Now I may be David and I may have a couple of river stones, which I'm going to share with you. And we got a Goliath that we got to work with. That's okay. But let's do the next slide because I got a punch line. And I'm going to get on schedule, in fact ahead of schedule. I'm going to end early to respect the next speakers. So here we go. That slide. Here's the deal, guys, you're going to share this slide, so I don't have to talk about it right? We're going to figure out a way to share the slide. Awesome. So you don't, I don't have to talk about it. Because I do have to talk about this.

There are two websites right now by any grace of God in the next five minutes or 10 minutes or hour, there's gonna be 100 websites like this, because what I conveniently did for every attorney general for every US Attorney for every law enforcement agent in this country, what I did was I went ahead and

drafted the indictment notice. (Applause) The United States of America v. And let's read it out because that's all the time I have.

We are going to do the following, you're going to go to that website, DavidMartin.world or fullyliveacademy.com, there's a button that says AG document, you are going to print that document and you're going to deliver it to every attorney general in every state, you're going to deliver it to every US attorney, you are going to put them on notice that from this day forward, and literally from this minute forward, every death is on their hands, because they can do something about it. And they have chosen now four times in four meetings, they have chosen to say, "Dave, this is a political, not a legal issue." And that's a quote from AGs offices. **Make it a legal issue.** And if they haven't made it a legal issue, if you haven't heard that an AG met with me, make it a political issue next year. Because this is our country, these are our children, and we will not let them die on our watch. (Applause)

Ladies and gentlemen, we the people can do something. You now are entrusted with much. And to quote that beautiful narrative in the Gospels. They’re the ones who find kids that died of COVID right before the FDA needs to vote on giving kids injections. They’re

the ones that go around the world, making sure every message is always the same: 'We will not return to normal until we have a vaccine.' Thank you, Justin Trudeau! Where'd you get the script? From Fors-Marsh! And how many of you knew that? None of ya!

"How about Palantir? Hey, that's a weird one, isn't it? Peter Thiel, who has successfully run a company that has lost \$200 million plus, every year for about seven or eight years, goes public in the middle of COVID. Isn't timing interesting? Isn't it fascinating that a company that's done nothing but lose billions of dollars goes public in the middle of the worst economic cycle we've had? Isn't that funny? THE COVID PIRATES

“Now, why do I call them ‘privateers’? How many are familiar with the difference between a pirate and a privateer? Pirates go rape and marauding and stealing and...a privateer is the same thing, that has permission to do it by a government that’s gone corrupt. That’s what these are (points to the slide of COVID contractors). They’re the privateers. But hey, since we have privateers, it feels only appropriate that if we have a world of privateers, we should also...have a world of pirates. And here’s our pirates.”

The new slide shows the universities who’ve been involved in the COVID War: UNC Chapel Hill, Vanderbilt, Emory, Johns Hopkins, University of California System, MIT, NYU Langone, DZIF, Imperial College, IHME, Erasmus Medical Center.

“Pirates. UNC Chapel Hill, I talked about that. That’s the guy who actually made the weapon, Ralph Baric. Since 1999, \$100 million to weaponize the particles of coronavirus. Over \$100 million. You’ve heard about \$3.7 million going to Wuhan – ohhhh – 3.7 million, that feels like a bad number.

From Left to right and top to bottom:

Bill Moyers, (born June 5, 1934) is an American journalist and political commentator of ultra liberally biased PBS News. He served as the ninth White House Press Secretary under the Johnson administration from 1965 to 1967. He was a director of [the Council on Foreign Relations](#), from 1967-1974.

Judy Woodruff (born November 20, 1946) is an American broadcast journalist who has worked in network, cable, and public television news since 1976. She is the anchor and managing editor of PBS NewsHour which is ultra liberally biased. Woodruff has covered every presidential election and convention since 1976. She has interviewed several heads of state and moderated U.S. presidential debates.

[Dr. Lawrence Palevsky Discloses the Dangers and Unknown Risks of Vaccines](#)



Introduction

I think this talk about vaccines by Dr. Palevsky is nothing short of outstanding! He is talking about regular vaccines given to children, which, in my opinion, are harmful but not even nearly as harmful as the Covid-19 vaccines! My first son, Jeremy, was vaccinated at only 5 months old, and he was not a normal child. It was only after Jeremy became older that I found information from the Internet that led me to think Jeremy has a type of autism known as Asperger syndrome. And I firmly believe it was due to the vaccination he received when he was a baby. His brother Timothy was never vaccinated and is normal. Timothy has lots of friends. Jeremy has few friends and is not a social person like Timothy is.

It's my hope that after you listen to or read this talk by Dr. Palevsky that you will question everything you hear from the mainstream media that is called "science". It may not be true science at all, only opinions, assumptions, conjectures, or speculations that are pushed by big corporations whose interest is only in profit for their shareholders, and not in your well-being! If you're a Bible believer, you *know* when you hear scientists talk about Darwin's evolution, they are not talking about real science which is based on observation and measurement. They absolutely refuse to consider God the Creator in the equation in spite of all the evidence that abounds in nature that manifests intelligent design. There is no design without a

designer! True science is a quest for knowledge. An honest scientist will follow the evidence wherever it leads.

Transcription

My name is Dr. Lawrence Palevsky. I'm a pediatrician, originally trained at NYU School of Medicine, graduated in 1987, finished my residency at Mount Sinai Hospital in New York in 1990, did a fellowship at the Bellevue Hospital in the outpatient department. The first nine years of my career were spent in ERs, running an intensive care unit, working in a neonatal intensive care unit, working inpatient in the hospital, working in a clinic and then eventually having a private practice.

In 1983, when I started medical school, I was taught vaccines were safe, and they were effective, but I was not taught about any of the science around their safety, or any of the studies around how safety were done. And it wasn't until 1998 that a mother came up to me and said, "Dr. Larry, did you know that there's mercury in vaccines?" And I said, "No, I did not." And as a medical student, I was trained to critically think. If you see an observation, you go after it, and try and figure out if there's a question to ask. So instead of just ignoring it, I looked further into the vaccine ingredients. And I found that there were a number of vaccine ingredients that in animal studies were proven to be very dangerous to animals. And I didn't understand why these same ingredients were actually in vaccines.

I'm starting to hear stories from parents, not dozens, not hundreds, but 1000s of stories from parents, who took a very healthy child into their doctor's office, and then found that their child lost much of their health, whether it was their speech, whether seizures, whether it was death, whether it was asthma, allergies, eczema, whether it was autism, whether it was learning disabilities, whether it was inflammatory bowel disease, autoimmune diseases. And every one of those parents were told, it had nothing to do with the vaccine, every single one. And this continues today. But yet, when I look at the ingredients that are in the vaccines, I have the science to actually explain how these medical problems could be happening in these children.

Today, one child in five is learning disabled. In 1976 it was one in 17. One in six under age eight, one in two adolescents, and one in four young adults are diagnosed with a mental behavioral, or emotional disorder. One in 20 children under the age of five have seizures. One child in 40 develops autism. The number of cases of children and adults with autoimmune diseases is rising exponentially. It's one of the highest-rising diseases in this country. And the vaccine ingredients, if you are willing to look at them, and understand how they work when they're injected into the body, can be seen to be responsible for every single one of these cases.

So what are these ingredients? Well, when I was in medical school, we were taught that the body has something called the *blood-brain barrier*. The blood-brain barrier is like Fort Knox to the brain. Elements of the bloodstream cannot get into the brain. And those elements include drugs, viruses, and bacteria, among other things that are in the blood. Drug companies were very

concerned about being able to develop drugs to get the drugs into the brain. And so they used something called a nanoparticle, nanoparticle, very small particle, bound to the drug. And they found that **if they could put a nanoparticle onto a drug, they could get that drug to go into the brain.** And it shows in animal studies, that they were able to do this.

They then were able to take an emulsifier which is something that's good with water and fat, it can dissolve in both. And if they added the emulsifier to the nanoparticle bound to the drug, **they could increase drug entry into the brain 20 fold.** This is right out of animal studies that I found. So you have a drug, you have a nanoparticle, and you have this emulsifier. The vaccines are constructed the same way. You have the vaccine viruses and bacteria that are bound to a nanoparticle called aluminum, and that aluminum is a nanoparticle. And by definition, a nanoparticle has the potential to enter the brain.

Most vaccines also contain polysorbate 80, or sorbitol. Both of those compounds are emulsifiers. Emulsifiers bind very tightly to the nanoparticle aluminum, which is bound very tightly to the vaccine antigens. This raises a question: If the vaccine model is the same model as the model that the drug companies are using to enhance the delivery of drugs into the brain, is it possible that vaccine ingredients are making their way into the brain of our children? That could explain why so many parents are watching their kids deteriorate after vaccinations, even though the doctors, the media, and the government say absolutely no connection, even though the science suggests that there is. You cannot find a single study in the literature that addresses whether the injection of aluminum into the body penetrates the brain, whether any vaccine ingredients enter the brain, and whether polysorbate 80 enhances the delivery of any of those ingredients into the brain. And when I could not find those studies, I was concerned, because I'm told you're told vaccines are evaluated, and very, very distinctly tested for safety. But yet, you cannot find a study that says, "Does aluminum get into the brain of children? Does aluminum take other vaccine ingredients into the brain that don't belong in the brain?" Because when ingredients get across the blood-brain barrier that don't belong in the brain, they cause inflammation. And inflammation is what we see in one in five children with learning disabilities, and one in 40 children with autism. And all you have to do is ask the guidance counselors. And if you get honest pediatricians who are telling you what they're seeing in their practice, they're seeing kids one after another with more and more brain disorders.

Now, as a medical doctor, who was taught to think and then went into the literature, and said, Are proper science studies done? – safety studies – where you take a vaccine and you inject it into 100 kids, and then you give 100 kids a saline placebo, meaning it's inert. No study exists to actually evaluate the safety of a vaccine compared to a placebo group. None.

When vaccines are studied, the maximum amount of days that vaccines are studied are up to 10 days to two weeks. And unfortunately, the vaccine manufacturers preselect what side effects they will allow to be associated with the vaccines. So if a child has a vaccine reaction that is associated with the vaccine, the vaccine manufacturers will decide whether or not it

should or should not be associated with a vaccine. And the public knows this, and they're learning it more and more. So if your child develops seizures five months after a vaccine, your child is told by the doctor it had nothing to do with the vaccine. But that's not true. Because there are no studies to prove it. There's opinion, but there's never been a study, really addressing whether a vaccination at two months, or even nine hours of age, could be related to an event that happened months or even years later. And yet we have some of the sickest children in our country.

In New York, we lost the religious exemption on June 13, because the unvaccinated children with a religious exemption were blamed for a measles outbreak. When I met with representatives in New York, I told them that there is no study to prove that unvaccinated children have ever been proven to start an epidemic. And he was surprised and he said, "I will vote against removing the religious exemption if I can't find a study, like you said." He could not find a study, but he voted to repeal the exemption anyway. Because there are no studies. There are no studies proving that unvaccinated children are responsible. There's consensus, and here's why there's consensus:

We are taught that vaccines stop the children from carrying the germs that we are vaccinating against. And **study after study shows that children who are vaccinated can still carry the germ, despite having received the vaccine.** So, the vaccinated are still capable of spreading disease. But **the unvaccinated are being unfairly blamed because of a consensus opinion, but not true science.** To repeat, no study, no science has ever proven that vaccines eliminate the existence of the organism in your body. If anything, science is showing that the vaccines cause the organisms to mutate, and there are plenty of articles showing that strains are replaced by new strains after vaccination, similarly, to the way antibiotics are bringing about new strains of bacteria because of the overuse of antibiotics.

So why are we blaming the unvaccinated children? No study has ever been done in this country appropriately to address the health outcomes of children who are vaccinated, versus the children who are unvaccinated. I have been seeing families in my practice for over 20 years that have opted out of vaccination. They are the healthiest children I have ever seen. I have families who have older children who have been vaccinated, middle children who have been partially vaccinated, and then younger children who have not been vaccinated at all. And those families are rising in number. And they see the difference between the health outcomes of their younger children who are rarely sick, versus their older children who are getting IDPs (?) in schools, needing medications, ERs and constant health issues. And all I get when I hear that, when I state something like that is, "Well, that's anecdotal." Well, it's anecdotal if you see it a couple of times. But it's not anecdotal when you see it for over 20 years, and when you speak to parents, and when you speak to teachers, and when you speak to guidance counselors.

And when I speak to pediatricians who were too afraid to come out in public, there is pressure to ostracize the families who know the science and know the lack of science that's available. There's a lot of consensus. And when I think about the subject of vaccination, I want to ensure that if we're going to prevent infectious diseases in children, that we don't create something

worse in its place.

Unfortunately, we're dealing with a lot of beliefs instead of actual science, and beliefs go a long way. I took the oath of "first do no harm". But when I look into the science, and I don't see long term studies, and I see only short-term studies, up to four to 10 days, where the side effects are manipulated by the manufacturers who are the only ones doing the studies on the vaccines. And when I see no placebo groups, and I see no studies of the single ingredients or the combined ingredients, and I see the science, the biochemistry of the ingredients in animal studies, where animals who are given the aluminum are found to have motor delays and behavioral problems, which is a great deal of what we're seeing in children today, I say, are we first doing no harm? And so, first do no harm means the precautionary principle. And more and more parents are understanding the dangers of vaccines. And that's why we're seeing such pressure to mandate vaccines because more of the science is coming out.

In order to create herd immunity, you have to be able to prove that children who are vaccinated are immune. And the sad part about that is that whenever you vaccinate a population of children, you're always going to have a population that doesn't develop any antibodies at all. The estimates of that are about 10% that vaccines will fail in 10% of the population. Vaccination, no antibody production. But the next group is even more suspicious. Because when you vaccinate, and you do produce an antibody, there is science to show that the presence of an antibody doesn't guarantee immunity either. And we don't know the percentage of children who get a vaccine, develop an antibody, but aren't immune at all. We assume that if we vaccinate, we're getting protection. **We assume that if we vaccinate, we're stopping spread of disease. Those are assumptions that have never been solidified in science.** And I'm happy to offer more explanations during the Q&A. I wouldn't say that if I didn't have the science to prove it.

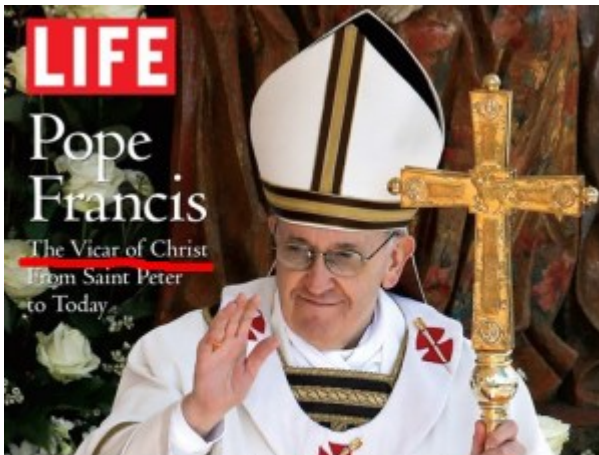
The parents that I work with a New York that I see around the country are very concerned that their rights are being taken away, that their knowledge about the science is being pushed away by an agenda that only says unvaccinated children are a problem.

Just to wrap up, in California when they had a measles outbreak, there were 194 cases. Of the 194 cases, 73 cases were due to the actual virus in the vaccine itself. Seventy-three, 38%, 73 cases were due to the measles virus causing measles. All the literature states that measles virus infection is not true measles and should not be counted as a health threat. That means only 121 Kids developed measles, 121 people. New York State did not do the proper testing that's given down by the CDC to test every child to see if the children had measles strain, wild type measles or a mutated measles. There are cases around the country and around the world where in a 95 ~ 98% vaccinated population they had measles outbreaks, because they found mutated viruses. As I said before, there are cases where the virus mutates, where they're strain replacements. New York State did not do the proper testing of the 1000 plus young children and adults who came down with measles. They wrote a little blurb on the CDC website of the two wild viruses that were responsible for the measles outbreak. But we in New York know that the

testing was not done. Four thousand two hundred kids on Long Island had the religious exemption and were not vaccinated. And there was not one case of measles on Long Island.

Not sure if it was that video or the one where I was pointing out all the deep state Trump nominated and pointed out he kept renewing the emergency declaration.

These platforms wanted certain narratives pushed. It’s not so much vaccine hesitancy that bans you. It’s how you attack the narrative. Like I wouldn’t get banned if I said the COVID “vaccine” alters your DNA, Jews are behind it, Q and Trump will save us.

There’s lots of good info everywhere, but if you don’t expose how it’s one entity in charge of this fraud and how it can orchestrate it with the whole world, all that good info does little.

Transcript of Dr. Bridle interview on *On Point* with Alex Pierson

Alex Pierson: Talking about a lot of science these days! It's coming out as fast and furious. And a lot of people asking a lot of good questions, you know, the vaccines, are they safe for kids? Certainly, there's a big push to get kids as young as 12 the shot as soon as possible, but, but everyone's confident about it, even if you're not an anti-vaxxer, there are a lot of parents who are kind of nervous about putting something into their kids.

And then I read that there have been several dozen cases of heart problems in teens and young adults, which Israel is now looking into. And what they're looking into which they'll release the results of are why mostly males, not all, but around 22 years of age and younger, are getting heart inflammation. So one to four days after getting a shot, they get shortness of breath, fatigue, and some very specific chest pain. It's mild, so no one's gotten really sick or died. But you want to know what you don't know if you're going to put something into your kids.

Let us bring in Dr. Byram Bridle. He's an associate professor of viral immunology at the University of Guelph (Ontario, Canada). Doctor, you've been very, you know, very open on this whole issue. And you know, you're not an anti-vaxxer by any stretch, but what do you think about this inflammation in the heart, and is it an actual threat?

Dr. Bridle: Yeah, thanks for having me on, Alex. Yeah, as you said, I'm very much pro-vaccine, but always making sure that the science is done properly, and that we follow the science carefully before going into public rollout of vaccines. I hope you'll run let me run with this a little bit, Alex. I'll forewarn you and your listeners that the story I'm about to tell is a bit of a scary one. This is cutting-edge science.

There's a couple of key pieces of scientific information that I have become privy to just within the past few days that has made the final link. So we understand now, myself and some key international collaborators, we understand exactly why these problems are happening. And many others associate these vaccines. And the story is a bit of a scary one. So just to brace you for this, but I'm going to walk you through this. The science that I'm gonna be talking about. I don't have the time here to describe exactly the scientific data. But let me assure you that everything that I'm stating here that I'm gonna state right now is completely backed up by peer-reviewed

scientific publications, and well-known and well-respected scientific journals.

I have all of this information in hand, I'm in the process of mildly trying to put it all into a document that I can hopefully circulate widely. So your listeners are going to be the first to hear the public release of this conclusion, and I can vouch for the science. So this is what it is.

The SARS-coronavirus 2 has a spike protein on its surface. That spike protein is what it allows it to infect our bodies. That is why we have been using the spike protein in our vaccines. The vaccines we're using get our cells in our bodies to manufacture that protein. If we can mount an immune response against that protein, in theory, we can prevent this virus from infecting the body. That's the theory behind the vaccine. However, when studying the disease, severe COVID-19, everything that you've just described heart problems, lots of problems with the cardiovascular system, bleeding and clotting is all associated with severe COVID-19.

And looking and doing that research, what has been discovered by the scientific community is the spike protein on its own is almost entirely responsible for the damage to the cardiovascular system if it gets into circulation. Indeed, if you inject the purified spike protein into the blood of research animals, they get all kinds of damage to the cardiovascular system, and it can cross the blood-brain barrier and cause damage to the brain.

Now at first glance, that doesn't seem too concerning because we're injecting these vaccines into the shoulder muscle. The assumption all up until now has been that these vaccines behave like all of our traditional vaccines that they don't go anywhere other than the injection site, so they stay in our shoulder. Some of the protein will go to the local draining lymph node in order to activate the immune system. However, this is where the cutting edge science has come in this and this is where it gets scary.

Through a request for information from the Japanese regulatory agency, myself and several international collaborators have been able to get access to what's called a bio-distribution study. It's the first time ever that scientists have been privy to seeing where these messenger RNA vaccines go after vaccination. In other words, is it a safe assumption that it stays in the shoulder muscle?

The short answer is absolutely not. It's very disconcerting.

The spike protein gets into the blood, circulates through the blood in individuals, over several days post-vaccination. It accumulates once it gets to the blood and accumulates in a number of tissues such as the spleen, the bone marrow, the liver, the adrenal glands. One particular concern for me is it accumulates at quite high concentrations in the ovaries. And, and then also a publication that was just accepted for a scientific paper just accepted for publication that backs this up, looked at 13 young healthcare workers that had received the Moderna vaccine which is the other messenger-RNA-based vaccine we have in Canada. And they confirm this They found the

spike protein in circulation in the blood of 11 of those 13 health care workers that had received the vaccine.

What this means is, so we have known for a long time that the spike protein is a pathogenic protein, it is a toxin, it can cause damage in our body if it gets into circulation. Now, we have clear cut evidence that the vaccines that make our bodies, our muscles or the cells in our deltoid muscles, manufacture this protein, that the vaccine itself, plus the protein gets into blood circulation. When in circulation, the spike protein can bind to the receptors that are on our platelets and the cells that line our blood vessels.

When that happens, it can do one of two things. It can either cause platelets to clump, and that can lead to clotting. That's exactly why we've been seeing clotting disorders associated with these vaccines, it can also lead to bleeding. And of course, the heart involved. It's part of a key part of the cardiovascular system. That's why we're seeing heart problems.

The protein can also cross the blood-brain barrier and cause neurological damage. That's why also in the fatal cases of blood clots many times is seen in the brain. And also of concern is there's also evidence of a study – this has not yet been accepted for publication yet, this one – they were trying to show that the antibodies from the vaccine get transferred through breast milk. And the idea was this may be a good thing because it would prefer some passive protection to babies. However, what they found inadvertently was that the vaccines, the messenger RNA vaccines, actually get transferred through the breast milk. So the delivering the vaccine vector itself into infants that are breastfeeding. Also what this note we know spike protein gets into circulation, any proteins in the blood will get concentrated in breast milk. Looking into the adverse event database in the United States, we have found evidence of suckling infants experiencing bleeding disorders in the gastrointestinal tract.

Alex Pierson: So okay, let me pause you there. There are only about 45 seconds left.

Dr. Bridle: Sure, I'll wrap it up this message.

So this has implications for blood donation. Right now Canadian Blood Services are saying that people who have been vaccinated can donate. We don't want the transfer of these pathogenic spike proteins to fragile patients who were being transfused with that blood. This has implications for infants that are suckling. And this has serious implications for people for whom SARS Coronavirus 2 is not a high-risk pathogen, and that includes all of our children.

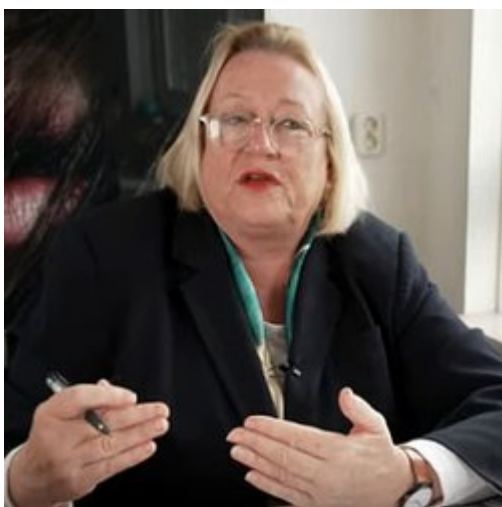
In short, the conclusion is, we made a big mistake, we didn't realize it until now, we thought the spike protein was a great target antigen, we never knew the spike protein itself was a toxin and was a pathogenic protein. So by vaccinating people, we are inadvertently inoculating them with a toxin. And some people this gets into circulation. And when that happens in some people, they can cause damage, especially in the cardiovascular system. And I have

many other, I don't have time, but many other legitimate questions about the long term safety, therefore, of this vaccine, for example, with it accumulating in the ovaries, one of my questions is, will we be rendering young people infertile, some of them infertile? So I'll stop there. I know it's heavy heading...

Alex Pierson: I'm up against the clock. I need like an hour when I talk to you because you have so much information and of course your one opinion of many, but you know, it's interesting because you have a different look at it. And certainly, the time will tell on this but we'll have you on again because I always get an interesting and different perspective from you. Doctor, thank you.

Dr. Bridle: It was my pleasure. Take care.

listening to someone on video.

Planet Lockdown

My name is Catherine Austin Fitts. I'm the publisher of the [Solari Report](#) and managing director of Solari Investment Advisory Services.

Interviewer: And what do you think is happening economically as a result of all this?

Catherine Austin Fitts: So what is happening, I just published a huge study called "[The State of our Currencies](#)", and what I describe is the fact that for many decades the dollar has been the reserve currency. And the system is what I would describe as *long in the tooth* (meaning getting old, often too old for a particular activity or purpose). And the central bankers are trying to bring in a new system but it's not ready to go yet. And we're in a period of great change and uncertainty where the central bankers are trying to keep the dollar system going and accelerate. So they're trying to lengthen the dollar system and then they're trying to accelerate bringing in the new system. And they have to bring in the new system without anybody quite realizing exactly what it is.

So we've had a global reserve currency system, the dollar, and it needs to evolve and change. And it's long in the tooth. There's lots of unhappiness with the system and the central bankers are trying to bring a new system. And to do it they're trying to extend the old and accelerate the new. And it makes it a very chaotic thing since much of the new was being tested and tried and prototyped. And it involves many different industries.

So I describe the new system as the **end of currencies**. We're not bringing in a new currency, we're essentially bringing in a new *transaction system* that will be **all digital** and essentially end currencies as we know them. So what they're trying to do is **involves essentially all the money on the planet**. So it's big, it's complicated, it's messy, and the challenge they have is how do you market a system that if people understood it nobody would want? And of course, the way you do that is **with a health care crisis**.

Interviewer: And why is the health care crisis good for that?

Catherine Austin Fitts: Because generally if a few people want to control the many, the question is how can you herd all the sheep into the slaughterhouse without them realizing it and resisting? So **the perfect thing is invisible enemies**.

We had the war on terrorism, you know, with invisible terrorists. And then now **a virus is perfect because it's invisible. You can't prove that it doesn't exist because it's invisible**. So invisible enemies are always the preferred ones **particularly if they scare people. If you can use fear and introduce significant fear, then people will need the government to protect them from the invisible enemy**.

Then the second tactic which is very effective is divide and conquer. And so

in the meantime, if you can use the media, the media plays a very important role. If you can turn men and women against each other, and Black and White against each other. And one of the reasons you import a lot of immigrants into Europe is turn the general population against the immigrants. And then you need the government to be in the middle. So these are all whether it's divide and tactic, or invisible enemies, these are all ways to institute fear and get people to go along with things.

And of course, the invisible virus allows you to do enormous control mechanisms. You can stop people from gathering, you can stop people from organizing, you can stop people from getting together and talking about what's going on, et cetera et cetera. And if you digitize it with contract tracing, then you can control who's talking to whom. If you can get them to do all their work and education online, you can literally listen to everything they're saying. So **you can institute extraordinary amounts of surveillance all in the theory that we're protecting you from the invisible virus.**

It's very clever. And as you can see it's working with many people, not everybody but many people, to me a lot. And I don't want to us underestimate the ability of the leadership to introduce pathogens that will kill people. And I don't want to suggest that people aren't getting sick, but essentially what you're trying to do is **you're trying to get people to buy into a solution before they see where it's ultimately going to go.** Because you're talking about a transaction system that is no longer a currency, it's a control system.

It's like the credit at the company store. If every central bank comes out with a digital central bank currency, they have the ability to turn your money on and off. So if you don't behave, that's it. And of course, as we know they want to combine this with transhumanism which means literally I take injections that can institute the equivalent of an operating system in my body. And so I'm hooked up to the financial system literally, physically.

Interviewer: What is the actual effect of the lockdown measures?

Catherine Austin Fitts: So what you're doing is you're trying to ... I used to call the Patriot Act the concentration in control of cash flow act. And this is a very similar process. You're trying to dramatically centralize economic and political control.

Let me give you an example. We have 100 small businesses on main street in a community. You declare them non-essential, shut them down. Suddenly Amazon and Walmart and the big box stores can come in and take away all the market share. In the meantime, the people on main street have to keep paying off their credit cards or their mortgage. So they're in a debt entrapment and they're desperate to get cash flow to cover basically their debts and their day-to-day expenses. In the meantime, you have the Federal Reserve institute a form of quantitative easing where they're buying corporate bonds and the and the guys who are taking up the market share can basically finance at zero to one percent, or their bank scan at zero to one percent when everybody in main street is paying 16 to 70 percent of their credit cards without income.

So basically now you've got them over a barrel and you can take away their market share. And generally, they can't afford to do what they say because they're too busy trying to find money to feed their kids.

In the 2016 election cycle, we saw the general population support candidates who represented populism in a variety of different ways. Bernie Sanders was a populist relative to the other candidates. Donald Trump was a populist relative to the other candidates. And literally, what the sort of global capital class realized was they had a problem that could be solved by destroying the independent income of small business and sole practitioners and people who had independent forms of income. If you're a doctor, if you're a lawyer, if you're a CPA, and you have your own practice, you are generally gonna support the populist candidates. And so the way to shut the populist candidates down and just shut off their income and support which is you put main street out of business. And then there's nobody to finance a Bernie Sanders or Donald Trump. There's nobody to support him.

Interviewer: So do those the lockdown measures appear to be more of an economic thing than a virus mitigation plan?

Catherine Austin Fitts: So this is an economic war and you've basically had sort of the top one percent. Since April we've seen global billionaires increase their net worth by 27%. Now what that says is this has been a very successful global economic work because what you're having is this sort of global capitalist class, and I shouldn't call it capitalism because it's not. It's much more totalitarianism. It's economic totalitarianism. What you've seen is they've been able to consolidate fantastic amounts of economic wealth not just by deleting the income of the middle class and consolidating it into their companies, but by significantly improving the wealth and power of the largest G7 developed countries and China vis-a-vis the emerging markets. So the countries with the most advanced technology and the access to AI and software, and to the sort of digital systems including through space, are dramatically consolidating economic power vis-a-vis the weaker nations. So we're seeing a consolidation of economic power centralization both into the wealthier and the more powerful nations, the basically top one percent who control them.

So I would describe what Covid-19 is, it's the institution of controls necessary to convert the planet from democratic process to technocracy. What we're watching is a change in control and an engineering of new control systems. Think of this as a coup d'etat. It's much more like a coup d'etat than a virus.

For 20 some years in the United States we've had a financial coup d'etat. And we knew in at the end of 1995, a decision was made to move much of the assets and money out of the country. That was part of sort of bubbling the global economy of globalization. And they knew that once they'd finished moving all those assets, that they would have to consolidate and change the fundamental system. So after the financial coup, you've stolen all the money in the pension funds, you've stolen all the money in the government. And now rather than turn and tell people, well, we stole your money, you need an excuse that will allow you to consolidate and change the fundamental system. And so you

have a Magic Virus. And the Magic Virus is we have to fundamentally change the system. And thanks to the Magic Virus, there's no money in Social Security. Thanks to the Magic Virus, there's no money in the treasury. And you have your perfect magic excuse.

Interviewer: Everything can be blamed on the Magic Virus.

Catherine Austin Fitts: Yeah, the Magic Virus. It's amazing because every implication of the financial coup has been magically solved by the Magic Virus! It's crazy!

If you're a financial person and you look at the world through the mathematics of time and money, it's quite amazing that anybody believes it, but they do. It's part of joining the what CJ Hopkins calls the convenient cult. You join the cult and you say oh yeah yeah yeah well the Magic Virus took all the money from Social Security, the Magic Virus caused our pension funds to not be sufficient blah blah blah blah blah.

Interviewer: So what do you think the technocracy that we're being towards is gonna look like?

Catherine Austin Fitts: The technocracy that they're pushing towards us is what is called transhumanism. So essentially what you do is you use injections to inject materials into the body that create the equivalent of an operating system. Everybody knows the idea of Microsoft causing you to download an operating system in your computer. That gives Microsoft and a variety of other players a back door into your computer. (Webmaster: That's why I prefer to use GNU/Linux!) And every month or two or three you've got to update it because there are viruses, right? It's back to the Magic Virus that can solve all problems. And so this is a similar system for your body. You inject materials into your body that essentially create the equivalent of an operating system and a receiver, and you can literally hook everybody up to the Cloud. And that includes hooking them up in a way that their transaction system, you know, the Bible calls it the Mark of the Beast – is one way people know this stuff – but you're basically talking about being able to digitally identify and track people in connection with their financial transactions. So it's a world of zero privacy.

But more importantly what's important to understand is if you then institute one or more central bank cryptos, you're now talking about a system where every central bank in the world can shut you off individually from transacting if they don't like the way you're behaving.

So many people are familiar with the social credit system in China, it's very similar. If you install the smart grid in their car, their community, and now in literally in their body, you've got 24/7 surveillance. And if people don't do what you say and behave the way you want, they can and will shut off your money.

And they'll also have spatial control. If they say you can't travel more than five miles, that's it, because you're in a complete digital control system, and it's controlled by the central bankers through the money. We're

digitizing everything but it includes the human body as well and the human mind. So this system comes with complete control, not only of your ability to transact financially which is hooked up to your body but very sophisticated mind control technology through the media and those cloud connections. So basically you're talking about hooking up into the "borg" (contraction for cybernetic organism) if you will. And so transhumanism and technocracy go hand in hand.

Now I would describe this as a slavery system. We're talking about shifting out of freedom where we have freedom to roam and freedom to say what we want into a complete control system 24/7 including mind control. Now the challenge before us is, if the sort of the committee that runs the world, my nickname being Mr. Global, if Mr. Global wants to go to a slavery system, and we want to remain a human civilization, then we have a fundamental disagreement. And that is the disagreement before us.

Interviewer: And we get to the diagrams here.

Catherine Austin Fitts: Okay, so if you look at what's going on, we have the tech people building the clouds and the telecommunications, we have the military doing space and operation warp speed. So they're putting up the satellites, okay, then we have big pharma which is making the injections that are full of these mystery ingredients and change and modify your DNA, and for all we know to make you infertile. And then we have the media pouring out the propaganda. And then we have the central bankers engineering the crypto, the central bank cryptosystems. So you have these different pillars and it's very important when you look at what's going on day to day, particularly in the media. They're trying to keep them separate so that you can't see how they're going to come together in an integrated system which is basically integrated into your body and your mind.

Interviewer: For what purpose?

Catherine Austin Fitts: To institute the slavery system. So in other words, if I am going to do everything through a smart grid and I need to run the smart grid into your neighborhood, and then I need to run the smart grid into your body, the question is how am I going to build it out in your neighborhood and build it on your body without you seeing the trap, right? So that's why you try and keep these different lines separate.

So if you listen to the central bankers, they try as hard as they can to stay away from these conversations. So it was interesting, I was watching an IMF presentation on cross-border payments, and the Federal Reserve chairman, the head of the IMF mentioned the digital global ID system. And the Federal Reserve chairman almost blanched! You could energetically feel him moving like a galaxy away like, "no no no no"! Because they're 325 million Americans, and they're more than 325 million guns, and he doesn't want everybody to see this until the trap is thrown and it's too late.

Interviewer: We've been put in a trap this year?

Catherine Austin Fitts: Yes right, but the door hasn't shut. So that's why

the reason we're talking is because **transparency can blow the game.**

It's interesting because in the beginning of the year when I wrote the article *Injection Fraud* and said Bill Gates is trying to download an operating system in your body just the way you download it your mind, and use the virus as an excuse to have to update it to to make it work for his back door every day, three months later (James) Corbett did a great series on Gates, and several people came out and sort of reaffirmed this. And it was in the Fall Yahoo Finance did a poll and published a poll saying that 44 of Republicans thought Bill Gates wanted to chip them, and I said, "okay we're making progress!" (Laughs) So and that's exactly when Gates sort of disappeared. And they brought out operation warp speed because they needed, and interestingly enough, the person they chose to run operation warp speed was an expert on injectable brain-machine interface. He used to head research at GlaxoSmithKline (a British multinational pharmaceutical company) and he's a brain-machine interface expert.

Interviewer: A creepy resume for that job huh?

Catherine Austin Fitts: It's a perfect resume for that job.

Here's one of the most important developments that happened in 2019. In addition to the approval of the going direct plan by the central bankers in Jackson Hall was the issuance by the Department of Defence of the JEDI Cloud contract to Microsoft. So you had Amazon receive ... Amazon is essentially a CIA

intelligence agency contractor. They started showing a random profit when they entered into major contracts with the CIA to provide the clouds not only for the CIA but all 17 U.S Intelligence agencies through that umbrella cloud contract. So you now have Amazon running the intelligence agencies contract this year. Latos did a big contract or at the end of 2019 Latos did a big contract with the Navy and then DOD did the JEDI contract. (The Joint Enterprise Defense Infrastructure (JEDI) contract is a large United States Department of Defense cloud computing contract which has been reported as being worth \$10 billion.)

And so those three huge cloud contracts give you the ability once you get everybody hooked up into them to radically re-engineer how the cash flows work. So you can literally shut down all small businesses, or almost all small businesses, put everybody in a universal basic income which is basically a control system, and run it all through the military clouds.

Interviewer: So you can see the direction we're headed but it's a little uncertain as to why or?

Catherine Austin Fitts: No, it's simple. Technology gives you the ability to institute a complete control system and further centralize economic and political control. I'll give you a perfect example. The reason the African-American slave trade ended ... there were two reasons in my opinion. One is you couldn't perfect collateral. So the banks in London kept losing money because the plantation owners when the commodities market went down would sell their slaves west, and the banks couldn't go get their collateral. So they would

finance the purchase of a slave and say 50 loan to value ratio, and then when the commodities markets down they'd sell the slaves and say they ran away, and the banks would be hung, right? And the banks couldn't prove that you know, Harry was their slave because they had no way of perfecting collateral.

Okay, so that was number one. The second was the Haitians rebelled and the Europeans sent several armies in to try and quell the rebellion and never could. The Haitians were too good. Okay, now if you look at digital technology, you can perfect the collateral. And with space weaponry and the kind of weaponry you have from space and surveillance, you can put down any rebellion, right? So the reason that the slave trade was unbelievably profitable, the history of the world is slavery, is the most profitable business. It's more profitable than mining, it's more profitable than narcotics, I mean it's more profitable than all the addictions. So if you now have the technological capability of implementing slavery, their attitude I think is, "okay, let's do it", right? And part of it is technology also makes it much easier for a small group of people to get together and be very powerful. So for example, if they bring in breakthrough energy technology, the danger is a small group of crazy people can weaponize it. So technology is powerful. The more powerful technology you integrate, the more danger there is you lose control.

Now there are other theories as to why people would want complete control. I'll give you another reason. Given the difficulty of feeding and managing a population that's getting ever larger, if you now have biotechnology that allows Mr. Global to live for 150 years, you can't afford, you can't keep that secret, right? If the wealthier lives for 150 years and we're not, you can't keep that a secret. So why not downsize the population, integrate robots, use robotics for everything, and you can have a very wealthy and luxurious life without all the management headaches, right?

Interviewer: So the kind of breaking of society into different classes or into an Uber class in a vast peasantry mixed with robotics?

Catherine Austin Fitts: Yes, yeah, in other words, what I think's trying to happen here is Mr. Global is using technology to move to a system where between robotics AI and software a few people can control the many with far less headaches and fear. You have to remember Mr. Global is very very afraid of the general population.

Interviewer: Their fear.

Catherine Austin Fitts: Yeah, they're very afraid because if you've been keeping ... several times I'm told the leadership in the United States has gotten together to discuss how can we undo the secrecy. And each time they come to the conclusion it's impossible. You can't undo the secrecy because the liabilities are too enormous. So if you're the Swamp and you're guilty of all the different things the Swamp is guilty of, and you try and open the window on the secrecy you run tremendous risks, tremendous risks. So you're afraid of the general population and the history of governance is the general population occasionally does turn and kill the leadership. So the 325 million people in America, they're more guns. So my guess the reason Jay Powell was

backpedaling when the head of the IMF was talking about digital identities is he's sitting there knowing he's got 325 million people and more and a lot of them have guns, and they don't have a lockdown yet.

This is why the Second Amendment is such a fractious issue. Most people around the world don't understand why people in America are so rabid about owning guns, and the first reason they're rabid about owning guns is they don't understand the power of mind control. So if I can institute total mind control which is what the system is, guns aren't that dangerous to me. But the leadership to do what they want to do, it would be very very convenient if they could bring in the guns. And you'll see if the Democrats win this election that's the first thing they're gonna try and do. After making everybody wear face diapers they're gonna they're gonna try and bring in the guns. And this is why the Republicans holding the Senate has been such a big issue because they can't do it if the Republicans hold the Senate.

Interviewer: The election is such a mess, huh?

Catherine Austin Fitts: So here's the thing when I try and tell everybody, because I grew up in Philadelphia, and my first boyfriend's father was a ward leader who used to go out with a roll of cash and buy all the votes every election. So there's an old tradition in America of voting fraud, and what I tell everybody is neither one of these candidates would have been the candidate without the voting fraud, to begin with. So we're in a funny position. But **I've never seen the voting fraud as blatant.** And I think to a certain extent it's interesting they could not have stopped a Trump landslide without Covid-19. So one question I have is how much of the ... because I thought they would do this after the election, how much of the timing of the health care op is basically designed to make sure they don't get a populist president? Not that Trump isn't ... it's hard for me to think of Donald Trump as a populist because he's very much on board for the pro-centralization team, but he's as Michael Moore has said, he's the American people's way of saying F.U. to the leadership. So I think it was very important to them to get rid of Trump which they're trying to do. The problem is they've used massive voter fraud to do it, but they've used the fraud in a way that it's obvious that the fraud is off the charts, and it's almost as though they're turning to the population which they're trying to turn into a cult and saying you have to pretend this guy is the President even though you know he's not. (Laughs) So we have a fake virus and a Magic Virus and a fake president and a magic political system and it's really is getting very cult-like. It's the only thing I can say.

Interviewer: yeah it's almost like a switch is flicked this year and we're in a bizarro world, right?

Catherine Austin Fitts: We've been in a bizarre world from the minute they started to steal the money we moved into a bizarre world.

(Note from the Webmaster: The final 28 minutes of the interview was sent to me from a gentleman in the Netherlands, Mr. Richard Zonneveld. He graciously allowed me to add it to this article.)

Catherine Austin Fitts: And I think the only difference is now as they moved all the money and the official reality moved away from reality even further and further, that's part and parcel of the secrecy, many people thought they could stay on the middle of the road. And now what's clear is you have to go with a cult or you have to go with the truth. The middle of the road is going away. And so everybody has to choose which they want.

Let's go to the riots. Okay so when the riots began and the leadership took the position that you couldn't go to church because of the danger of the Magic Virus, but you could go to the riots and protest, (she laughs) my team and I started to look at the riots. And so first we made if you if you come into Solari there's a database called Covid-19, I think it's Covid-19 riots and Fed, so the first thing we did is we looked at the state, and we looked at the cities, and whether the governor was Democrat or Republican, and then what the Covid cases and deaths were. And then we said, okay, we're going to check a box called riots where riots have been. So we started to look at the patterns of the riots vis-a-vis the machine political machine control, and sort of the Covid Magic Virus op, and there was something wrong when I was looking at the data. I could feel, I'm a very intuitive person, I was saying there's something here. So I said to the wonderful teammate who was building this I said,

"Do me a favor. I want you to put a box called the Federal Reserve, and I want you to check the box. There are 12 banks, one headquarters, and then the branches for a total of 37 locations. I want you to check the box wherever in any city where we have a branch or a bank or the headquarters I want a check."

And what we discovered is 34 of the 37 bank locations have riots. And I said, "Well wait a minute. That's a pattern! (Laughs) There's something here. Let's drill down."

So we started with Minneapolis and we said let's take the data of all the buildings that were harmed or burnt or businesses, and we'll map it, we'll do a GIS software, and we'll map where these businesses were, and how close they were to the Federal Reserve bank. And so the first one we did there's a street going across Minneapolis called Lake, and we mapped them. And one of the things we did when we mapped them was, we drew pictures of where the opportunity zones were. Do you know what an opportunity zone is? An opportunity zone is a tax shelter mechanism created in 2018 to help the tech billionaires as they sold their stock avoid capital gains. So you can if you're Jeff Bezos who sold 10 billion dollars of stock this year, if you were to rollover your proceeds into opportunity zone investments and handle it in a certain way you could avoid all capital gains tax. So this is fantastically profitable. Now, if you look at the riots when I first saw how all the buildings and businesses destroyed along Lake street were right at the bottom of the opportunity, I started to laugh and I said – I was assistant secretary of housing – "That's not a riot pattern, that's a real estate acquisition plan."

Interviewer: So what are you saying it's to cheapen the prices in the city?

Catherine Austin Fitts: So I have a thriving series of small businesses a lot owned by African American and Hispanics along a particular boulevard in the opportunity zone. If first I declare the businesses are non-essential and shut them down, right? – Magic Virus – So first I declare them non-essential. Now they're in real trouble, right? – because they can't do their business. And then I have riots and burn and damage them. Right? If I was really clever I pulled their insurance right before I did it. I don't know what the case was but we'll see. So now their business is shut down, they're now hung on their debt, right? Whether their mortgage or their credit card, but even worse now their building has been damaged. And of course, insurance doesn't cover all the repairs and fixing, right? So needless to say, it's going to be a lot easier and cheaper for me to go in and buy up all those buildings, right? Voila! It's called disaster capitalism.

So we then mapped, we did Minneapolis, then we mapped Kenosha, then Portland, and now we're doing a place in Ohio. And the patterns we're seeing. If you look at the clusters of where the damage is, just speaking as assistant secretary of housing, those are, in my opinion, real estate acquisition plans, completely, especially when they come on top of declaring all those small businesses not essential and shutting them down. We're restricting them. I'm sure you got a lot of restaurants in there.

(Interviewer: Yeah.)

Catherine Austin Fitts: So for example if you look at San Francisco 49 percent of the businesses in San Francisco are expected to be out of business by the end of the year. Do you know how much real estate you're going to be able to pick up cheap on this? It's phenomenal! Now when you realize that if they sell their tech stocks high they can pick it up really cheap what's important to understand is this makes the economics of building the smart grid out in the Fed cities. Remember I said 34 of 37 cities have a Fed bank or branch. So this makes building out the smart grid around the Fed banks much cheaper which I'm assuming you want to do if you're going to come out with a crypto-system.

Interviewer: Okay.

Catherine Austin Fitts: Okay so Mr. Global is now coming to the point where..

Interviewer: And can you explain who's Mr. Global?

Catherine Austin Fitts: Yeah. So Mr. Global is my nickname for the committee that runs the world. The defining characteristic of life on planet earth is our real global governance system is a mystery. And think about it. It's phenomenal we live on a planet and we don't demand to know how our governance system really works, but instead, it's a secret. So I have a lot of high octane conjectures, Dr. (Joseph P.) Farrel would say, about who and what that is but for now we'll call it Mr. Global. So Mr. Global is now implementing robotics. That's one of the new technologies that's really starting to make an enormous difference.

Interviewer: Can you label that?

Catherine Austin Fitts: Okay, so here's our robot, and here's our human. And of course, the question for Mr. Global is which is more efficient doing what? In other words, if I'm supposed to manage the planet and all the natural resources and harvest it to my benefit and make sure my risk is reduced, how much do I want to use robots for and how much do I want to do humans for? Now the brilliance of hooking everybody into the cloud with a crypto-system is, with AI and software, I can have the humans teach the robots to the AI software how to do all their jobs. And in fact, I was at the Aspen Institute of 2017 and I was having a discussion with a venture capitalist, sort of billionaire type, and he looked at me with these amazingly dead eyes and he said, "Look honey, I can take every company completely automated with software and robotics and fire all the humans. We don't need them anymore." I've never talked to anybody who didn't understand the riot part. (**Interviewer:** uh-huh) Because that's a very typical old game, yeah, especially in poor neighborhoods.

Interviewer: Yeah right.

Catherine Austin Fitts: Do you want me to continue with this? So we have Mr. Global at the top, we have the database and software systems using artificial intelligence. A very important part of this now is the satellite system that's being put up in the orbital platform. And using telecommunications and digital technology you have the ability 24/7 to track and monitor both your humans and your robots. And the question for Mr. Global is what's more efficient? If I can do everything with robots, then what do I do with the humans? I don't need them anymore.

Interviewer: So are we seeing built a kind of human farming or something?

Catherine Austin Fitts: So they would describe it as resource management. If you look at the technocracy, and the writing about technocracy, so many of us describe we're moving from whatever systems we use now to a technocracy. In a technocracy, they view ... you have two different visions of the world. My vision of the world is that humans are sovereign individuals whose freedom comes by Divine authority. That is what the Bill of Rights is, the Declaration of Independence, the Constitution, all revolve around the image of a sovereign individual as someone who is free by Divine authority. In the vision of technocracy, a human is a natural resource, like an oil deposit, and to be used as such. So they're not a sovereign individual, they're labor, and they are either more efficient or less efficient than a robot at different functions. In other words, what I'm saying is Mr. Global views the human race like livestock, not someone with which they share empathy. And, they don't view us as the same species as them. And in fact, with a lot of biotechnology, they figure they're going to live much longer lives than we do and live very differently than we do. So there's been a real ... one of the challenges with the secrecy as one group becomes more and more technologically advanced, they separate culturally, legally, financially from all the other groups. In other words, they have literally broken away and created a separate civilization. They don't think of themselves as part of our civilization anymore.

Interviewer: And who is "they"?

Catherine Austin Fitts: Well that's the great mystery, and that's why I call this group Mr. Global. And my personal experiences with many different people in that group and factions, but ultimately I can't tell you who really controls. What I will tell you is the planet is run by force. And so ultimately the question is, "Who is the most powerful gun?" And that comes down to space. Who has the most powerful space presence, space weapons, as well as who controls the sea lanes? So traditionally control behind the reserve currency came from control of the sea lanes, but then as we've moved into space, it's now become control of both the sea lanes and the satellite lanes. And the question is, who controls what and who has what weapons? One of the reasons you've seen a very interesting discussion in the United States for the last two years is Trump has been very verbal about Space Force and what is possible in space. And he'll make these allusions to our magical weapons in space at which point the generals look at him very disapproving like, "Don't talk about that!" So the answer is we don't know. We don't know.

What we do know is part of the competition right now between China and America is that the player who has the most dominant position in space has the power to control the whole planet. So the Chinese have a system called the Social Credit System, and they're very much tying their financial transactions and different abilities to travel and do other things to your behavior. And we've seen different TV shows talk about these kinds of systems. But you're talking about a world where, and we see in China, where most people are under 24/7 surveillance, and then their financial incentives and their financial powers relate to how well behaved they are. And I would describe it essentially as a slavery system because there's no personal freedom. So to a certain extent what technocracy will do is move us to a similar kind of system as the Chinese Social Credit System.

Interviewer: Where if you misbehave you can be punished.

Catherine Austin Fitts: Right. So in theory you have to get a certain kind of job to make a certain kind of money in the current system. In the new system, you have to work for a certain kind of company and achieve a certain kind of prominence to be allowed to move more than 10 miles from your home or to be allowed to fly. So there will be a pecking order that relates to your freedoms to either travel or roam, or how many sorts of access you have to resources, how much money you can make. But remember, you're going into a system where if they believe they can automate everything with robotic software and AI it's going to be that much harder for you to share in the benefits and the wealth of the system because the central group can extract so much more. In other words, they have a one-way mirror, they can see everything you do. You can't even see who they are.

Interviewer: Yeah okay.

Catherine Austin Fitts: What's very important to understand about what is happening is that the majority of people have been ... if we're talking about a transhumanist system or, in short, a slavery system, most of us have been supporting it and financing it and building it. So when I look at all the big pharma executives, why are they building a system where their own children or grandchildren will be slaves? Why are the central banks doing it? Why do they

think, you know, there's a theory in America for many years among the certain classes that if I make enough money, I can get a waiver, I can get out of it, I can eat organic food, not eat the GMO's, and my grandkids won't have to take vaccines. But if you look at who's implementing all these different activities, we're building our own slavery system and that means we have the power to stop. In other words, we don't have to finance the companies that are doing this, we don't have to work for the companies that are doing this, and in fact, we don't even have to pay our taxes (**Webmaster:** I don't know about that! I wouldn't challenge the IRS!) because the government is breaking all the laws related to financial management. We have the ability to hold them accountable. So we're building the prison and we're financing the prison and that gives us the power to stop. And that's why it's so important that we see where the system is going. There will be no exceptions.

Interviewer: So what is the solution?

Catherine Austin Fitts: Solution is, number one, bring transparency to what's happening, understand where the system is going, and then stop building it. If you work for big pharma and you're building this, stop! Go find something else to do like build local fresh food systems so you will have food. So stop financing it. Begin the conversation of where this is going and more importantly where we want to go, because we're going to have to rebuild the economy bottom up if we don't want to be highly centralized. So this comes down to I call it coming clean. Once upon a time I was in Washington I was writing a check on my JP Morgan Chase private banking account, and in the meantime I was engaged in 12 different tracks of litigation, litigating with the people who are trying to engineer the housing bubble. I was trying to stop the housing bubble from happening. And I was writing a check on my JP Morgan Chase personal banking account. I realized, why am I banking at the bank that's doing this criminality, that's destroying communities, that's doing predatory lending? And I said I need to come clean. I need to stop banking there. So if tomorrow everybody woke up in America and stopped banking at JP Morgan Chase and said, "You all are criminals! We want nothing to do with you! We're out!" and went to a local credit union or community bank, it would be a revolution. It would be a total revolution! If 20 women turned to big farm executives and said, "You know something? You're disgusting! No sex! Bye! Out the door." It would be a revolution! So we have the power to change this, but we're all going to have to come clean because almost all of us are complicit in implementing this. It's not them, it's us. The solution is for every one of us to come clean. You're either for the trans-humanist slavery system or you're for a human system. But if you're for a human system then you're gonna have to find a way to make money, and engage socially in a human system, and stop building a trans-human system.

Well, the first thing you have to see is you have to get a good map. In other words, you can't navigate this unless you can see the trans-humanist system that is being built, and who's building it. But if you're involved with ... so let's go back to the pillars. Okay, don't help the military build Operation Warp Speed, okay? Don't help the tech guys figure out how to inject nanoparticles into your body and hook them up to the cloud. Don't help big pharma make injections that are poisoning American children to death. Don't

help big agriculture make grow GMO food that is poisoning America to death. Don't help the government institute corrupt sort of health crisis regulations that are really disaster capitalism and making the private equity guys and the billionaires rich, and on and on and on. But if you, I'll just be blunt, get the 'State of our Currencies' and read it, and you'll know who's doing this. I mean, it's pretty obvious who's doing this.
