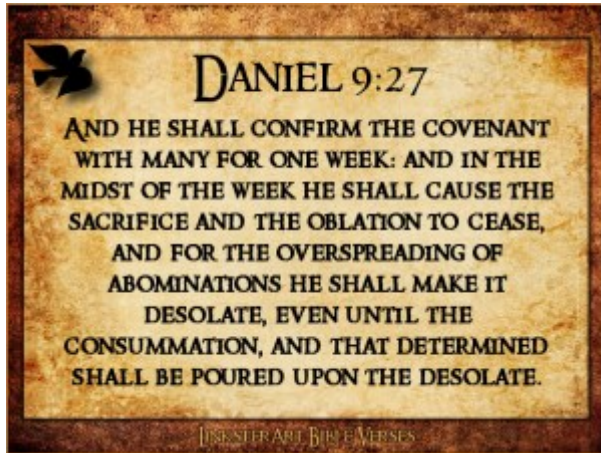


# Seven Facts that Led Me to Conclude the Seventh Week of Daniel was Fulfilled by Christ and His Apostles



I've been having exchanges with a brother in Christ who is a Futurist. He believes the prophecy of Daniel 9:27 is an Endtime event, and I believe it was fulfilled in the past. The Devil has deceived many Christians today through ignorance of history and Jesuit false doctrines that have crept into the Church to think prophecies of Daniel, Matthew 24, II Thessalonians 2, and nearly all of the prophecies in the Book of Revelation are yet to be fulfilled in the future. And why would Satan do that? To stop Protestant Christians from calling Papal Rome "MYSTERY, BABYLON THE GREAT, THE MOTHER OF HARLOTS AND ABOMINATIONS OF THE EARTH" of Revelation 17:5, and to stop calling the popes of Rome "that man of sin ... the son of perdition" of 2 Thessalonians 2:3.

Up till the beginning of the 20th century, sound eschatological doctrine among Bible reading Protestants still prevailed. It changed dramatically after C.I. Scofield published his Scofield Reference Bible.

Here are seven facts I shared with my friend about the Futurist interpretation of Daniel 9:27 which he holds, facts that I consider irrefutable.

1. It was my pastor who taught me the Futurist view of Daniel 9:27 and the 70th Week of Daniel about the Antichrist making a seven-year-covenant with the Jews and Israel to rebuild their temple which was destroyed by the Romans in 70 AD. He taught me there is an undetermined gap in time between the 69th Week and the 70th Week. I first heard this from him circa 1974 when I was young and without knowing any alternate interpretations of the 70th Week. I had no reason in my mind to question him because he was more learned than I was. In 2005 an email friend told me there is no gap of time between the 69th and 70th Week of Daniel. I rejected the idea then due to my cognitive bias and because my friend was a SDA. I thought he was giving me an SDA-specific doctrine. It was 9 years later when I learned he was telling me standard Protestant

interpretation of the 70th Week.

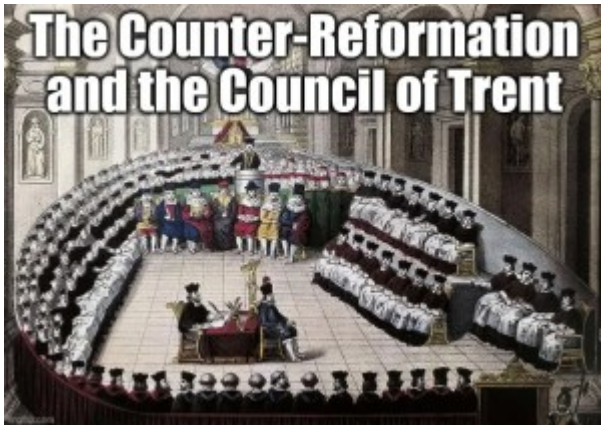
2. The very same pastor 19 years later in 1993 confessed that he got that interpretation of the 70th Week of Daniel from C.I. Scofield, a man who also taught the evil doctrines of Zionism and pre-tribulation secret rapture. These were two doctrines from Scofield my pastor threw out the window over 20 years earlier! The pastor also stated that his interpretation of the 70th Week is only a theory. In spite of that, I was not motivated at the time to search for alternative interpretations. I had no access to other resources because I was living in Japan then, a land with limited English libraries. The Internet was not yet popular. I didn't start using the Internet to gain information until 1997, four years later.
3. It was finally in December of 2014 I learned from articles on the Internet that up to the 19th century, most Bible commentators taught that Daniel 9:27 is a Messianic prophecy that was fulfilled by Christ and His Apostles. One reason I think I received it then is because a couple years before that I learned that 19th century and earlier Protestant Bible commentators taught that the prophecy of the man of sin of 2 Thessalonians 2:3,4 is talking about the office of the papacy. I believed they were correct. That took me halfway to understanding Daniel 9:27.
4. Scripture interprets Scripture. Verse 4 of Daniel chapter 9 says, "keeping the covenant and mercy to them that love him." This is clearly the same covenant of verse 27! "And he shall confirm the covenant with many for one week:" Notice the definite article "the" before covenant in verses 4 and 27? This is indicative that the covenant that was confirmed was already in existence. The covenant of verse 4 is the same covenant of verse 27, namely the covenant God made with Abraham, the covenant of grace through faith. Jesus Himself confirmed this covenant with the Jews when He preached the Gospel to them! Paul confirms this in Galatians 3:17 when he says "And this I say, that the covenant, that was confirmed before of God in Christ..." It was Jesus, not Antichrist, who caused the sacrifice and oblation to cease in the middle of the "Week" or seven-year period when He was crucified on the Cross of Calvary. His Apostles continued to openly preach the Gospel for three and a half more years until major persecution of the believers and followers of Christ began with the stoning of Stephen, thus ending the 7-year confirmation of the covenant with Israel and the beginning of Paul's ministry of preaching the Gospel to the Gentiles.
5. Jesuit Francesco Ribera around 1585 concocted the Futurist interpretation of Daniel 9:27 to put the Antichrist into the unknown FUTURE, to stop the Protestants from calling the popes of Rome the Antichrist. It also diverted attention from papal Rome, the so-called "Holy See" of being "MYSTERY, BABYLON THE GREAT, THE MOTHER OF HARLOTS AND ABOMINATIONS OF THE EARTH" of Revelation 17:5.
6. The Futurist interpretation of Daniel 9:27 was largely REJECTED by Protestants until the 20th century when it was proclaimed by C.I. Scofield in his Scofield Reference Bible, a Bible filled with false interpretations of prophecy that blinded the Church as to who the man of sin of 2 Thessalonians chapter 2 is. It and Scofield's other dispensational doctrines such as Christian Zionism was and continues to

be promoted by the prestigious Dallas Theological Seminary which wrongly influenced nearly all the popular preachers of today.

7. The false Jesuit Futurist interpretation of Daniel 9:27 is held by the majority of evangelicals today which is why many churches are apostate churches.

## [John Hagee vs. the Bible](#)



Millions of Christians today, especially American Christians, have been deceived by false doctrines of dispensationalism formulated by John Nelson Darby in the 19th century that say God has two covenant peoples, the Church

and Israel. Dispensationalism rejects the longstanding teaching that there is one church that consists of both old covenant saints and new covenant saints. Dispensationalism rejects the teaching that old covenant Israel was the church and that, in the new covenant, God grafts believing Gentiles into that same church (Rom. 11:17–24).

Dispensationalism is a false unbiblical doctrine! The Book of Hebrews clearly says God will give the house of Israel a *new* covenant, the *same* covenant the Church is under, the covenant of grace through the belief that Jesus is the Christ, the Son of God Who died for our sins and was resurrected on the third day.

Hebrews 8:10 For this is the covenant that I will make with the house of Israel after those days, saith the Lord; I will put my laws into their mind, and write them in their hearts: and I will be to them a God, and they shall be to me a people:

11 And they shall not teach every man his neighbour, and every man his brother, saying, Know the Lord: for all shall know me, from the least to the greatest.

12 For I will be merciful to their unrighteousness, and their sins and their iniquities will I remember no more.

13 In that he saith, A new covenant, **he hath made the first old**. Now that which decayeth and waxeth old is ready to vanish away.

Darby's doctrines of dispensationalism became popular because it was promoted by C.I.Scofield and his reference Bible. It was further promoted by the Dallas Theological Seminary It led to so-called "Christian Zionism" and the promotion of the restoration of the Jews in Palestine which has resulted in the bloodshed in Gaza we see today! And why do Christian Zionists want to promote the State of Israel? Because they believe Israel has a role in the end time to bring about the return of Christ! They believe the Antichrist will make a deal with Israel and the Muslims creating peace so that the Jews can rebuild their temple to renew animal sacrifices. They believe the Church will be raptured to heaven just before that happens. They believe that three and a half years later the Antichrist will set up his image in the temple, tell everyone to worship it, and have all those who don't killed. They believe Jesus will return three and a half years later with his raptured saints to fight the Antichrist and his people in the battle of Armageddon. All these doctrines are *false*! They are all based on the erroneous interpretation of Daniel chapters 9, 11, Matthew 24, and the Book of Revelation. I wrote extensively about this subject on this website.

If this surprises you, it's because you have been influenced by popular dispensational preachers today who promote Christian Zionism. One of the loudest and most influential Christian Zionist preachers is pastor John Hagee.

“John Charles Hagee (born April 12, 1940) is the founder and Senior Pastor of Cornerstone Church in San Antonio, Texas, a non-denominational evangelical church with more than 22,000 active members. He founded John Hagee Ministries, which telecasts to the United States and Canada. He is also the founder and chairman of the Christian Zionist organization Christians United for Israel.” – Source Wikipedia and Hagee Ministries website.

Let’s compare what John Hagee teaches to what the Bible says:

“I’m not trying to convert the Jewish people to the Christian faith. . . . trying to convert Jews is a waste of time. The Jewish person with his roots in Judaism is not going to convert to Christianity” (Houston Chronicle, Apr. 30, 1988)

“The first rule adopted by Christians United for Israel was that there would be no proselytizing at our events. CUFI exists only to honor and support the Jewish people, never to convert them” (Hagee, “Why Christian Zionists Really Support Israel,” May 13, 2010).

On the day just before Jesus ascended back to Heaven, He told His disciples:

Acts 1:8 But ye shall receive power, after that the Holy Ghost is come upon you: and ye shall be witnesses unto me both in Jerusalem, and in all Judaea, and in Samaria, and unto the uttermost part of the earth.

Witnesses to whom in Jerusalem and Judaea? To the Jews!

Acts 2:5 And there were dwelling at Jerusalem Jews, devout men, out of every nation under heaven.

Peter preached the Gospel in Acts chapter 2 to those Jews.

Acts 2:41 Then they that gladly received his word were baptized: and the same day there were added unto them about three thousand souls.

Those 3000 souls who were saved were all Jews! Jesus clearly told His disciples to share the Gospel with them!

Hagee says,

“I’m delighted to present my latest book, “**In Defense of Israel.**” This book will expose the sins of the fathers in the vicious abuse of the Jewish people. “*In Defense of Israel*” will shake Christian

theology. It Scripturally proves that **the Jewish people, as a whole, did not reject Jesus as Messiah.** It will also prove that Jesus did not come to Earth to be the Messiah. It will prove that there was a Calvary conspiracy between Rome, the high priest and Herod to execute Jesus as an insurrectionist too dangerous to live. Since Jesus refused by word and deed to claim to be the Messiah, how can the Jews be blamed for rejecting what was never offered?" (also declared on p. 145 of the book)

Anybody who believes that statement by Hagee doesn't read their Bible! Even a Sunday School kid should be able to disprove Hagee's heretical statements. Jesus identified Himself to the Samaritan woman at the well as the Messiah.

John 4:25 The woman saith unto him, I know that **Messias cometh, which is called Christ:** when he is come, he will tell us all things.

26 Jesus saith unto her, **I that speak unto thee am he.**

In the KJV, the word Messiah is found twice in the Old Testament in Daniel 9:25 and 26. The spelling variation of Messiah in the New Testament is Messias. Besides John 4:25 it's also found in John 1:41.

John 1:41 He first findeth his own brother Simon, and saith unto him, We have found the Messias, which is, being interpreted, the Christ.

As you can see, both times the name Messias is used, Christ is also used as the Greek meaning of the Hebrew word Messias / Messiah. Messias / Messiah and Christ are synonymous! Christ occurs 60 times in the four Gospels! It occurs 555 times in the entire New Testament! For Hagee to say, "Jesus did not come to Earth to be the Messiah" is the same as saying that Jesus did not come to Earth to be Christ! It's even saying that Jesus is *not* Christ! Does that make John Hagee an antichrist? It does if he denies Jesus is Christ!

Jesus unequivocally told the high priest He is Christ!

Mark 14:61 But he held his peace, and answered nothing. Again the high priest asked him, and said unto him, **Art thou the Christ, the Son of the Blessed?**

62 And Jesus said, **I am:** and ye shall see the Son of man sitting on the right hand of power, and coming in the clouds of heaven.

Jesus also told it to the elders of the people, the chief priests and the scribes:

Luke 22:66 And as soon as it was day, the elders of the people and the chief priests and the scribes came

together, and led him into their council, saying,  
67 Art thou the Christ? tell us. And he said unto them,  
If I tell you, ye will not believe:  
68 And if I also ask you, ye will not answer me, nor let  
me go.  
69 Hereafter shall the Son of man sit on the right hand  
of the power of God.  
70 Then said they all, Art thou then the Son of God? And  
he said unto them, Ye say that I am.  
71 And they said, What need we any further witness? for  
we ourselves have heard of his own mouth.

Jesus identified Himself to the man who was blind from birth who He healed as  
the Son of God, the Messiah, the Christ.

John 9:35 Jesus heard that they had cast him out; and  
when he had found him, he said unto him, Dost thou  
believe on **the Son of God?**

36 He answered and said, Who is he, Lord, that I might  
believe on him?

37 And Jesus said unto him, Thou hast both seen him, and  
it is he that talketh with thee.

Hagee says,

“If God intended for Jesus to be the Messiah of Israel, why didn’t  
he authorize Jesus to use supernatural signs to prove he was God’s  
Messiah, just as Moses had done?” (p. 137)

The Bible says that God *did* authorize Jesus to use supernatural signs!

Luke 7:20 When the men were come unto him, they said,  
John Baptist hath sent us unto thee, saying, Art thou he  
that should come? or look we for another?

21 And in that same hour he cured many of their  
infirmities and plagues, and of evil spirits; and unto  
many that were blind he gave sight.

22 Then Jesus answering said unto them, Go your way, and  
tell John what things ye have seen and heard; how that  
the **blind see, the lame walk, the lepers are cleansed,**  
**the deaf hear, the dead are raised,** to the poor the  
gospel is preached.

Hagee says curing the blind, the lame, the lepers, the deaf and raising the  
dead are not supernatural signs?!

“Jesus refused to produce a sign ... because it was not the Father’s will, nor his, to be Messiah.” (p 138)

Jesus refused to produce *an immediate sign* to the Pharisees when they demanded one! The fact is Jesus *already did* many signs!

John 10:31 Then the Jews took up stones again to stone him.

32 Jesus answered them, **Many good works have I shewed you from my Father**; for which of those works do ye stone me?

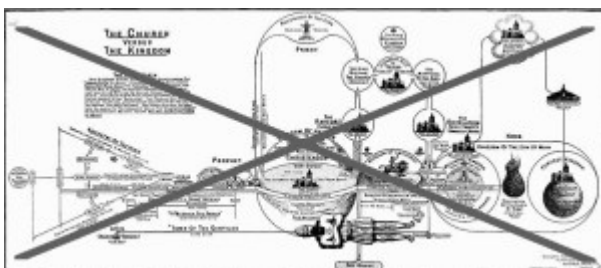
John 20:30 And **many other signs** truly did Jesus in the presence of his disciples, which are not written in this book:

“The Jews were not rejecting Jesus as Messiah; it was Jesus who was refusing to be the Messiah to the Jews. . . . They wanted him to be their Messiah, but he flatly refused. . . . He refused to be their Messiah, choosing instead to be the Savior of the world.” (pp. 140-141, 143)

I hope this convinces you that John Hagee is a false teacher. His book *In Defense of Israel* is rank heresy. If you support the modern state of Israel in its genocide of Palestinians, many of whom are Christians, it means you have their blood on your hands as much as he does.

# Have You Been Duped by Dispensationalism?



You may not have heard of the theological term, "Dispensationalism," or even if you have, you may not know how to define it. But even so, if you are a Bible believer and a follower of Jesus Christ, the chances are high that your views of the Endtime have been tainted by Dispensational doctrines.

## **What is Dispensationalism?**

Dispensationalism is a method of Bible interpretation that was devised by John Nelson Darby (1800-1882), and later formulated by Cyrus I. Scofield (1843-1921), and is also known as Pre-millennial Dispensationalism. Although Darby was not the first person to suggest such a theory, he was, however, the first to develop it as a system of Bible interpretation and is, therefore, regarded as the Father of Dispensationalism.

Dispensationalism was promoted through the publication of the Scofield Reference Bible, which was published in 1909. Scofield's Bible contributed to the spread of Dispensationalism because it included study notes written from a distinctively dispensationalist perspective.

The founding of Dallas Theological Seminary in 1924 by Lewis Sperry Chafer provided an academic institution for the training of pastors and missionaries in the dispensationalist tradition. The influence of the prestigious Dallas Theological Seminary together with the Scofield Reference Bible is the reason why American evangelicals were corrupted with the false doctrines of Dispensationalism!

The origin of Dispensational theory can be traced to **three Jesuit priests**.

(1) Francisco **Ribera** (1537-1591). He's the guy that cooked up the doctrine of Futurism, namely that there is a gap of unknown time between the 69th and 70th Week of Daniel, and the 70th Week of Daniel is the final 7 years of the Endtime when the Antichrist makes a covenant or treaty with Israel, rebuilds their temple, breaks the covenant halfway into the 7 years, and persecutes everybody who doesn't obey and follow him.

(2) Cardinal Robert **Bellarmino** (1542-1621) one of the best-known Jesuit apologists, who promoted similar theories to Ribera in his published work

between 1581 and 1593 entitled *Polemic Lectures Concerning the Disputed Points of the Christian Belief Against the Heretics of This Time*. The “heretics” are Protestants, Baptists, and all Bible believers and followers of Jesus Christ who are not members of the Roman Catholic Church! Bellarmine was arguing against all basic Bible doctrines such as salvation by grace through faith in Christ alone.

(3) Manuel **Lacunza** (1731–1801). The writings of Ribera and Bellarmine, which contain the precedence upon which the theory of Dispensationalism is founded, were originally written to counteract the Protestant reformers’ interpretation of the Book of the Revelation which, according to the reformers, **exposed the Pope as Antichrist and the Roman Catholic Church as the whore of Babylon.**

### **What are the doctrines of Dispensationalism?**

- A distinction between the Church and Israel.
- A distinction between the Kingdom of Heaven and the Kingdom of God.
- Support for the State of Israel.
- The world will be led by a one-world government and a one-world leader called “the Antichrist” who will promote a one-world religion.
- The Antichrist **will probably be a Jew.**
- The Antichrist makes a 7-year peace pact with the Jews which allows them to rebuild the Temple of Solomon.
- The Church will disappear in the “secret rapture” where all Christian believers vanish from the planet and that this rapture is “imminent.”
- The Rapture is then followed by a 7-year period called the “Great Tribulation.” A variation of this is the Great Tribulation will begin in the middle of the 7-year period.

All so called “Christian-Zionists” are Dispensationalists. Famous Dispensationalists include Billy Graham, Franklin Graham, Pat Robertson, Jerry Falwell, James Dobson, John Hagee, and Paula White. Just think what an influence these people have had on Christianity in America! Is it a good influence based on pure Bible doctrine? John Hagee tells us:

“As Christians, we are commanded by God to support Israel. We believe in the promise of Genesis 12:3 regarding the Jewish people and the nation of Israel. We believe Christians should bless and comfort Israel and the Jewish people. Believers have a Bible mandate to combat anti-Semitism and to speak out in defense of Israel and the chosen people.” – John Hagee

Hagee’s statement is based on Dispensationalism. The Bible tells me:

2 *John 1:9* *Whosoever transgresseth, and **abideth not in the doctrine of Christ**, hath not God. He that abideth in the doctrine of Christ, he hath both the Father and the Son.*

10 *If there come any unto you, and bring not this doctrine, receive him not*

*into your house, neither bid him God speed:*

**11 For he that biddeth him God speed is partaker of his evil deeds.**

The words, "God speed" in the King James Bible is a synonym for blessing someone. The Word of God tells us not to bless those who do not abide in the doctrine of Christ. If we do, we are partakers of their evil deeds. Does the modern state of Israel abide in the doctrine of Christ? Absolutely not. And yet, John Hagee is telling us to bless the ones who do not abide in the doctrine of Christ. Not only do they not abide in the doctrine of Christ, they curse Jesus Christ and reject Him!

Ask yourself, is God blessing America today? The liberals, atheists, and leftists are blaming America's extreme weather, the current heat wave, destruction of houses by tornados, fires, and floods on "Climate Change." I believe it's much more to do with God's judgments on America for her sins. One of those sins is America's support for Israel due to dispensational theology.

Dispensationalists accuse Christians who do not support the modern state of Israel of holding the doctrine of "Replacement Theology." This is a misnomer. The Church has not replaced Israel, [the Church is the continuation of Israel!](#)

## [The Mystics, The Masons and Dallas Theological Seminary](#)

I was impressed by this article by James Whisler I found on <https://historicist.info/articles/dts.htm> and thought to repost the first part of it. The website is in need of repair. There are broken links to images and other technical errors.

It must first be brought to the reader's attention that the mystery

religions, including Freemasonry, have employed symbolism as a form of communication. The hidden understanding of symbols was a necessary part of the initiation into the mysteries. This has been going on for thousands of years and is still in existence today, with the common masses never catching on. The Masonic Master Reference Bible states "Freemasonry has been defined as a peculiar system of morality, veiled in allegory and illustrated by symbols."

The greatly honored 33<sup>rd</sup> degree Freemason and Luciferian Albert Pike wrote:

*Masonry, like all the Religions, all the Mysteries, Hermeticism, and Alchemy, conceals its secrets from all except the Adepts and Sages, or the Elect, and uses false explanations and misinterpretations of its symbols to mislead those who deserve only to be misled; to conceal the Truth, which it calls light, and draw them away from it."*

Dallas Theological Seminary (DTS) is no stranger to this symbolism. I contacted DTS about their logo and asked them what it symbolized. Their exact response is reproduced below:

*The Dallas Seminary logo features a three part flame symbolizing the Father, Son and Holy Spirit illuminating the Scriptures which are shown in two parts indicating both Testaments. Thanks for the inquiry.*

I don't believe the Lord wants us symbolizing the Trinity in art. Acts 17:29 says "Forasmuch then as we are the offspring of God, we ought not to think that the Godhead is like unto gold, or silver, or stone, graven by art and man's device." In studying DTS, however, I have come to the conclusion that it means something far different. Bear in mind that Satan has a counterfeit trinity.

I believe and intend to prove that the flame represents the illumination of the ancient mystery religions for the initiates only and the books represent the ancient poisonous Alexandrian manuscripts, also written by initiates. All the modern bible versions are based on these manuscripts and without them, the dispensationalists could not teach their doctrines. I would hope that reader does not jump to any conclusions but lets the evidence speak for itself.

The three-fold flame, which is a symbol popular with the Luciferians and new agers today (symbolizing a false trinity), is attributed to the occultist and Rosicrucian Saint Germain who lived about three centuries ago.

*“The Christ flame within the heart embodies the same qualities of love, wisdom, and power that manifest in the heart of the Almighty, in the heart of your I AM Presence, and in the heart of your Christ Self. Right within your own body temple are three fiery plumes of the Holy Spirit-pink, yellow, and blue pulsations of living flame. Thus the heavenly Trinity gains expression in the world of material form. And the energies of Father (blue), Son (yellow), and Holy Spirit (pink) are resplendent in the heart of man. Also corresponding with the trinity of body, mind, and soul, the threefold flame supplies man’s needs for power to run the body (the faith and goodwill of the divine intent); wisdom to nourish the mind (illumination and the right use of the knowledge of the Law); and love to fulfill the destiny of the soul in conscious outer manifestation (a just and merciful compassion that is always rewarded by individual creative fulfillment)”*

Now as far as the area they selected for their mystery school, the Dallas area is sacred to Freemasonry because of its location. It is near the 33<sup>rd</sup> parallel of the 33<sup>rd</sup> degree of latitude. The number 33 is revered by Masons. (Lucifer took 33% of the angels when he left heaven. There are 33 degrees of initiation in Scottish Rite Freemasonry. The number is integral to their sacred geometry.) The founding Scottish Rite Masonic temple in America is located in Charleston, South Carolina, which is on the 33<sup>rd</sup> degree of latitude. Initiates in the Mysteries believe they can harness spiritual energies and receive an occultic blessing on their labors by carrying them out on their sacred grounds. Is it any coincidence that Tim LaHaye set up his Pretrib Rapture Research Center in [Washington D.C., a city designed by Freemasons](#) with the streets forming Masonic symbols? LaHaye was located in a plaza, on a street named after Pierre Charles L’enfant, the Mason who designed the city. This street forms one leg of the Masonic compass, an area believed by the Luciferians to hold strong occultic energies. By another coincidence, LaHaye, moved his research center to the Dallas area. Wouldn’t you agree that he is receiving some kind of spiritual blessing on the sales of his latest books? Do you believe this blessing is from God?

Some might mistake it for a Christian symbol, but Masonic author Ray Denslow reveals its true meaning:

"The Cross and Crown may be said to be confined almost exclusively to the historical degrees in Masonry as exemplified in the various orders of knighthood of York and Scottish rites. In Gaul we find the cross to have been a solar symbol when it had equal arms and angles; to the Phoenicians, it was an instrument of sacrifice to their God, Baal; and to the Egyptians, the crux ansata was his symbol of eternal life." (Ray V. Denslow, *Masonic Portraits*, Transactions of this Missouri Lodge of Research, vol. #29, p.7

Masonic authority Albert Pike also wrote of the meaning of the above symbol in his book *Morals and Dogma*, explaining that it has a sexual connotation to it as well. (Why is this symbol on a 'Christian' book cover ?).

Dealey Plaza, named after 33<sup>rd</sup> degree Freemason George Bannerman Dealey, was the site of the first Masonic Temple in Dallas; of course, the Dealeys were associated with it. George used his newspaper the Dallas Morning News, and his contacts within the paper industry to promote Scofield and his teachings and to screen out information that would embarrass the man. This is the standard operating procedure with the powermongers behind the scenes and happens every day. Luciferians place their people in key positions in the media and are then able to promote their men in key positions in politics and religion, which promote certain policies and doctrines in order to direct public opinion. Illuminist newspaper tycoon William Randolph Hearst used his resources to introduce 33<sup>rd</sup> degree Freemason Billy Graham to the world. Biographical researcher Canfield penned the following example in relation to Scofield's death:

"On Sunday, November 27, 1921, the whole day was given over to memorial services for Scofield at the First Church in Dallas. The Dallas Morning News, the next day, devoted five columns on its page 7 to report the affair. Looking at the report of the day, one gets an impression that some tributes dripped with gooey syrup if they had any truth in them."

One of Scofield's students, Dr. W. Irving Carroll gave the eulogy at his funeral. In regards to Scofield's work, he stated:

"He was the greatest Bible expositor of his generation and there have been none to equal him in clarity of thought nor brevity of thought of any generation. I am saying this, not in fulsome flattery of the man's life, but simply in recognition of a great fact. I say again that no man ever had a deeper insight into the revealed truth of Scriptures nor a broader grasp."

But was Scofield the greatest bible expositor of his generation? Did he really know what he was talking about? Once again Canfield shines some light. In an analysis of a statement made by Scofield to the effect that Charles Finney and Charles Spurgeon preached the same doctrine, Canfield remarked "His assertion that Spurgeon and Finney preached the same message is incorrect. The views of the two men were so far apart that reconciliation is impossible. The statement is another suggestion that Scofield's knowledge was superficial and his expressed views suited to occasion and congregation." After reading Canfield's excellent biography about the man and finding out about all his scandals which his associates helped cover-up, I would be hard-pressed to say he was anything more than a confidence man employed to promote a false teaching.

Quite possibly the biggest momentum builder to the dispensationalist movement was the Scofield Reference Bible. It has even been suggested that dispensationalism might have died out if not for the timely introduction of this Reference Bible. In preparation for writing his bible, Scofield felt some strange need to travel to the British Isle for 'research'. What he was really doing was going to get instructions from the controversial scholars B.F. Westcott and F.J.A. Hort. There is much evidence out there documenting how **these two Bible scholars were deeply involved into occultic societies and mystery religions** including Roman Catholicism. Scofield gratefully acknowledged the help of Hort and Westcott in the introduction of his 1909 Scofield Reference Bible. These two men are responsible for translating the corrupted Alexandrian manuscripts Sianaticus and Vaticanus into the Revised Version of the Bible in 1881.

Scofield wanted to use the Revised Version for his reference Bible but in the climate of the times, the KJV was much more popular and respected (oh the times they are a changing), so he knew his reference work would not sell as well if coupled with the RV. But **the King James Version is highly incompatible with the dispensationalist doctrines**. In order to correct this problem, he inserted footnotes in crucial areas where the KJV disagreed with

the RV and the Alexandrian manuscripts. Each footnote "corrected" the KJV text to comply with the corrupted manuscripts.

DTS has inherited his contempt for the KJV. A thorough examination of DTS shows that the only King James Bible they really tolerate is the one doctored up by Dr. Scofield. They have since come out with new Scofield Reference Bibles in NIV (1984), NASB (1988), and NKJV (1989). The DTS Doctrinal Statement, which all faculty must affirm to each year, contains all the basic elements of dispensationalism (a pretrib rapture, a separation between Israel and the Church, a seven-year tribulation, etc.). Consequently, every student attending is automatically taught these doctrines, as well as their contempt for the KJV. Therefore, a majority of the books and articles they produce will include these same heretical teachings.
